

(Branch Road to Henrietta Street—westwards); Commercial Street (Well Lane to Hick Lane—south eastwards); and on Spa Hill (north eastwards).

(f) To create a point closure across Market Square (by means of the erection of bollards) at the southern side of the junction with the unnamed road between the Head Post Office and the Public Library.

(g) To create point closures on New Way approximately 14 metres east of Peel Avenue and on Peel Avenue approximately 14 metres north west of Russell Close. These will be introduced in such a way as to allow emergency services vehicles to pass.

(h) To prohibit the driving of vehicles (except buses and emergency services vehicles) on a length of St James Street from approximately 46 metres north of Branch Road to its termination.

A copy of the Order which comes into force on 1st January 1986, together with a map showing the affected roads may be examined during normal office hours at the Reception Desk, Main Entrance, County Hall, Wakefield; and at the County Council's office at Albion Street, Huddersfield and at the Kirklees Metropolitan Council's office at the Town Hall, Batley.

If you wish to question the validity of the Order, or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirements of that Act or of any Instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the date upon which the Order was made (i.e. 3rd December 1985) apply to the High Court for this purpose.

TOWN AND COUNTRY PLANNING ACT 1971

Conservation Area at Netherwitton

Notice is hereby given that the Castle Morpeth Borough Council as Local Planning Authority in exercise of their powers under section 277 (1) of the Town and Country Planning Act 1971, and after consultation with the North-umberland County Council, have designated the area referred to in the Schedule hereto as a Conservation Area. The area is one which the Borough Council consider to be of special interest, the character and appearance of which it is desirable to preserve and enhance. Future development in the area will be subject to strict planning control designated to secure the preservation of the character and the general improvement of the area. No buildings in the Conservation Area can be demolished without the consent of the District Planning Authority. The District Council must be given 6 weeks notice of any proposals to cut down, chop, top or uproot any tree in the Conservation Area.

Copies of a plan showing the area, together with a statement of the Borough Council's reasons for designating it as a Conservation Area, may be inspected during normal office hours at the office of the Chief Executive, Castle Morpeth Borough Council, Council Offices, The Kylins, Morpeth.

SCHEDULE

Description of Conservation Area in the Borough of Castle Morpeth

Commencing at the south-west corner of the grounds of the school house, the boundary proceeds eastwards then northwards along the boundary of the school house thence eastwards to the west bank of the River Font and northwards to Netherwitton Bridge. It then proceeds along the northern side of the C144 road and the western side of the C142 road to enclose the grounds of Netherwitton Hall. It then proceeds westwards mainly following the northern wall of the walled garden to Netherwitton Hall, to the Gardener's Cottage and south-westwards from there through woodland and across the River Font to the C144 road. It then proceeds southwards along the eastern side of the

C144 enclosing the western side of Netherwitton Village, thence round the northern, western and southern boundaries of Netherwitton Cemetery to the north bank of the Ewesley Burn. It then proceeds south to include a group of properties and attached gardens in the south-west part of Netherwitton Village and then to the C154 road and the western boundary of the grounds of the school house.

Notice is hereby given that the Mid Devon District Council being the Local Planning Authority have determined that Conservation Areas be designated at Cheriton Fitzpaine, Morchard Bishop, Newton St. Cyres, Sandford and Zeal Monachorum.

The areas designated as Conservation Areas are regarded as being of Special Architectural and Historic Interest, the character and appearance of which it is desirable to preserve and enhance and have designated such lands Conservation Areas for the purpose of section 277 of the Town and Country Planning Act 1971.

The effect of designation of the Conservation Areas is that all buildings (with minor exceptions) within the areas may not be demolished without the consent of the Mid Devon District Council and that the proposed development or alterations will be required to blend with the character of the areas as a whole. Details of applications which affect the character or appearance of the areas will be publicised in the local press. Persons wishing to cut down, top, lop or uproot trees in the area (except exempted trees) must give the Council 6 weeks notice of their intention to do so.

The Conservation Areas are shown edged black on plans which may be inspected during normal office hours on Monday to Friday at The Great House, 1 St. Peter Street, Tiverton, Devon.
