TOWN AND COUNTRY PLANNING ACTS

BLYTH VALLEY BOROUGH COUNCIL

TOWN AND COUNTRY PLANNING ACT 1971 (AS AMENDED)

Notice is hereby given that in accordance with section 277(7) of the above Act the Borough of Blyth Valley, in pursuance of their powers under section 277(1) of that Act, have designated the under-mentioned area of the Borough as a Conservation Area:

The buildings and most other curtilages within the area bounded by and including:

On the north side: Lyndon Farm, O.S. (Ordnance Survey) plots 0300, 0700, 2204, 5700, that part of O.S. plot 7640 south of the track connecting Lyndon Farm with Blackburn Cottages, Blackburn Cottages, and O.S. plot 0058.

On the east side: O.S. plots 0058, 0027, 3133, 3700, 5572, 7351, 5637, 5400 and 7500, Lookout Farm, O.S. plots 4879, 8767 and 0760, Seaton Lodge, O.S. plot 4171 and 3587, the northern edge of O.S. plot 3587 extended in a north-easterly direction to join the northern boundary of O.S. plot 4789 and meet the mean high water mark, the mean high water mark southward to the mouth of Seaton Burn at Sandy Island, the mouth of Seaton Burn, the mean high water mark southward to O.S. plot 2600, O.S. plot 2600.

On the south side: O.S. plot 2600, Pony Field (O.S. plot 2413), Duckett Field (O.S. plot 0300), O.S. plot 9631, the lane to the rear of 1-4 Co-operative Buildings, 10-32 Collywell Bay Road, The Waterford Arms Hotel, Seaton Sluice Clinic, Seaton Sluice and District Social Club, the A193 northward for approximately 30 metres, the Allotment Gardens to the rear of Beresford Court, the Allotment Gardens at the western end of Queen's Road, O.S. plot 5030, Holywell Dene (O.S. plots 4431, 5510, 6900, 7659, 7455, 7155 and 6750), the Borough Council boundary westward to its junction with the dismantled railway (the former Avenue Branch line).

On the west side: The dismantled railway from its junction with the Borough Council boundary northward to its junction with The Avenue (A190), The Avenue from its junction with the dismantled railway westward to its junction with the A192 plus O.S. plots 5113, 3000 and 2200, the dismantled railway from its junction with O.S. plot 2200 northward to Hartley Junction, O.S. plot 3300, Seaton Red House Farm, O.S. plots 1526, 0465 and 9378, and Lyndon Farm.

A plan showing this area can be inspected during normal office hours at the Planning Office or Borough Secretary's Office, Council Offices, Seaton Delaval.

The effect of the designation of this area as a Conservation Area will be that no person may, without the written consent of the Council, demolish any building or cut down, top, lop, uproot or wilfully damage or destroy any tree within the Conservation Area. Offences against these provisions may result in heavy fines.

The Council will also give special attention to the desirability of preserving or enhancing the character or appearance of the designated area, both in works initiated by the Council and in making decisions on applications for planning permission within or materially affecting the designated area.
