## 1. Introduction

- 1.1. This Duty to Cooperate statement has been prepared to accompany the Northumberland Local Plan Regulation 18 consultation. It demonstrates how the Council has, and continues to, fully comply with the requirements of “the Duty”.
- 1.2. This statement provides an update to the March 2017 Duty to Cooperate statement (Appendix 1) which was prepared to accompany the, now withdrawn, Northumberland Local Plan Core Strategy (NLPCS). The new Northumberland Local Plan rolls forward significant aspects of the evidence and joint working that was undertaken for the NLPCS and therefore the joint cross boundary strategic work recorded in the March 2017 statement is still relevant. The new Northumberland Local Plan has been influenced by previous work undertaken and agreements made between neighbouring authorities and key stakeholders.
- 1.3. The Council has sought in its Regulation 18 Local Plan to address the concerns raised in representations relating to the NLPCS, for example proposed levels of housing growth and Green Belt deletions for housing.
- 1.4. Northumberland County Council has identified the following list of cross boundary strategic matters that require cooperation with our neighbours, these include;
  - Population and Housing - Setting Future Housing Requirements
  - Economic Growth and Planning for Jobs
  - Transport and Infrastructure
  - Community Infrastructure Levy
  - Shopping, Leisure and Tourism
  - Minerals and Waste
  - Renewable Energy
  - Green Infrastructure
  - Wastewater Treatment
  - Healthcare
  - Education
  - Utilities
- 1.5. The format of this paper includes an update to the March 2017 statement on the following matters;
  - the plan position of Northumberland’s neighbouring authorities;
  - North of Tyne Devolution and Borderlands Growth;
  - concerns raised in previous representations to the NLPCS;

- a schedule, including outcomes, of duty to cooperate meetings held since production of the Regulation 18 Northumberland Local Plan began.

## 2. Local Plan position of Planning Authorities adjoining Northumberland inside the North East LEP area

- 2.1. Following the adoption of Newcastle and Gateshead's Joint Core Strategy and Urban Core Plan in March 2015 the Councils have begun work on individual allocations DPDs.
- 2.2. The draft Development and Allocations Plan (DAP) is part two of **Newcastle's** Local Plan. Consultation on the draft DAP ended in November 2017. The responses received are currently being considered and will help to inform the next stage in the preparation of the DAP.
- 2.3. The Making Spaces for Growing Places (MSGP) Local Plan Document is Part 3 of **Gateshead's** Local Plan. Consultation on MSGP ended in December 2017 and it is envisaged that the submission draft MSGP document will be consulted upon in summer 2018.
- 2.4. **North Tyneside** Council formally adopted their Local Plan on 20 July 2017. They sought the views of residents regarding the Strategic Allocations of Murton Gap and Killingworth Moor between October and November 2017, and they submitted their Draft Community Infrastructure Levy (CIL) Charging Schedule with Proposed Modifications to the Planning Inspectorate on 1 May 2018.
- 2.5. Consultation on the Preferred Option of the County **Durham** Plan commenced on 22 June 2018.
- 2.6. **Northumberland National Park** Authority (NNPA) are undertaking a Local Plan Review. A Policy Options Paper was consulted on in autumn/winter 2017. This followed on from a spring 2017 Issues Paper consultation which began to suggest a potential direction of travel for policy formulation.

## 3. Local Plan position of Planning Authorities adjoining Northumberland outside the North East LEP Area

- 3.1. Three Cumbrian and two Scottish planning authorities also share administrative boundaries with Northumberland.
- 3.2. **Carlisle City** Council adopted the Carlisle District Local Plan 2015-2030 on 8 November 2016. The Local Plan sets planning policies for the District against

which planning applications will be assessed. The Plan also allocates land for various uses, including housing development, across the District, setting out a strategic vision for growth over the next 15 years.

- 3.3. The **Eden District** Local Plan 2014/32 was the subject of a series of initial hearing sessions between May and September 2016 which were followed by a comprehensive consultation between March and April 2017. Further hearings covering outstanding issues were held in May 2017. The proposed Main Modifications were the subject of a subsequent further consultation in July / August 2017. A number of the representations affected the plans soundness and necessitated five further modifications which were the subject of a public consultation in December 2017 / January 2018. With the exception of the five further modifications, the Inspector confirmed the remainder of the plan was sound and could be attributed substantial weight in decision making from November 2017.
- 3.4. Following consideration of the consultation responses to the further modifications in February 2018, the Inspector was satisfied that the sum of the changes proposed would make the plan sound and concluded the hearings. Accordingly, the whole of the plan may now be attributed substantial weight in decision making as from February 2018. As of the end of May 2018 the Inspector concluded his draft report, which has now been quality assured by PINS and passed on to Eden District Council for Fact Check on 1 June 2018. This is prior to its return to the Inspector to enable him to issue his final report in due course.
- 3.5. **Cumbria County** Council is a minerals and waste planning authority. The Cumbria Minerals and Waste Local Plan (CMWLP) was adopted by the County Council on 6 September 2017.
- 3.6. The **Scottish Borders** Local Development Plan (LDP) was adopted on 12 May 2016 and sets out policies on development and land use within the Scottish Borders. Scottish Borders are now preparing a new Local Development Plan (LDP2) which will replace the current LDP and guide future development within the Scottish Borders for the period 2021-2026.
- 3.7. The **South East Scotland Development Planning Authority** (SESplan) is a partnership of six local authorities, including the Scottish Borders and Edinburgh, which prepares a region-wide Strategic Development Plan.
- 3.8. The second Proposed Strategic Development Plan was submitted to Scottish Ministers for examination on 26 June 2017. Following an assessment of conformity with the participation statement and the appointment of a reporter, the examination formally commenced in August 2017. The reporter

considered unresolved representations received during the period of consultation on the Proposed Plan which ran from 13 October to 24 November 2016. As of 18 May 2018 the reporters have received all of the responses to the latest request for further information and do not envisage any further procedure being necessary. The report of the examination is expected by end of June 2018.

#### **4. North East Combined Authority (NECA)/ Devolution Deal**

- 4.1. Discussions regarding devolution to the North East Combined Authority (NECA), which covers the local authority areas of Durham, Gateshead, Newcastle, North Tyneside, Northumberland, South Tyneside and Sunderland were put on hold following a Government announcement on 8 September 2016 to withdraw the 'minded to' devolution deal.
- 4.2. The three local authorities north of the river Tyne, Newcastle, North Tyneside and Northumberland, continued discussions with Government on a new devolution deal and agreed a 'minded to agree' devolution deal with Government on the 24 November 2017. Following a consultation process, the local authorities have worked with Government to enable the creation of a Mayoral Combined Authority and amend the boundaries of NECA.
- 4.3. The NECA Leadership Board, on the 26 April 2018, agreed in principle to Government making the requisite Order, which will allow the three authorities North of Tyne to withdraw from NECA in order to create a new mayoral Combined Authority for the North of Tyne area, and also to maintain governance arrangements for Transport across all seven local authorities.
- 4.4. The two combined authorities will continue to work together on a number of areas, including Transport and Inward Investment and all seven local authorities remain members of the North East Local Enterprise Partnership and support the delivery of Strategic Economic Plan.

#### **5. Borderlands Growth**

- 5.1. Borderlands Growth brings together the five cross-border local authorities of Northumberland County Council, Carlisle City Council, Cumbria County Council, Dumfries & Galloway Council and Scottish Borders Council to promote economic growth and competitiveness of the area that straddles the Scotland-England border.
- 5.2. The partners are working on a collective ambition to unlock the potential for sustainable and inclusive economic growth across the south of Scotland and north of England.

- 5.3. The themed topics that the Borderlands Partnership has been working on are: Energy; Digital; Transport Connections; Business; Destination Borderlands; Quality of Place; Rural Productivity; and Skills and Innovation.
- 5.4. The first Borderlands conference was held on 18 June 2018. The conference enabled stakeholders to hear about the work to date, the ambition for the Borderlands region and gave them the opportunity to provide their input through workshop sessions.

## **6. How have we cooperated? - Evidence and outcomes**

- 6.1. A schedule of Duty to Cooperate meetings and outcomes, that have helped to shape the preparation of this Plan is included at Appendix 2.

## **7. Ongoing cooperation**

- 7.1. The Duty to Cooperate requires Local Planning Authorities to constructively and actively engage with relevant bodies as part of an ongoing process.
- 7.2. The Council looks forward to continued engagement with partners to continue to manage strategic cross boundary matters and to develop effective planning policies and delivery strategies.
