1.0 Introduction

1.1 This Basic Conditions Statement sets out how the Acklington Parish Neighbourhood Plan has been prepared in accordance with the Neighbourhood Planning (General) Regulations 2012 (as amended), hereafter referred to as 'the Regulations', and how the basic conditions have been met as prescribed by Paragraph 8 of Schedule 4B to the Town and Country Planning Act 1990 (as amended) (the 1990 Act). The statement has been prepared by Acklington Parish Council as the qualifying body for the designated neighbourhood plan area and is submitted alongside the submission version of the Acklington Parish Neighbourhood Plan, the Consultation Statement, and other submission documents as set out below.

2.0 Submission Documents

2.1 All the documents required by part 5, paragraph 15 of the Neighbourhood Planning (General) Regulations 2012 (as amended) are submitted with the Acklington Parish Neighbourhood Plan. Those submission documents consist of the following:

i) The proposed neighbourhood development plan

2.2 The Acklington Parish Neighbourhood Plan (Submission Version 2024 – 2036) is submitted along with this statement.

ii) A map or statement which identifies the area to which the proposed neighbourhood development plan relates

- 2.3 A Policies Map is submitted with the neighbourhood plan, showing detail in relation to relevant policies in the Plan. The Policies Map was produced by Northumberland County Council for the Parish Council. It is considered that the maps included within the Neighbourhood Plan give enough clarity to give accurate context to the policies contained in the Plan.
- 2.4 The Policies Map covers the Neighbourhood Area and identifies sites in relation to specific policies:
 - Local Green Spaces in Acklington and Guyzance
 - Community Facilities in the Neighbourhood Area
 - Non-Designated Heritage Assets including a Historic Core for Acklington
 - Existing Conservation Area boundary for Guyzance
 - Existing Coastal Mitigation areas (7km/10km from the coast)
 - Woodland and natural environment designations to interpret Policy ANP4

iii) A Consultation Statement

2.5 A Consultation Statement is submitted with the Plan, which details the consultation that was carried out throughout the development of the Plan and how this consultation informed the development of policies in the Plan. The document contains details of the persons and bodies consulted about the neighbourhood plan; it also explains how they were consulted. The appendices cover in detail the consultation process and Appendix F contains a full list of responses made by people and organisations who were consulted at the Regulation 14 stage. It also sets out how these concerns have been subsequently addressed in policies and changes to policies in the neighbourhood plan.

iv) A statement explaining how the proposed neighbourhood development plan meets the requirements of paragraph 8(2) of Schedule 4B to the 1990 Act as applied to neighbourhood plans by section 38A of the Planning and Compulsory Purchase Act; (otherwise known as the Basic Conditions statement)

2.6 This statement is the Basic Conditions statement. The basic conditions are identified in part 4 of this statement.

v) An environmental report prepared in accordance with paragraphs (2) and (3) of regulation 12 of the Environmental Assessment of Plans and Programmes Regulations 2004; or where it has been determined under regulation 9(1) of those Regulations that the plan proposal is unlikely to have significant environmental effects (and, accordingly, does not require an environmental assessment), a statement of reasons for that determination.

- 2.7 A screening opinion was sought from Northumberland County Council during the Plan preparation period. The Acklington Parish Neighbourhood Plan was screened out and so a Strategic Environmental Assessment was not required. The screening opinion is included in the list of submission documents.
- 2.8 A screening opinion was also sought under the Habitats Regulations as to whether an Appropriate Assessment would be required. No policies were screened in, as there are no policies related to the provision of new housing or allocation of housing sites or other units of accommodation which may lead to increased recreational disturbance impacts on coastal sites.'
- 2.9 A copy of both screening opinions is submitted with the Plan.

3.0 Legislative Requirements

3.1 Legislative Requirements are set out in the Localism Act (2011), the Town and Country Planning Act (as applied to neighbourhood plans by section 38A and 38B of the Planning and Compulsory Purchase Act) and the Neighbourhood Planning (General) Regulations 2012 (as amended). Each requirement is addressed as follows:

i) The draft Plan is Being Submitted by a qualifying body

- 3.2 This submission draft Plan is submitted by Acklington Parish Council who are the qualifying body. The Plan has been prepared by the Acklington Parish Neighbourhood Plan Steering Group, which was given delegated authority by the Parish Council to produce the Plan. Regular feedback to the Parish Council has taken place. The Chair of the Steering Group was Mr. Bill Byatt. The Parish Council clerk attended the meetings and minutes were kept on the website during the preparation period. The Parish Council were regularly updated on the progress of the Plan, and a Terms of Reference was adopted and used to ensure transparency and proper conduct of affairs at all times. The Steering Group meetings were also attended by Northumberland County Council's Neighbourhood Planning Officer (Mr. Rob Naples).
- 3.3 The Parish of Acklington (forming the Plan area for the Acklington Parish Neighbourhood Plan) is entirely within the Northumberland County area. A Neighbourhood Area application was submitted under the Neighbourhood Planning Regulations 2012 (part 2 section 6) to Northumberland County Council who approved the application on 7th February 2018.

3.4 The Parish of Acklington Parish was therefore designated as a Neighbourhood Area for the purposes of section 61(G) of the 1990 Act. Copies of the Neighbourhood Area designation documents are available on the Northumberland County Council website.

ii) What is being proposed is a neighbourhood development plan

3.5 The Acklington Parish Neighbourhood Plan contains policies that relate to planning matters (the use and development of land) and has been prepared in accordance with the statutory requirements and processes set out in the Town and Country Planning Act 1990 (as amended by the Localism Act 2011) and the Neighbourhood Planning Regulations 2012 (as amended).

iii) The proposed neighbourhood plan states the period for which it is to have effect

3.6 The draft Plan identifies a 13-year period to which it relates: 2024 to 2036. This timescale is designed to fit in with the timescales set out in the Northumberland Local Plan which was adopted in March 2022.

iv) The neighbourhood plan does not deal with excluded development such as strategic county matters (mineral extraction and waste development), nationally significant infrastructure or any other matters set out in Section 61K of the Town and Country Planning Act 1990.

3.7 None of the policies in the Plan relate to excluded development.

v) The proposed neighbourhood plan does not relate to more than one neighbourhood area and there are no other neighbourhood development plans in place within the neighbourhood area.

3.8 The Plan relates to the Acklington Parish Neighbourhood Area, which is the designated neighbourhood area consisting of the Parish of Acklington. The Plan does not contain policies or proposals that relate to any other area. There are no other neighbourhood plans relating to this designated neighbourhood area.

vi) The Neighbourhood Development Plan only contains policies relating to the development and use of land.

3.9 The Plan contains policies relating to the development and use of land. Other proposals that are not related to the development and use of land that have been raised by the local community in response to consultations will be considered separately by the Parish Council but have been included in the Plan in a separate section entitled 'Community Projects'. This section of the Plan is not subject to examination and does not form part of the development plan for the purposes of determining planning applications.

4.0 Basic Conditions

- 4.1 A Neighbourhood Plan will be considered to have met the Basic Conditions if:
 - 1. Having appropriate regard to national policies and advice contained in guidance issued by the Secretary of State, it is appropriate to make the neighbourhood development plan;
 - 2. The 'making' of the neighbourhood plan contributes to the achievement of sustainable development;
 - 3. The 'making' of the neighbourhood plan is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area);
 - 4. The 'making' of the neighbourhood plan does not breach, and is otherwise compatible with, retained EU obligations as incorporated into UK law. There are 4 directives that may be of particular relevance to neighbourhood planning: Directive 2001/43/EC on the assessment of the effects of certain plans and programmes on the environment (often referred to as the Strategic Environmental Assessment (SEA) Directive); Directive 2011/92/EU on the assessment of the effects of certain public and private projects on the environment (often referred to as the Environmental Impact Assessment (EIA) Directive); Directive 92/43/EEC on the conservation of natural habitats and of wild fauna and flora Directive 2009/147/EC on the conservation of wild birds (often referred to as the Habitats and Wild Birds Directives respectively).
 - 5. Prescribed conditions are met in relation to the plan and prescribed matters have been complied with in connection with the proposal for the neighbourhood plan. The following prescribed condition relates to neighbourhood plans: Regulation 32 of the Neighbourhood Planning (General) Regulations 2012 (as amended) sets out a further Basic condition in addition to those set out in primary legislation. That the making of the neighbourhood plan is not likely to have a significant effect on a European site (as defined in the Conservation of Habitats and Species Regulations 2012) or a European offshore marine site (as defined in the Offshore Marine Conservation (Natural Habitats etc.) Regulations 2007) (either alone or in combination with other plans or projects). (See Schedule 2 of the Neighbourhood Planning (General) Regulations 2012 (as amended).
- 4.2 The Acklington Parish Neighbourhood Plan will be assessed against each of the identified basic conditions above:

Basic Condition 1: Having appropriate regard to national policies and advice contained in guidance issued by the Secretary of State, it is appropriate to make the neighbourhood development plan.

4.3 National Planning Practice Guidance states (Paragraph: 070 Reference ID: 41-070-20190509):

'A qualifying body is advised to set out in its basic conditions statement how they have had regard to national policy and considered whether a particular policy is or is not relevant. A qualifying body is encouraged to set out the particular national polices that it has considered, and how the policies in a draft neighbourhood plan or the development proposals in an Order take account of national policy and advice.'

4.4 How the Acklington Parish Neighbourhood Plan has regard to national policies and advice contained in guidance issued by the Secretary of State is contained in Table 1 which sets out those particular national policies and guidance in the NPPF that have a

bearing on policies in the submission Acklington Parish Neighbourhood Plan.

Basic Condition 2: The 'making' of the neighbourhood plan contributes to the achievement of Sustainable Development

4.5 The meaning of 'sustainable development' in this context is set out in paragraph 8 of the NPPF. Paragraph 8 identifies three objectives (economic objectives, social objectives and environmental objectives), the combination of which, contribute to the achievement of sustainable development. The objective of sustainable development can be summarised as 'meeting the needs of the present without compromising the ability of future generations to meet their own needs'.¹ There are several objectives set out in the Acklington Parish Neighbourhood Plan, the combination of which contribute to the delivery of 'sustainable development'. Five objectives were identified as a result of the community consultation exercises and are listed below:

Objective 1: To ensure that new development is **sustainable**, meets **local needs**, and is in keeping with the **scale and design** of existing buildings and places and **preserves the beauty of the open countryside**, valued **local landscapes and dark skies.**

Objective 2: To support the local community by the **protection of existing, and the encouragement of new community facilities** and by the maintenance of **green spaces, outdoor recreation areas** and the network of **local footpaths and bridleways**.

Objective 3: To **support and encourage new local services and businesses**, while protecting the tranquil rural character of the area and the amenity of residents

Objective 4: To **enhance the natural environment** by ensuring that new development delivers a net gain for biodiversity and that areas of value to wildlife are protected.

Objective 5: To ensure that new development **preserves and enhances the significance of the historic environment** in the parish.

4.6 The Plan contains 7 policies, which in combination, seek to deliver the vision and the objectives identified above which relate to the three areas of sustainable development identified in the NPPF of delivering economic, social and environmental objectives. How the policies deliver these objectives is summarised below:

Economic Objectives

NPPF Para 8: 'to help build a strong, responsive and competitive economy, by ensuring that sufficient land of the right types is available in the right places and at the right time to support growth, innovation and improved productivity; and by identifying and coordinating the provision of infrastructure' [para 8 NPPF]

4.7 Policy ANP3 identifies community facilities that will be protected and supported. These facilities are also in some cases local businesses.

Social Objectives:

NPPF Para 8: 'to support strong, vibrant and healthy communities, by ensuring that a sufficient number and range of homes can be provided to meet the needs of present and future generations; and by fostering a well-designed and safe built environment, with accessible services and open spaces that reflect current and future needs and support communities' health, social and cultural well-being'

- 4.8 Policy ANP1 is about design in Acklington village and seeks to ensure that new development will be well-designed, resulting in a built environment that reflects the desire of the local community to live in an area that is both attractive and well-related to existing development.
- 4.9 Policy ANP2 seeks to address issues in the Neighbourhood Area related to lack of permanent occupancy housing, and the rapid increase in second homes and holiday lets which is of concern to the communities living in those areas, and resulting in a loss, particularly of smaller more affordable dwellings suitable for younger families.
- 4.10 Policy ANP5 lists Local Green Spaces which have been identified by residents in the Neighbourhood Area as being special. These spaces are important to retaining a strong, vibrant and healthy community.

Environmental Objectives:

NPPF Para 8: 'to contribute to protecting and enhancing our natural, built and historic environment; including making effective use of land; helping to improve biodiversity, using natural resources prudently, minimising waste and pollution and mitigating and adapting to climate change including moving to a low carbon economy.'

- 4.11 Most of the policies in the plan have an environmental objective: Policy ANP4 is about biodiversity, woodlands and hedgerows and reflects the very strong support for the protection of the natural environment that came through at all stages of consultation.
- 4.12 Other policies are specifically related to the historic environment, in particular Policy ANP1 which refers to the historic core of Acklington and Policy ANP6 which is about the Guyzance Conservation Area. Policy ANP7 identifies non-designated heritage assets in the Neighbourhood Area, and these are listed in Appendix A of the Plan.
- 4.13 In combination, it is considered that this Plan will contribute to the achievement of sustainable development as defined in the NPPF and the Plan therefore meets the second Basic Condition. Table 1 further assesses each policy in the Plan against the objective of delivering sustainable development.

Basic Condition 3: That the Neighbourhood Plan is in General Conformity with Strategic Local Policy

- 4.14 The Acklington Parish Neighbourhood Plan area lies entirely within Northumberland County Council. On 31st March 2022, the County Council adopted the Northumberland Local Plan (NLP). This Plan contains strategic and non-strategic policies. A list of strategic policies is provided in Appendix A.
- 4.15 The neighbourhood plan must be in 'general conformity' with strategic policy. Paragraph 074² of the National Planning Practice Guidance explains what is meant by

² (Reference ID: 41-074- 20140306)

'general conformity':

"When considering whether a policy is in general conformity a qualifying body, independent examiner, or local planning authority, should consider the following:

- whether the neighbourhood plan policy or development proposal supports and upholds the general principle that the strategic policy is concerned with.
- the degree, if any, of conflict between the draft neighbourhood plan policy or development proposal and the strategic policy.
- whether the draft neighbourhood plan policy or development proposal provides an additional level of detail and/or a distinct local approach to that set out in the strategic policy without undermining that policy.
- the rationale for the approach taken in the draft neighbourhood plan and the evidence to justify that approach.'
- 4.16 The Acklington Parish Neighbourhood Plan is only required to be in conformity with strategic policies. In this Basic Conditions Statement each policy in the plan has been tested against the relevant strategic policies in the Northumberland Local Plan and is set out in detail in Table 1. Policies in the neighbourhood plan are also tested against national planning policy and practice guidance as set out in the NPPF.
- 4.17 The conclusions in Table 1 confirm that the Acklington Parish Neighbourhood Plan meets the basic conditions in all areas. There are no areas of conflict with existing or strategic policy in the NLP. The policies in the Acklington Parish Neighbourhood Plan give a level of local specificity to strategic policies which is appropriate to planning at a neighbourhood level.

This policy seeks to ensure that new housing in the Neighbourhood Area meets local needs by ensuring that new housing is for principal residency only. As certain parts of the Neighbourhood Area have higher rates of second homes/holiday lets than others, the Policy has split the Neighbourhood Area into 3 distinct areas. The approach is broadly consistent with the government's aims to increase the availability of housing. The policy sets a strong presumption against the loss of these areas of woodland and supports the retention of trees and hedgerows in the Neighbourhood Ara. A Wildlife Corridor consistent with a Network Enhancement Zone are also shown on the Policies Map and referenced in the policy. The evidence for the policy comes from Natural England's mapping services (MAGIC) and the policy is consistent with the government's policy aspirations and legislative changes in the Environment Act, to conserve and enhance biodiversity. The Local Green Spaces identified in this Neighbourhood Plan meet the requirements set out above, and evidence is provided to demonstrate that in the form of background evidence papers. The policy states that the management of the Local Green Spaces should be consistent with those for green belts, as set out in NPPF paragraph 107. The spaces identified are highly valued by the local community – some for recreational value, some for biodiversity value, and some for historic interest. - 4.18 Directive 2001/42/EC requires the assessment of the effects of certain plans and programmes on the environment (often referred to as the Strategic Environmental Assessment (SEA) Directive).
- 4.19 The Conservation of Habitats and Species Regulations 2017 (the 'Habitats Regulations') requires that competent authorities assess the potential impacts of land use plans on the Natura 2000 network of European protected sites. This is to determine whether there will be any 'likely significant effects' on any European sites as a result of the plan's implementation (either alone or 'in combination' with other plans or projects); and, if so, whether these effects will result in any adverse effects on that site's integrity with reference to the site's conservation objectives. The process by which the effects of a plan or programme on European sites are assessed is known as 'Habitats Regulations Assessment' (HRA).
- 4.20 The requirements for Strategic Environmental Assessment and Habitats Regulations Assessment are set out in separate legislation. The Acklington Parish Neighbourhood Plan was screened 'out' for SEA. A copy of the Screening Opinion is submitted with the Plan.
- 4.21 The Plan was screened under the Habitats Regulations and all policies were screened 'out'. The screening opinion is submitted with the Plan.

European Convention on Human Rights (ECHR)

4.22 The Acklington Parish Neighbourhood Plan is fully compliant with European Convention on Human Rights. There is no discrimination stated or implied, or threat to the fundamental rights and freedoms guaranteed under the Convention.

Basic Condition 5: Regulation 32 of the Neighbourhood Planning Regulations 2012 (as amended)

4.23 Regulations 32 and 33 of the Neighbourhood Planning (General) Regulations 2012 (as amended) add a basic condition for neighbourhood plans in addition to those set out in the primary legislation. Regulation 33 applies specifically to Neighbourhood Orders and therefore does not apply in this case. Regulation 32 applies to Neighbourhood Plans and requires that: 'the making of the neighbourhood development plan does not breach the requirements of Chapter 8 of Part 6 of the Conservation of Habitats and Species Regulations 2017.' Sections 4.19 to 4.21 set out how the Neighbourhood Plan was amended to take account of statutory requirements through the carrying out of a Strategic Environmental Assessment and a Habitats Regulations Assessment, and how the Plan has been amended accordingly.

5.0 Conclusions

5.1 The evidence provided in this Basic Conditions Statement concludes that this submission version of the Acklington Parish Neighbourhood Plan (2024-2036) meets the Basic Conditions as set out in the Neighbourhood Planning Regulations (2012) (as amended).
