1. Introduction

1.1 This consultation statement has been prepared to fulfil the legal obligations set out in the Neighbourhood Planning (General) Regulations 2012. Section 15(2) of the regulations, define that a consultation statement must contain:

- Details of the persons and bodies who were consulted about the proposed neighbourhood development plan;
- An explanation of how the persons and bodies were consulted;
- A summary of the main issues and concerns raised by the persons consulted; and
- A description of how those issues and concerns have been considered and where relevant, addressed in the proposed neighbourhood development plan.

1.2 In order to meet the requirements of the Regulations, this consultation statement sets out:

- The background to the preparation of the Cresswell Neighbourhood Plan ('the CNP');
- A summary of the publicity, engagement and consultation that has helped to shape and inform preparation of the CNP;
- Details of those consulted about the CNP during plan preparation and the extent to which efforts were made to ensure the CNP was prepared with support and input from the local community; and
- A description of the changes made to the CNP in response to consultation and engagement.

1.3 Cresswell Parish Council (CPC) consider that the extent of engagement meets the obligations set out in the regulations.

1.4 The consultation statement is intended to help the independent examiner review the process of the preparation of the CNP and make any appropriate recommendations in relation to the CNP.

2. Background to the Cresswell Neighbourhood Plan

2.1 On 9th June 2022, the parish of Cresswell was designated as a neighbourhood area for the purposes of neighbourhood planning. CPC is a small parish, with only seven councillors. As a result it was determined that it was not necessary to establish a separate neighbourhood plan steering group. Work on the plan was therefore led by the full parish council and progress discussed at parish council meetings.

2.2 The main driving force behind the decision of the parish council to prepare a neighbourhood plan was concern at the increasing numbers of caravan sites and their impact on local green spaces and the need to protect our local rural and coastal environment . In September and October 2021 the parish council had conducted a survey via our newsletter delivered to all residential properties in the parish. The survey sought feedback on a broad range of issues .

2.3 The preparation of the CNP has involved inclusive engagement, all of which will be discussed further in this document. The parish wide survey informed the preparation of the Cresswell Pre-Submission Draft Plan, which was subject to consultation from 4th August to 14th September 2023. The draft plan identified:

- The context in which the plan has been prepared – an overview of Cresswell and the opportunities and challenges for the plan to address;
- A positive vision for the future of the Cresswell Neighbourhood Plan area; and
- How the vision of the plan will be delivered through a planning policy to designate a number of areas within the parish as local green spaces.

2.4 The Draft Submission Cresswell Neighbourhood Plan (January 2024) is a revised version of the PreSubmission Draft Craster Neighbourhood Plan (August 2023). It is has been modified to take into account of representations received.

2.5 The key stages in the preparation of the plan can be summarised as:

a)9th June 2022 Designation of the Cresswell Neighbourhood Area

b)September -October 2021 Parish wide survey

c)June 2022-January 2023 Pre-Submission Draft Plan engagement, including a drop-in event (4th January) .

d)March 2024 Submission

3. Early Engagement

3.1 In order to inform the preparation of the draft CNP the parish council undertook a parish survey, which was sent to all residential properties in September and October 2021 (appendix 1). 3

3.2 The survey sought views on a wide range of issues

3.3 The parish council received 39 responses to the survey.

A recurring theme was the need to look after the village environment and community.

Several respondents raised issues with regard to traffic and parking in the village as well as the antisocial and dangerous behaviour of motorbikes and quadbikes behaviour.

4. Pre-Submission Engagement

4.1 Consultation on the Pre-Submission Draft CNP took place between August and September 2023. In advance of the commencement of the consultation NCC provided advice to ensure it was in accordance with Regulation 14 of the Neighbourhood Planning (General) Regulations 2012, (Appendix 2).

4.2 The local community, consultation bodies and other interested parties (Appendix 3) were informed of the consultation on the Pre-Submission Draft CNP and the opportunity to comment on the plan in the following ways:

- A notification email/ letter was set to statutory and non statutory consultation bodies (Appendix 4 and 5);
- The draft plan and supporting documents was available online at: northumberlandparishes.uk/cresswell/documents/neighbourhood-plan; and
- A drop-in event was held on Wednesday 4th January 2023 between 6p.m and 7 p.m where copies of the plan were available to view.

4.3 The drop-in event was attended by 6 people.

4.4 Constructive responses to the pre-submission consultation were received from:

- Historic England
- Marine Management
- Northumberland County Council as well as one local business
- Northumberland Leisure

4.5 No comment replies were received from

- Natural England
- National Gas
- National Grid

4.6 Acknowledgements only (no response) were received from

- Coal Authority
- Alncom
- Lynemouth Parish Council
- Vicar of St Bartholomew's Church (Cresswell, Lynemouth, Widdrington)
- National Highways

4.7 The responses and details of how they have been taken account of in the Submission Draft CNP is included in Appendix 6. Following engagement on the Pre-Submission Plan, the plan was amended where necessary.

5. Conclusions

5.1 The submission version of the CNP is the outcome of broad engagement since 2021. Throughout that time, guidance, input and support has been obtained from various sources, all of which has been afforded due consideration in the preparation of the plan.

5.2 This has resulted in a submission CNP that reflects the community's aspirations for the area and the advice of stakeholders, whilst being in general conformity with local and national planning policy and that meets the basic conditions.

5.3 This consultation statement demonstrates that the publicity, consultation and engagement on the plan has been meaningful, effective, proportionate and valuable in shaping the plan, which will benefit Cresswell parish both currently and in the future by ensuring it is a tranquil and attractive place to live and visit .






Q1. Cresswell Parish Council has surveyed traffic flow and discussed traffic issues roadside with the police. What level of importance is traffic management through Cresswell for you?




Q2. Cresswell Parish Council has discussed parking issues and potential solutions with Northumberland County Council. How important are parking issues in Cresswell for you?




Q3 We pride ourselves as a village with low levels of anti-social behaviour. How concerned are you about anti-social behaviour in Cresswell?

A book swap facility. These are really popular and a good way of sharing read books (x 2 respondents)

A few benches on the green or near the beach.

Safety

Traffic calming measures eg speed bumps, repeater 20mph sign at settlement boundaries (x 4 respondents)

Dealing with roads that flood with heavy rain.

Expand the boatyard car park from 60 to 70 to 200

Footpaths and parking

Establish a stretch of the beach as a lifeguard patrolled safe swimming area

Beach warden

A safe roadside path northbound from the village to the car park opposite the drift café (x 4 respondents)

Better policing of motorcycles and quad bikes tearing up the sand dunes

The prevention of youths on motorbikes and quad driving on the dunes and speeding through Cresswell Home Farm

Neighbourhood Planning Advice Notes

Regulation 14 Consultation

1. What is 'Regulation 14'?

- 1.1 Regulation 14 of the [Neighbourhood planning regulations](#) require the draft neighbourhood plan proposal to be the subject of a pre-submission consultation before it is submitted to the local authority for independent examination. The consultation should last at least 6 weeks. The qualifying body (in Northumberland this would be the Parish Council) will need to approve the consultation draft of the plan and ensure that the Regulation 14 consultation takes place.
- 1.2 Pre-submission consultation requirements include publicising the draft plan to people who live, work or run businesses in the area. The publicity must include details of the proposed neighbourhood plan, where and when it may be viewed, and how to make comments on the plan and by what date.
- 1.3 Certain statutory bodies must be consulted, including the county council, the Environment Agency, Natural England and Historic England. **A list of contact details for the statutory consultees is appended to this advice note.**
- 1.4 It is also advisable to consult any local business or community organisations, such as chambers of commerce, civic societies and local trusts.
- 1.5 Many people will not want to read through the whole document, so it is useful to produce a simple leaflet or display boards that set out the main aims and the focus of the policies in the plan. Drop-in events may be a useful means of allowing people to ask questions or discuss the plan on a one-to-one basis. The draft plan and supporting documents should be uploaded to the neighbourhood plan website. Printed copies should be made available at convenient locations, such as libraries, community centres, council offices and

other key public buildings. Copies should be available to send to people who can't access a digital or displayed copy.

2. Considering representations and modifications

- 2.1 Any comments received by the end of the consultation period must be considered conscientiously by the qualifying body. All representations need to be considered, but it is legitimate for the neighbourhood plan body to take a different view. Indeed, different representations may demonstrate opposing views. A planning judgement needs to be taken.
- 2.2 A decision will need to be made over whether or not to amend the neighbourhood plan in response to each representation. The decisions on whether or not to amend the plan, and the reasoning behind them, should be recorded, as this information will need to be incorporated into the consultation statement.
- 2.3 The Regulations require that a 'consultation statement' is prepared and submitted with a neighbourhood plan when the plan is sent to the County Council. The consultation statement must:
 - contain details of the persons and bodies who were consulted about the proposed neighbourhood development plan;
 - explain how they were consulted;
 - summarise the main issues and concerns raised by the persons consulted; and
 - describe how these issues and concerns have been considered and, where relevant, addressed in the proposed neighbourhood development plan.
- 2.4 The qualifying body will need to agree the modifications and approve the resulting draft of the plan for submission to the local planning authority

Appendix 6

Summary of comments

Historic England suggested referring specifically to designated and non designated heritage assets within the parish. However it was our opinion that these were covered at sections 2.6 and 2.7. and the CNP was not amended.

Marine management advised referring to the North East Marine Plan in relation to areas within the CNP which might impact upon the marine environment .After due consideration it was agreed that this would not be the case so was the CNP was not amended.

Northumberland County Council , by way of the Neighbourhood Planning team, offered a number of helpful suggestions with regard to text and layout as well as up to date statistics and the CNP was amended accordingly.

Northumbrian Leisure expressed the view that Figure 4 and the Policy 1 map were insufficiently detailed to accurately show the areas to be covered by policy 1 (although OS coordinates were provided).The assistance of the Neighbourhood Planning Team was sought and the maps were amended accordingly. Policy 2 was criticised as being inadequate not exercising any meaningful control other than replicating other controlling policies and the phrasing used as inconsistent with the Northumberland local plan . The wording was amended in line with the latter comment but in relation to the policy itself and our objectives 2 and 3 we felt it important to retain this policy.
