1. Introduction

1.1. The Hexham Neighbourhood Plan (the Plan) was made (brought into force) at Cabinet on 13th July 2021. It now forms part of the development plan for Northumberland and is a material consideration in the determination of planning applications in Hexham Parish. Planning applications must be determined in accordance with the policies in the Plan unless material considerations indicate otherwise.

1.2. Preparation of the Plan included consultation with the statutory consultation bodies, stakeholders and the local community. In parallel with the preparation of the Plan, a Strategic Environmental Assessment (SEA) was undertaken. SEA is a process by which the Plan and its policies, and any reasonable alternative approaches to achieve the objectives of the Plan, were appraised against a set of environmental objectives. The purpose of SEA is to help ensure that potential significant adverse environmental effects are identified and then avoided or mitigated; and to consider opportunities for improving expected outcomes from implementing the Plan.

1.3. SEA is undertaken as a series of stages in line with the requirements of the Environmental Assessment of Plans and Programmes Regulations 2004 (the SEA Regulations). Once a plan that has been subject to SEA is brought into force Regulation 16 of the SEA Regulations require the local authority that brings the plan into force to publish an 'adoption statement'.

This document is the Regulation 16 Adoption Statement for the Hexham Neighbourhood Plan for the purposes of the SEA Regulations.

1.4. In accordance with the SEA Regulations this adoption statement includes the following prescribed information:

- an overview of the process that has been undertaken;
- how environmental considerations have informed the development of the Plan, including consideration of reasonable alternatives;
- how the results of any consultations have been taken into account; and
- the measures that are to be taken to monitor the significant environmental effects of the implementation of the plan.

2. Overview of the Process

2.1 SEA was completed over a series of stages in parallel with the development of the Neighbourhood Plan. The key stages are summarised in Table 1.

2.2. The SEA Scoping Report helped to inform the creation of an SEA Framework, which comprised a list of objectives under seven environmental themes, against which the Plan and its policies were assessed throughout its preparation. This SEA Framework is shown in Table 2.

2.3 A full draft SEA Environmental Report (September 2018) was prepared but the pre-submission consultation period on the draft Plan had already been carried out. The pre-submission consultation version of the HNP was updated to reflect commentary in the SEA and both the SEA and the draft Plan were subject to a further 6 weeks of consultation to satisfy SEA regulations. This provided a comprehensive assessment of the draft Plan including consideration of reasonable alternatives to the policies proposed in the Plan. The findings helped to inform a review and further revisions to the Plan. The SEA Environmental Report and Addendums (February and October 2019) is an amended iteration that takes account of changes to the draft Plan following consultation. This aligns with the purpose of SEA which must be seen as a continuous process applied throughout the period of plan preparation.

3. How SEA has informed the Development of the Plan

3.1 SEA has been undertaken as an iterative process to ensure that environmental considerations have guided the neighbourhood plan-making process. Polices have been developed having regard to objectives established in the SEA Framework and the need to deliver, through planning policies, Plan's Objectives which are set out in Chapter 4 of the Plan. Together these seek to place environmental considerations at the heart of decision-making.

3.2 The process for preparing a neighbourhood plan requires an independent examination of the draft plan. This requires an independent person to consider and make recommendations on whether the plan meets a range of legal and policy requirements. That examination concludes with the publication of a report by the independent person appointed to examine the plan. The Examiner's Report for the Hexham Neighbourhood Plan was published in January 2020. In Paragraph 33 he noted A Strategic Environmental Assessment, containing a Scoping Report, was submitted alongside the Neighbourhood Plan. An Addendum document was also submitted, presenting relevant updates to the findings in the SEA since Regulation consultation. Further to consideration of the submitted documents, Historic England submitted a representation setting out concerns: "...about the lack of a clear train of thought to conclude an absence of significant environmental effects on the historic environment, even if this might well be the case." Taking this into account, the Qualifying Body asked the Local Planning Authority to request a pause in the examination to allow further work to be undertaken to supplement the environmental report and to undertake consultation on an addendum to that report. Further work was undertaken and a further addendum was thus produced and submitted, following consultation with statutory bodies. None of the statutory bodies dissented from its conclusions and Historic England stated that they are: "...satisfied with the revised environmental report...there is a clear train of thought to conclude an absence of significant environmental effects on the historic environment..." The Examiners Report confirms the examiner's conclusions that the relevant statutory requirements in respect of SEA were eventually satisfied through the plan-making process.

Reasonable Alternatives

3.3 A key element of the SEA process is the appraisal of 'reasonable alternatives' for the HNP. The SEA Regulations are not prescriptive as to what constitutes a reasonable alternative, stating only that the Environmental Report should present an appraisal of the 'plan and reasonable alternatives taking into account the objectives and geographical scope of the plan'.

3.4 **Housing**. Given that the Plan is not dealing with the overall housing target or potential release of Green Belt land, it is considered that there are no alternative strategic approaches for supporting additional housing provision in Hexham. Though the Local Plan has been withdrawn since the draft Hexham Neighbourhood Plan was prepared, the strategic level of housing growth and the consideration of Green Belt

release will be considered in a new iteration of the Local Plan. Therefore, it is not considered necessary or appropriate to explore these factors through the Neighbourhood Plan.

3.5 **Site Allocations**. The Plan proposes to allocate twelve sites for housing development plus one 'reserve site'. To inform the decision on which sites to allocate, the Group identified a range of sites that could potentially be allocated. Twenty eight such sites were identified by residents (at a Public Forum), and Steering Group. Research reduced these to 13 viable sites with owner consent. These sites were assessed by AECOM (through a separate technical support package), with the findings helping the Group to identify which sites should be allocated and those which should be discarded. This report can be accessed by following a link at the end of this report.

Policy Appraisals

3.6 The Plan policies were appraised against the SEA Framework at various stages to help inform the final policies in the made version of the Plan. The appraisal commentary for each sustainability theme does not necessarily discuss every single Plan policy, only those where notable effects are predicted. The results of the policy appraisal are summarised in Table 3 below. Notably, there were no policies which were expected to result in significant negative impacts. SEA findings helped give assurance that the Plan would contribute positively toward meeting environmental objectives.

4. How the Results of Consultations have been taken into Account

4.1 As illustrated in Table 1, the Plan and corresponding SEA have been subject to several rounds of public consultation with responses informing the preparation of both documents.

4.2 An SEA Scoping Report was published for consultation in October 2017 with the statutory consultation bodies (Natural England, Environment Agency and Historic England). The Environmental Report and subsequent Addendums (February and October 2019) sets out how the response to the consultation bodies comments was reflected in the SEA scope.

4.3 A draft SEA Environmental Report (September 2018) was published for consultation alongside the Town Council's second phase of consultation on the draft Neighbourhood Plan. Comments were received on the Environmental Report from Historic England. Page 25 of the Consultation Statement, a document that must be prepared to describe the outcome of consultation undertaken by the Town Council on the Neighbourhood Plan, provides a link in paragraph 5 to the written representations received and the Town Council's response to those representations, including any consequent modification they made to the Plan as a result of those representations.

4.4 The final SEA Environmental Report was submitted to Northumberland County Council along with the final draft version of the Plan in May 2019. These documents were subsequently publicised by the County Council for a period of 6 weeks in accordance with the Neighbourhood Planning (General) Regulations 2012 (as amended). All representations made in response to that publicity were considered by the Examiner during the independent examination of the Plan. A further SEA Environmental Report Addendum was produced in October 2019 and the examination was paused while this Addendum was made. The Addendum to the Environmental Report was prepared to take into account comments from Historic England.

4.5 In addition to the statutory consultation stages, the Town Council also engaged with the local community and stakeholders at a number of informal consultation events throughout the preparation of the Plan. This community engagement provided a further opportunity for the Town Council to consider local environmental considerations. Further information is available in the Consultation Statement.

5. Monitoring Measures

5.1 The SEA Regulations require that the significant environmental effects of the implementation of the Plan should be monitored.

5.2 The final SEA Environmental Report (September 2018) highlighted the range of significant positive effects that had the potential to arise as a result of the

implementation of the Plan, with no identified significant negative effects. However, the Environmental Report concludes that:

' There is a requirement to present measures that could be used to monitor the effects of the Plan identified through the SEA. It is particularly important to monitor effects that are predicted to be significant, whether this be positive or negative. Monitoring helps to track whether the effects turn-out as expected, and to identify any unexpected effects. The table below sets out the monitoring measures for the predicted significant effects.'

These measures are presented in Table 4.
