Affordable Housing for Sale

The Discounted Market Homes programme was launched in Mav 2019. MHCLG are continuing to encourage neighbourhood planning groups to apply for Technical Support, especially if they are seeking to allocate sites for affordable housing for sale. Funding packages ranging from £10.000 £50,000 are available support groups in identifying suitable sites for affordable homes for sale and even to grant permission through a neighbourhood development order. training and advice is also available for groups.

Activity in the South East

The Cramlington Neighbourhood Plan was formally adopted after a decision at Cabinet meeting on 10 March 2020. The Plan has now been brought into legal force and forms part of the statutory development plan for the area.

Decisions on planning applications must now be made in accordance with the policies in the Plan unless material considerations indicate otherwise.

Activity in the West

The independent examination of the Hexham Neighbourhood Plan has been completed and the County Council has considered and accepted each of the recommendations made by the examiner.

The Hexham Neighbourhood Plan referendum is to be held on Thursday 23rd April.

As the referendum date has been agreed the plan now carries **substantial weight** in planning decisions.

Hexhamshire Parish Council was designated as a Neighbourhood Area on 18 February 2020.

Activity in the North

The independent examination of the Embleton Neighbourhood Plan began on 17 February 2020. The independent examination of the Lesbury Neighbourhood Plan will begin on 23 March 2020. At this stage each plan is given **limited weight** in planning decisions.

The Wooler Neighbourhood Plan has been submitted to the County Council for Independent Examination. We are publicising the Plan and supporting documents and are inviting comments until 5pm on Monday 30 March 2020. At this stage the Plan will be given **limited weight** in planning decisions.

Both Craster and Alnmouth Parish Councils are consulting on their pre-submission draft neighbourhood plans. Each Plan contains a single planning policy relating to a principal residency restriction. At this stage each plan carries little weight in planning decisions.

Warkworth Parish Council was designated as a Neighbourhood Area on 18 February 2020.
