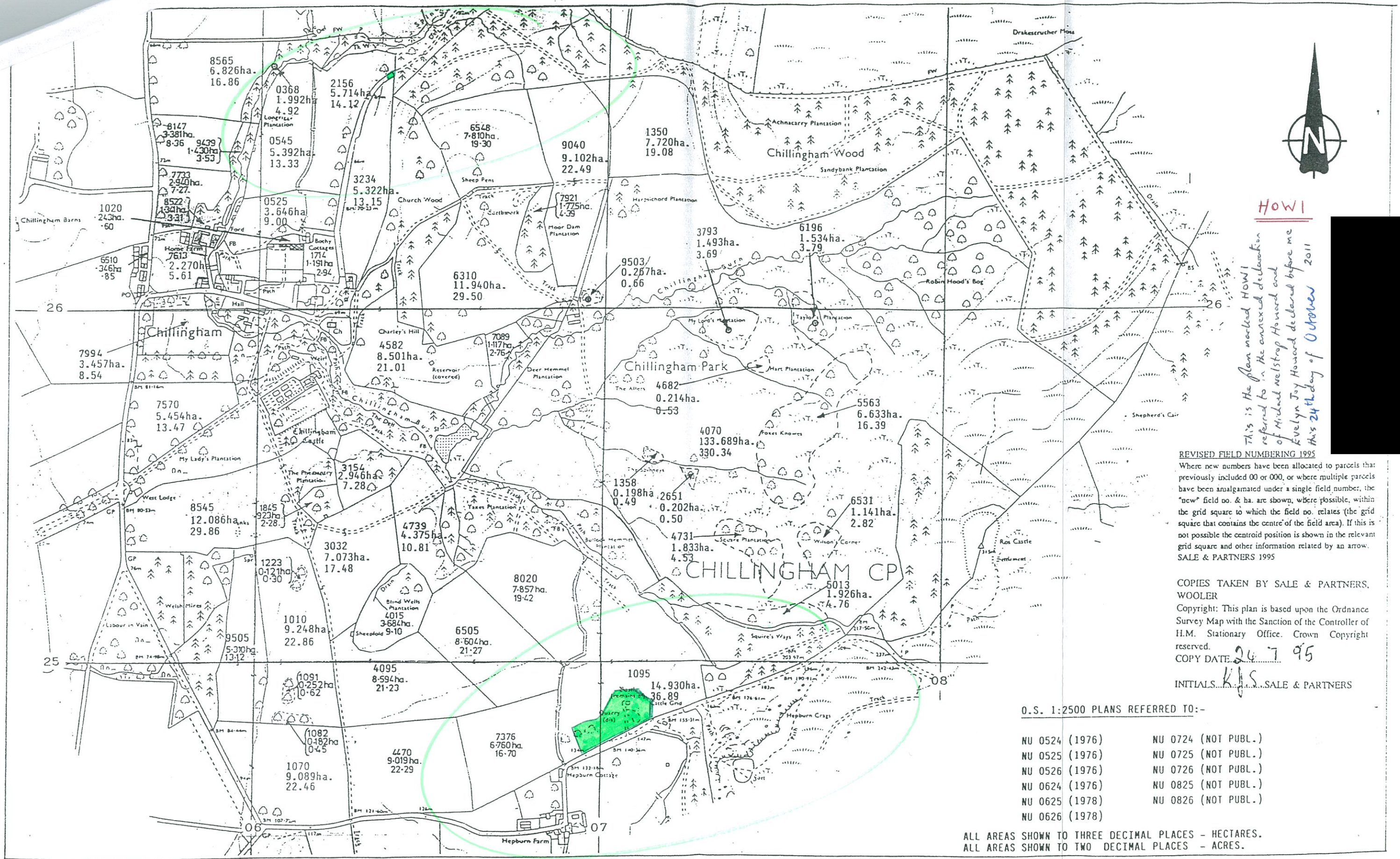

WE MICHAEL NELSTROP HOWARD and EVELYN JOY HOWARD of Chillingham Home Farm Chillingham Alnwick Northumberland do solemnly and sincerely declare as follows:

1. On 4 March 1996 we deposited a map of our land at Chillingham Home Farm Chillingham Alnwick Northumberland ("Our Land") with Northumberland County Council together with a statement dated 5 February 1996 denying that any of the ways over Our Land had been dedicated by us for the use of the public as highways.
2. On 4 March 1996 we deposited with Northumberland County Council a statutory declaration dated 27 February 1996 stating that since the deposit of the statement referred to above no ways over Our Land had been dedicated by us for the use of the public as highways.
3. Prior to 7 March 2002 we deposited with Northumberland County Council a statutory declaration dated 14 February 2002 stating that since the deposit of the statement referred to above no ways over Our Land had been dedicated by us for the use of the public as highways.
4. We now own the whole of Our Land other than the parts shown coloured green on the map annexed marked "HOWI".
5. Since the statutory declaration dated 14 February 2002 referred to above no ways over the part of Our Land that we still own have been dedicated by us for the use of the public as highways.

AND we make this solemn declaration conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835

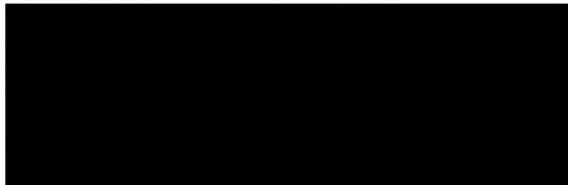
