

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

Gallowshieldrigg, Parish of Henshaw, Northumberland

We, Alasdair Macfarlane Mitchell and Astrid Camilla Mitchell, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. We are the owners within the meaning of the above section of the land at Gallowshieldrigg, in the Parish of Henshaw, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On January 8, 2009 we deposited with Northumberland County Council, being the appropriate Council, a statement accompanied by a plan delineating the above property by red edging, stating that two highways only – a public road leading from the south west corner of the said property to the north end of Gibbs Hill bridge, and a public footpath from that point leading initially in a north west direction - had been dedicated to the public over our property.
3. No additional way of any description has been dedicated to the public over the land edged in red accompanying this declaration since the statement dated January 8, 2009 referred to in (2) above and we have no intention of dedicating any more public rights of way of any description over our property.

AND WE MAKE this solemn declaration on the 12 th day of January 2009 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

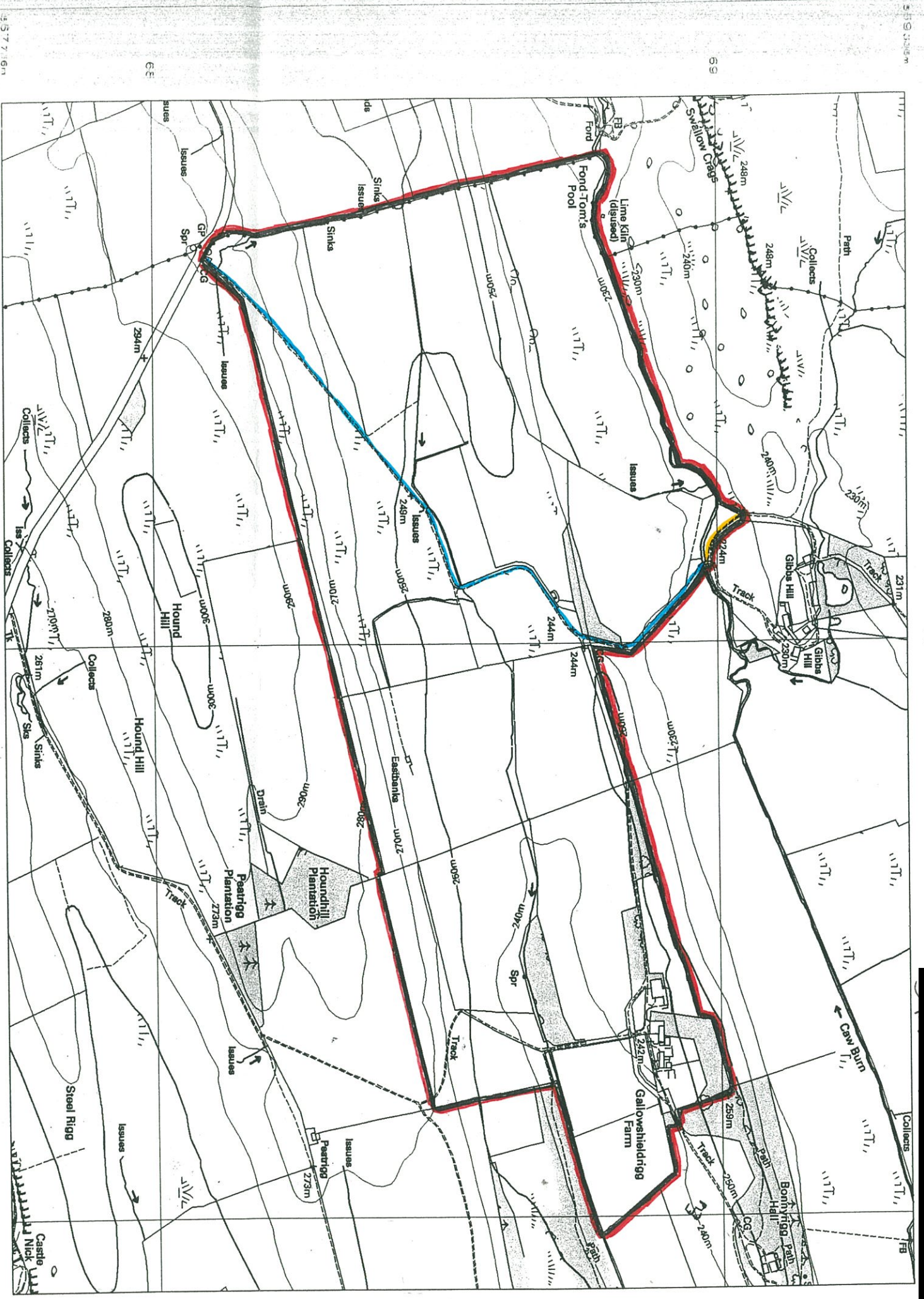

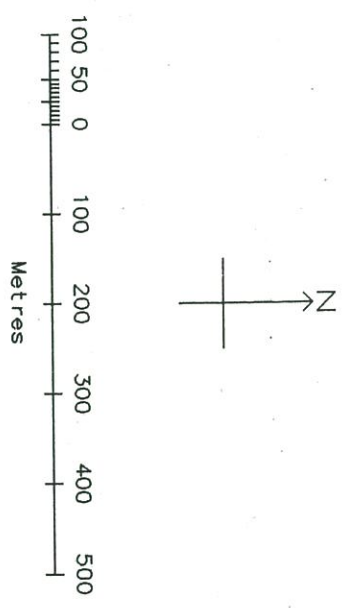
