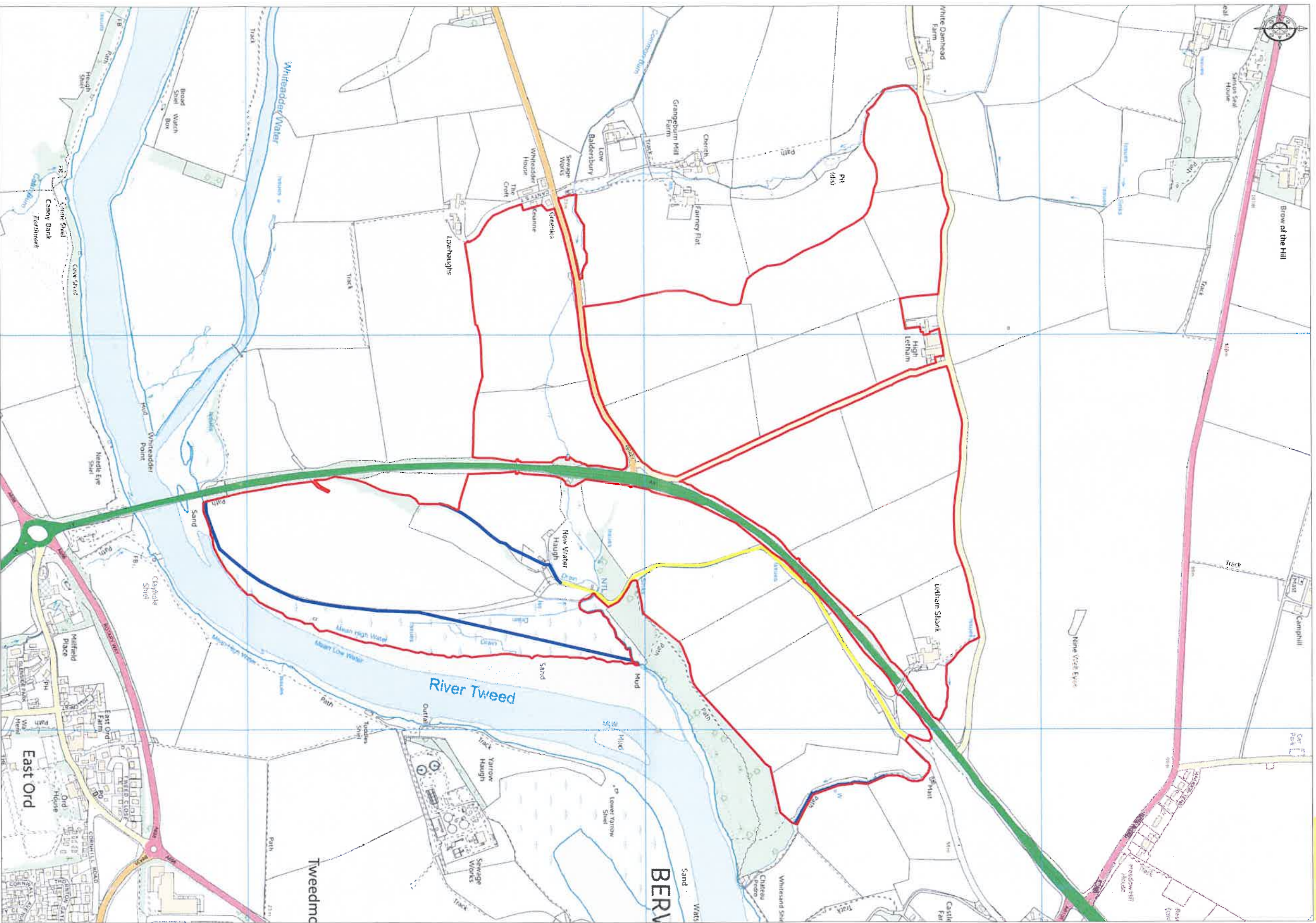

Plan 1 of 7: High Letham & Letham Shank

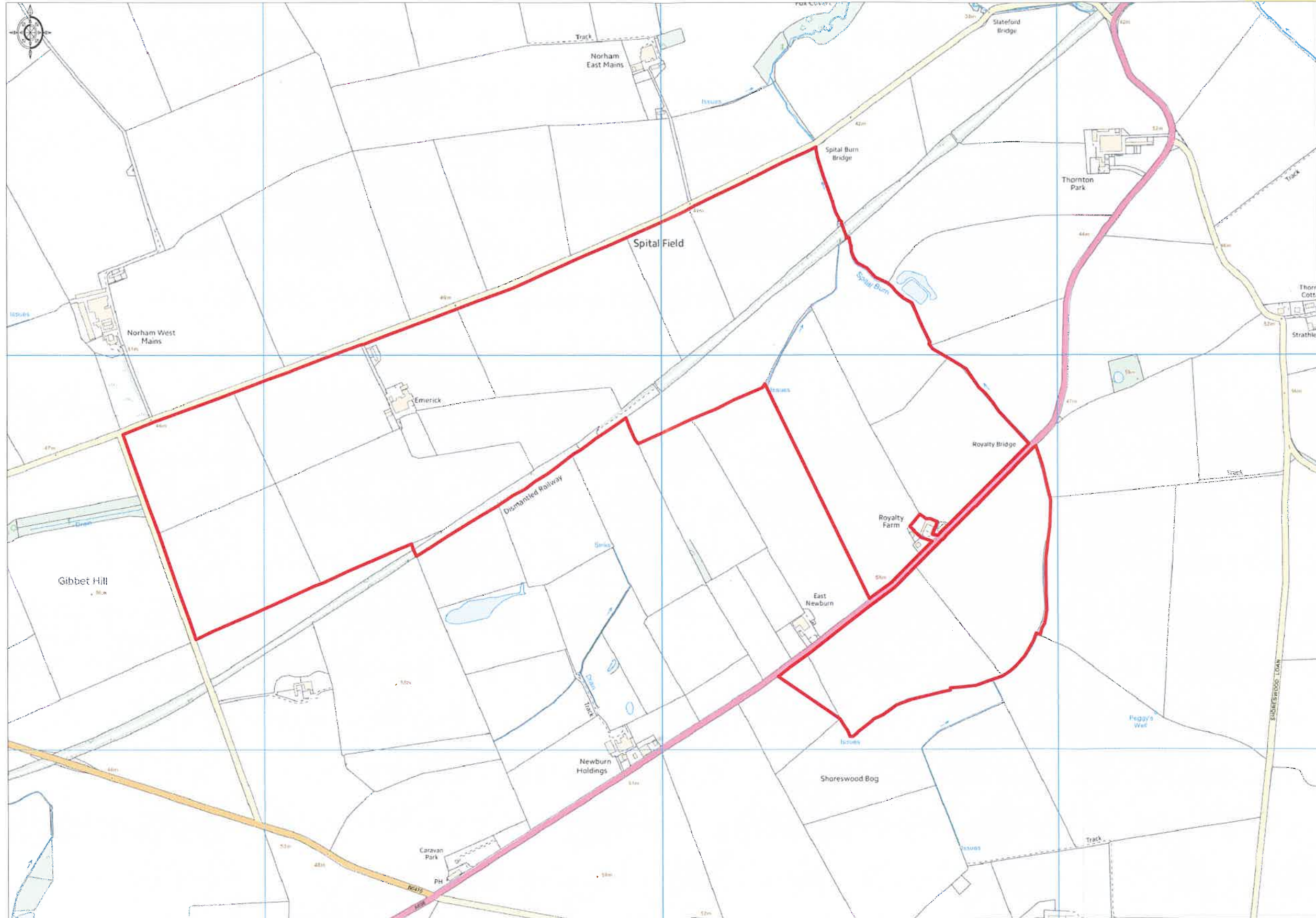

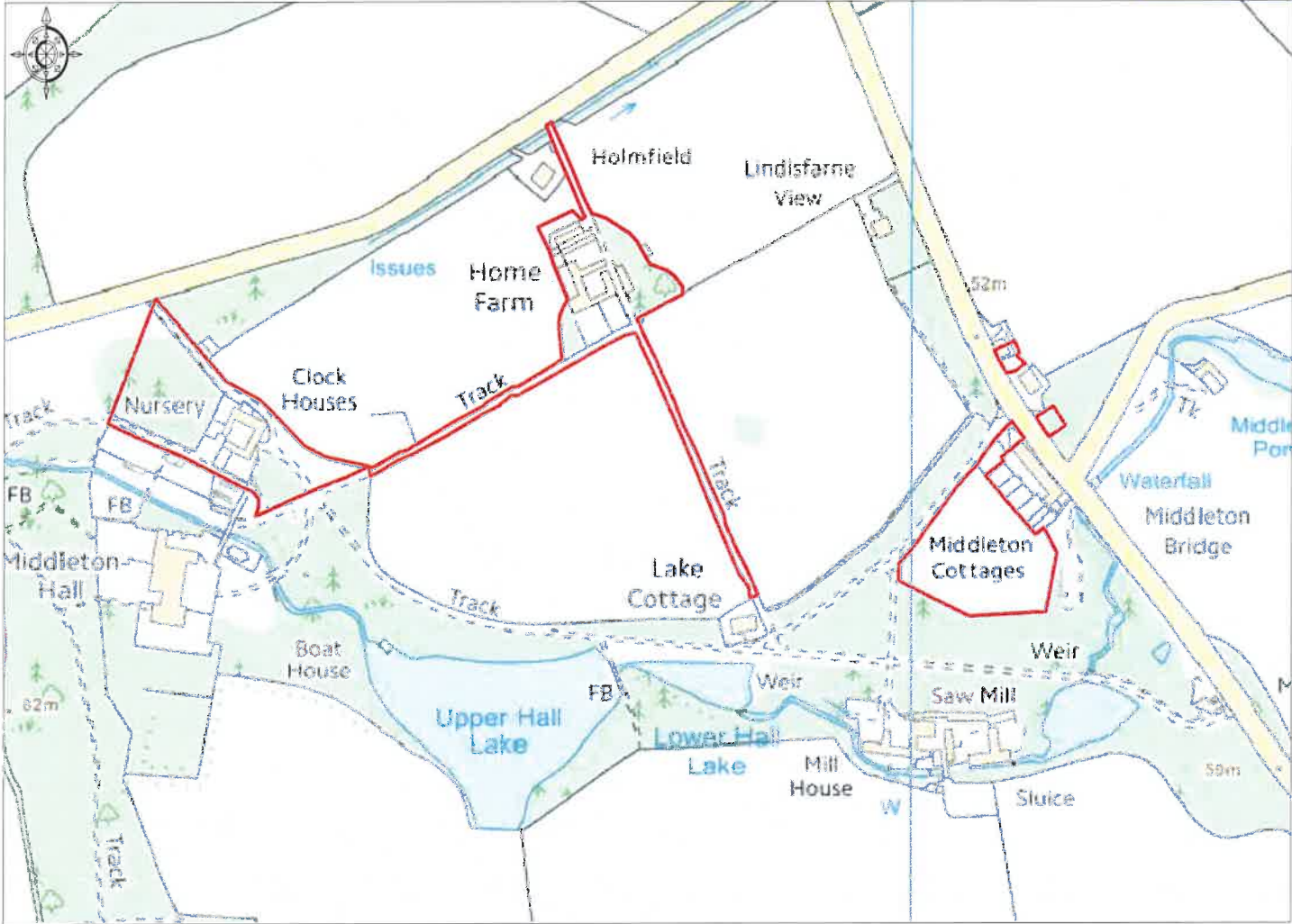
Greenwich Hospital

Plan 5 of 7: Middleton

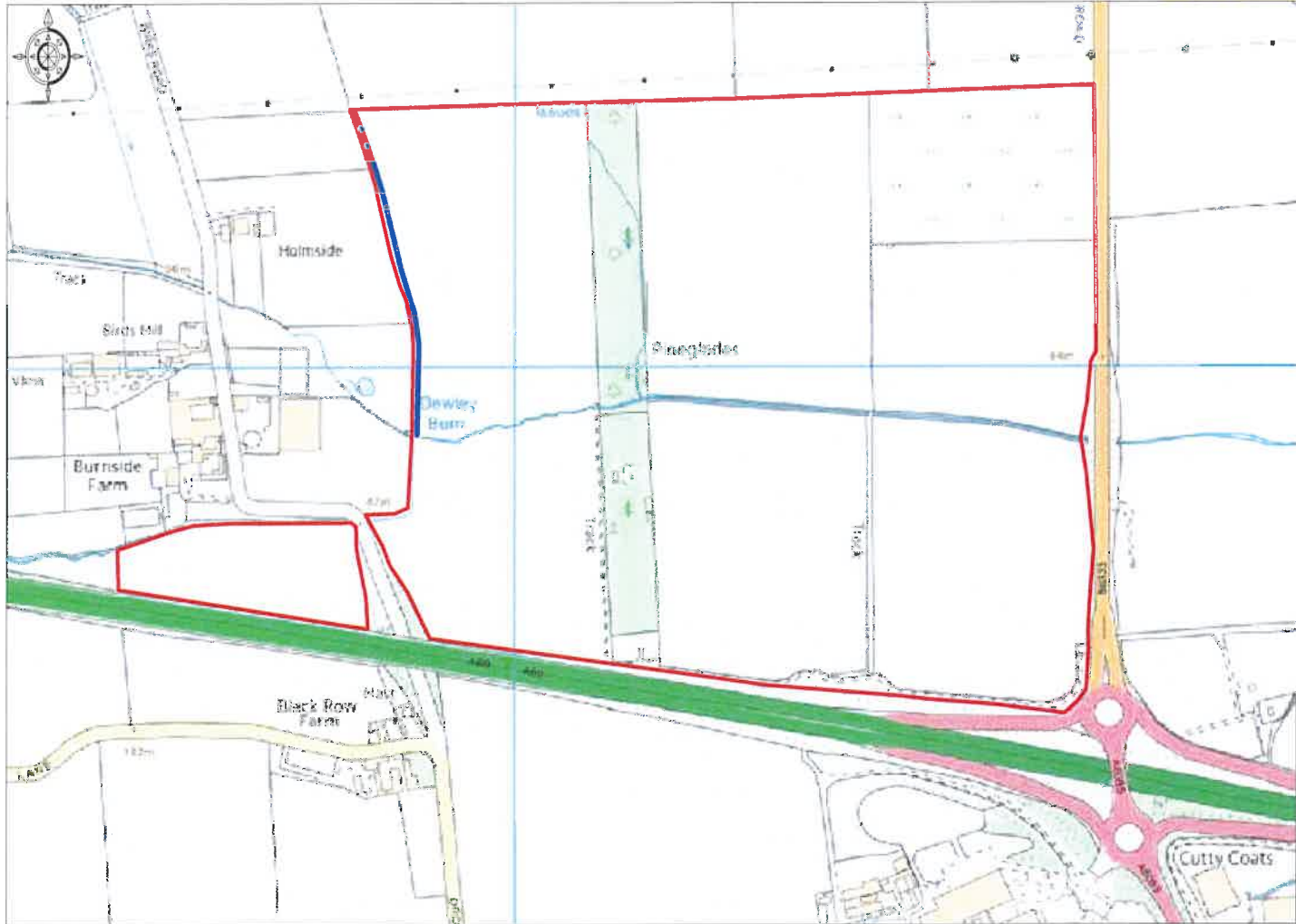

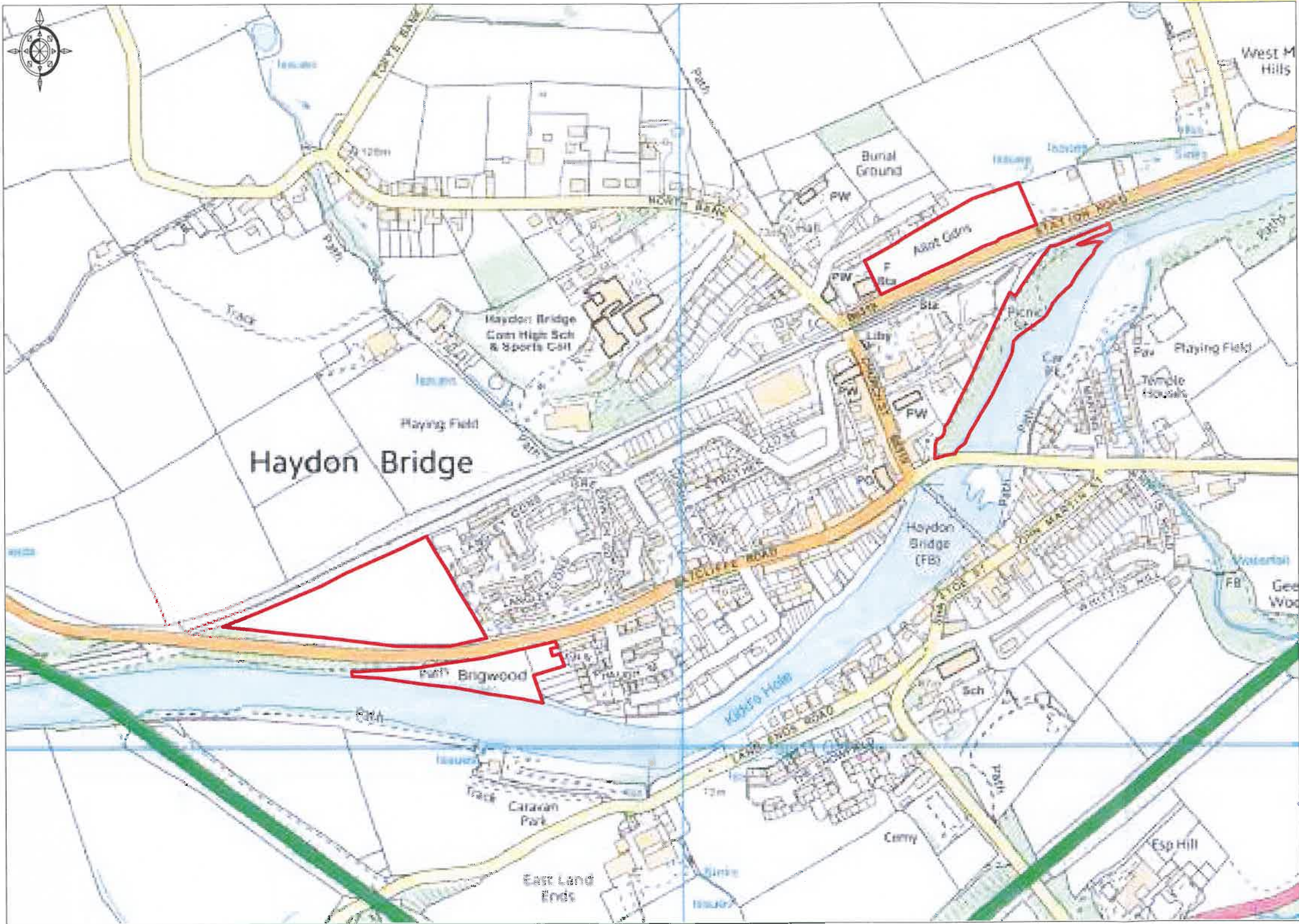
