
- I, EDWARD CHARLES PEAT, Estates Director of Harworth Estates and Authorised Signatory of Potland Burn Limited of Harworth Park, Blyth Road, Haworth Doncaster, South Yorkshire DN11 8DB DO SOLEMNLY AND SINCERELY DECLARE as follows:-
- 1. Potland Burn Limited is the owner (within the meaning of the above section) of the land in the County of Northumberland more particularly delineated on the plans attached to this Statutory Declaration and thereon edged red ("the Land").
- 2. On 22 August 2000 my agents deposited with Northumberland County Council, being the appropriate Council, a Deposit Statement by Edward Charles Peat on behalf of RJB Mining (U.K.) Limited accompanied by plans delineating the Land by red edging.
- 3. The Deposit Statement referred to in paragraph 2 above stated that the ways coloured blue on the said plans and on the maps accompanying this Statutory Declaration had been dedicated as footpaths and the ways coloured green on the said plans and on the maps accompanying this Statutory Declaration had been dedicated as bridleways.
- 4. On 28 September 2000 my agents deposited with Northumberland County Council, being the appropriate Council, a Statutory Declaration by Edward Charles Peat (authorised to sign documents on behalf of RJB Mining (UK) Limited) dated 19 September 2000 declaring that no additional ways had been dedicated as rights of way since the deposit of the Deposit Statement referred to in paragraph 2 above.
- 5. On 25 May 2001 RJB Mining (U.K.) Limited changed its name to UK Coal Mining Limited and on 22 May 2009 the Land was transferred to Potland Burn Limited.
- 6. No additional rights of way have been dedicated by me / RJB Mining (U.K.) Limited / UK Coal Mining/ Potland Burn Limited over the Land edged in red on the plans accompanying this Statutory Declaration since the Deposit Statement dated 22 August 2000 referred to in paragraph 2 above and the Statutory Declaration referred to in paragraph 4 above and I / UK Coal Mining Limited/ Potland Burn Limited have no intention to dedicate any such ways.
