

**HIGHWAYS ACT 1980  
Statement under Section 31(6)**

**I, Jennifer Jane Lovett of Wark Farm Cornhill-on-Tweed in the County of Northumberland, DO SOLEMNLY and SINCERELY DECLARE as follows:**

1. I am and have been since the Fourth day of November One thousand nine hundred and eighty four the owner within the meaning of Section 31 of the Highways Act 1980 of the property known as Wark Farm, in the Parish of Carham, Cornhill-on-Tweed in the County of Northumberland. The said property is more particularly delineated on the two maps annexed to this Declaration, namely on the map marked "Plan 1", and thereon edged red, except for the village of Wark itself and its immediate environs, where the extent of the said property in my ownership is more particularly shown on the map marked "Plan 2" and thereon edged red.
2. On the Twenty seventh day of November Two thousand and twelve I deposited with Northumberland County Council, being the appropriate Council, a Statement dated the Twelfth day of November Two thousand and twelve accompanied by maps identical to those annexed hereto which said Statement stated that the ways shown coloured green on the said Plans 1 and 2 are within my said property and have been dedicated for the use of the public or otherwise designated as Byways Open to All Traffic; and that the ways shown coloured blue on the said Plans 1 and 2 are within my said property and have been dedicated for the use of the public or otherwise designated as footpaths.
3. No additional ways have been dedicated over the said property within my ownership shown on the said maps accompanying this Declaration since the date of the said Statement referred to in paragraph 2 above and I have no present intention to dedicate any other public rights of way over the said property.

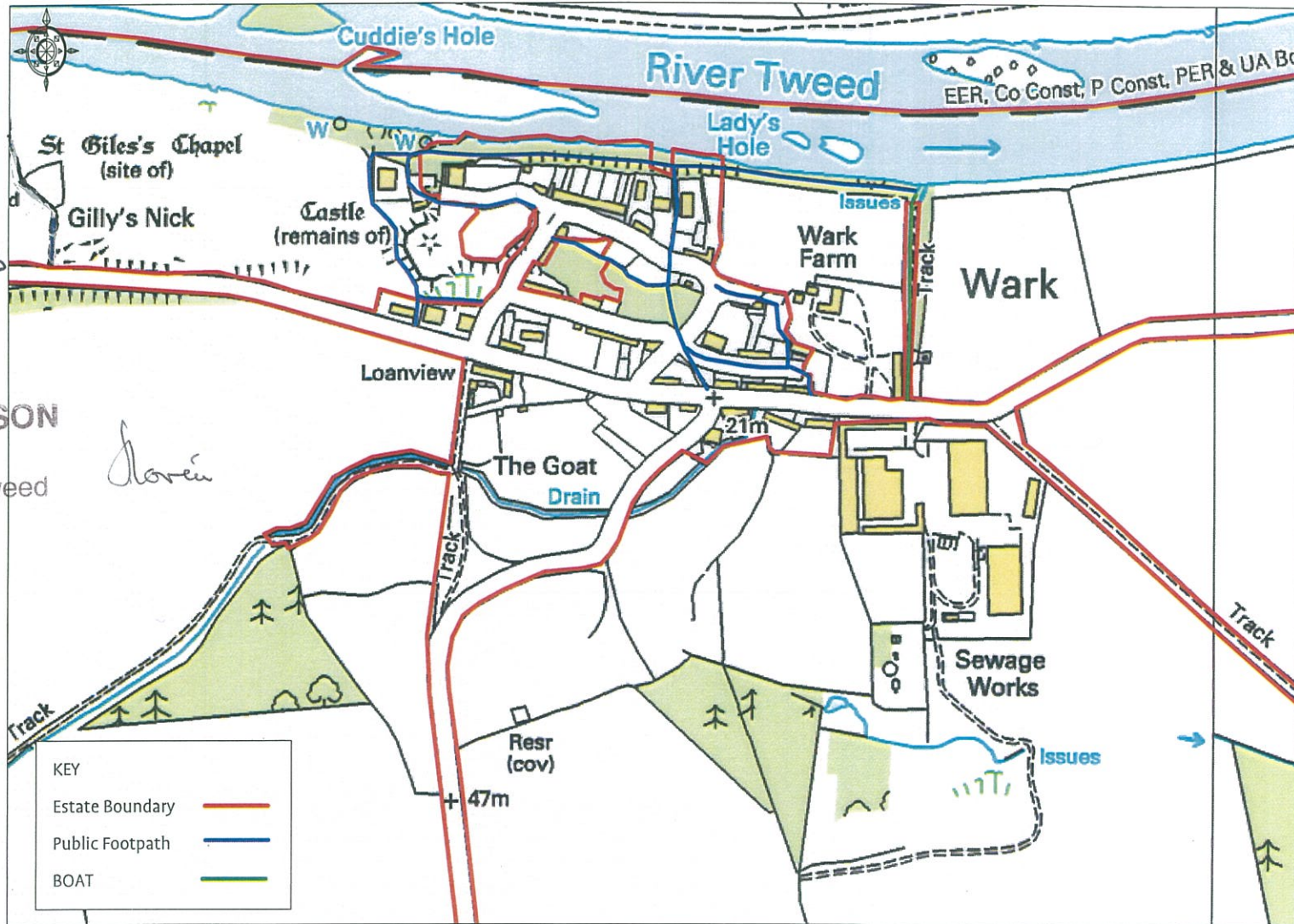
