PROPOSED 'RESIDENT PERMIT PARKING ZONE' CIRCLE PLACE & 'NO WAITING AT ANY TIME' RESTRICTION - HAUGH LANE - HEXHAM

Purpose of report:

To consider introducing a 'Resident Permit Parking Zone' on Circle Place and 'No Waiting at Any Time' restriction on Haugh Lane in Hexham.

Recommendations:

It is recommended that the Executive Director of Local Services agrees the proposals set out in the report relating to;

1) The provision of 'a 'Resident Permit Parking Zone' on Circle Place and 'No Waiting at Any Time' restriction on Haugh Lane in Hexham.

Key issues

- 1) The current 'No Waiting Every Day between 9am and 6pm' restriction causes parking difficulties for residents of Circle Place.
- 2) The gap in the existing 'No Waiting at Any Time' restrictions on Haugh Lane causes congestion.

PROPOSED 'RESIDENT PERMIT PARKING ZONE' CIRCLE PLACE & 'NO WAITING AT ANY TIME' RESTRICTION - HAUGH LANE - HEXHAM

BACKGROUND

Introduction

- 1) Circle Place is purely residential in nature and is situated on the periphery of the town centre. A walkway provides access to the busy Haugh Lane Industrial Estate immediately to the north whilst some local businesses operate at the junction where Circle Place meets Gilesgate. The road averages approximately 5 metres in width and opens out at the bottom to allow for turning requirements. A 'No Through Road' sign is provided on the entry to Circle Place whilst 'No Waiting Every Day between 9am 6pm' signs are utilised at 60 metre intervals to support the existing single yellow line operating throughout the full extents of the highway. Access is available to the rear of the properties via an unadopted road.
- 2) Residents initially approached the Local Member Councillor Robson for the area to see if the current restrictions could be amended to allow parking during the day. Due to the narrow width of the road, the safety concern of getting emergency service vehicles through and the potential for nearby business customers to make use of Circle Place, representatives of the County Council were reluctant to simply lift the 'No Waiting' restriction without imposing some form of mitigation measure. As such, the option of imposing a 'Resident Permit Zone' on Circle Place was put forward for consultation.

Consultation

- 3) Consultation took place throughout August 2013 with a proposal to remove the existing 'No Waiting Every Day 9am-6pm' restriction and replace it with a 'Resident Permit Parking Zone' as shown on Appendix 1.
- 4) Signs at the entry points to Circle place would dictate where Resident Permit Parking is in operation. Bays would not be provided within the zone as they are not required for this type of restriction. To make this scheme enforceable, residents of Circle Place would be asked to purchase Resident Parking Permits. (Currently £15 a year per permit). A maximum of 2 permits would be made available per household with one permit reserved for residents and one for visitor parking. The zone would cover adopted highway only. 'No Waiting at Any Time' restrictions are also proposed on Haugh Lane as shown on the plan to ease congestion.

- 5) 39 consultation letters were sent out to those affected and to associated statutory bodies. Of those that responded there were no objections and 5 indicated their preference for the scheme, (see Appendix 2). Residents indicated that they have to make use of the Tesco car park which is an estimated 400 metres away. The North East Ambulance Service also offered their support for the scheme and residents were reminded within the original consultation document to leave sufficient space for emergency vehicles to pass. Finally, Hexham town Council indicated their preference for the scheme.
- 6) The Council has the power to hold a public inquiry before making a traffic regulation order. Such an inquiry might enable disputed evidence to be tested under cross-examination and the need for an order to be critically examined by an independent inspector. In this particular case, officers believe that the extensive consultation process and involvement with interested parties, means that such an inquiry is unlikely to bring any fresh information to light and it is therefore recommended that an inquiry is not held.

<u>Proposed 'Resident Permit Parking Zone' – Circle Place & proposed 'No</u> Waiting' restriction – Haugh Lane - Hexham

It has been brought to the attention of the County Council that residents of Circle Place in Hexham are experiencing parking difficulty due to the existing 'No Waiting Every Day 8am – 6pm' restriction.

After discussion with your Local Member Councillor Robson, it is proposed to remove the current 'No Waiting' restriction and replace it with a 'Resident Permit Parking Zone' as shown on the attached plan. Signs at the entry points to Circle place will dictate where Resident Permit Parking is in operation. Bays would not be provided within the zone as they are not required for this type of restriction. To make this scheme enforceable, residents of Circle Place will be asked to purchase Resident Parking Permits. (Currently £15 a year per permit). A maximum of 2 permits are available per household with one permit reserved for residents and one for visitor parking. 'No Waiting at Any Time' restrictions are also proposed on Haugh Lane as shown on the plan to ease congestion.

The scheme will cover adopted highway only and will be for residents and visitors only. Private access and parking will still be permitted without the use of permits as long as the parking takes place off the highway in a suitable manner. If the scheme does proceed to implementation residents are reminded to leave sufficient space for emergency and refuse vehicles to pass safely.

I am therefore writing formally in accordance with Regulation 5 of the Local Authorities Traffic Orders (Procedure)(England and Wales) Regulations 1996 (as amended) to ask for your comments on the proposals as above and shown on the enclosed plan. The proposal is being considered for preventing the use of the road by vehicular traffic in a manner which is unsuitable having regard to the existing character of the road.

The County Council is seeking your views and a free post response form is attached to facilitate the consultation process. I would welcome a reply by Monday 23rd September 2013. If no comments are received by that date it will be assumed that you do not wish to make any representations regarding the above proposal. You may wish to note that any comments received may be included in a Decision Report to be assessed by the Corporate Director of Local Services and may be available for public inspection.
