

RECORD OF DECISION TAKEN BY CORPORATE DIRECTOR EXECUTIVE DIRECTOR OF LOCAL SERVICES: BARRY ROWLAND

PROPOSED PARKING RESTRICTIONS COLLYWELL BAY ROAD, SEATON SLUICE

Purpose of Report

To consider the results of the public consultation exercise, regarding proposed parking restrictions on Collywell Bay Road, Seaton Sluice, (see attached consultation plan in appendix A).

Recommendations

It is recommended that:

- 1) The proposed parking restrictions on Collywell Bay Road are not provided.
- 2) The proposed parking restrictions at the Collywell Bay Road/Beresford Road junction are provided.
- 3) Appropriate signage is provided to direct visitors to the Community Centre car park.

Key Issues

- 1) Representations have been received about parked cars causing congestion and safety issues in Collywell Bay Road.
- 2) Some short sections of double yellow lines were provided in the area in 2014 following receipt of a residents petition.
- 3) Indiscriminate parking also occurs at the junction of Collywell Bay Road and Beresford Road by users of the nearby chip shop.

Link to Corporate Plan

This report is relevant to the *Places and Environment Aim* in the Corporate Plan:

Our aim is to maintain and further improve the quality of our towns, villages and countryside and make it easier for residents to access services and high quality, affordable homes and to travel using different modes of transport. To achieve this, we will keep Northumberland clean, green and safe from detrimental impacts of climate change, build more houses to benefit those most in need and provide a convenient, integrated public transport network.

Background

- 1. Parked cars on both sides of Collywell Bay Road can make it difficult for oncoming vehicles to pass, with the road width often reduced to one lane.
- 2. In 2014, following receipt of a petition and subsequent consultation with local residents, some small sections of double yellow lines were provided in order to create sections where vehicles can pass.
- 3. Further representations have since been received requesting that these small sections of double yellow lines be 'joined up' to create a continuous restriction.
- 4. It is claimed that traffic still cannot pass adequately, leading to safety concerns.
- 5. It is also claimed that access for emergency services is impeded; however, this claim is not backed up by the consultation responses.
- 6. As well as residents, visitors to the beach and local café also park in this area.
- 7. Parking also occurs at the junction of Collywell Bay Road with Beresford Road by visitors to the nearby chip shop. This parking affects visibility at the junction and blocks a cycle track.

Consultation

- 8. A scheme of additional double yellow lines was prepared and was the subject of a consultation which concluded on 5th January 2015
- 9. The consultation exercise involved the delivery of a consultation letter together with a plan showing details of the scheme to residents, statutory consultees; County Councillor Dungworth, Seaton Valley Council; road user organisations; and other interested parties. The proposal was also available to view and comment via the Council's website. A plan showing the scheme is attached as Appendix A. The consultation letter is attached as Appendix B.
- 10. 22 responses were returned. 8 were in favour of the proposal (36%), 13 against (59%), 1 neither (5%). A summary of the responses is attached as Appendix B.

- 11. Many of those who responded were strongly against the proposal, stating they did not consider there to be a problem, and that the sections of double yellow lines already provided were a suitable solution.
- 12. A number of respondents were, however, in favour of providing double yellow lines at the Collywell Bay Road/Beresford Road junction.
- 13. Seaton Sluice Community Association has offered the use of their car park in Albert Road for public parking, which would help reduce pressure on Collywell Bay Road. Some signage may be necessary to direct visitors to this car park.
- 14. One statutory consultee responded. The North East Ambulance Service recognised and appreciated the need for the scheme and supported the proposals. No other Emergency Services responded.
- 15. Seaton Valley Council stated that residents would be unlikely to agree to the proposals and there may also be an adverse impact on local businesses.
- 16. In addition to the formal consultation, a local resident undertook an informal survey of those residents directly affected by the proposal.
- 17. This survey asked residents if they thought there was a problem with parking or congestion, and whether they thought the proposed restrictions would have a positive or negative effect.
- 18. Thirteen households responded to this survey. 12 of the respondents stated there were no issues with parking or congestion and that the proposal would have a negative effect. Only one stated that there were problems and the proposal would have a positive effect.

Conclusion

- 19. It is recommended that, in view of the results of the consultation exercise:
 - 1) The proposed 'No Waiting at Any Time' restrictions should not be provided on Collywell Bay Road.
 - 2) The proposed 'No Waiting at Any Time' restrictions should be provided at the Collywell Bay Road/Beresford Road junction.
 - 3) Appropriate signage is provided to direct visitors to the Community Centre car park.



<u>Proposed Amendments to Parking Restrictions – Collywell Bay Road, Seaton Sluice</u>

Concerns have been raised by residents regarding parking problems in Collywell Bay Road. Some short lengths of double yellow lines were provided recently, in order to provide room for traffic to pass. However, it has come to our attention that parked cars are still causing congestion and access issues. With this in mind, I am writing to you to find out your views on extending the existing 'No Waiting At Any Time' parking restriction so that it forms a continuous length, as shown on the enclosed plan. Restrictions are also proposed at the junction with Beresford Road in order to keep the junction and the cycle track free of parked cars.

I am therefore writing formally in accordance with Regulation 5 of the Local Authorities Traffic Orders (Procedure)(England and Wales) Regulations 1996 (as amended) to ask for your comments on the proposals as above and shown on the enclosed plan. The proposal is being considered to improve the amenities of the area.

A free post response form is attached to facilitate the consultation process. I would welcome a reply by Monday 5th January 2015. If no comments are received by that date it will be assumed that you do not wish to make any representations regarding the above proposal. Regrettably, it is not possible to reply to all individual comments but staff will be on hand to clarify any queries you may have. You may also wish to note that any comments received may be included in a Decision Report and may be available for public inspection.

The council considers that residents may not be happy with double yellow lines amendment proposed on Collywell Bay road, there will be an impact on businesses, and they are asking if it would be possible to consider a trial of a one-way system along Collywell Bay road as an alternative, please. Yours sincerely - Lorraine Fox service Officer. I have lived here for 22 years, lived in Seaton Sluice 37 years I've never had a problem until they put in yellow lines. Just recently had 2 hip operations I'm now back at work part times when I get home how do I carry my shopping when cars are parked outside my doors I'm not able to carry heavy stuff. One person (George Wilson) should not be able to change our street, as he's the complainer. People are coming from other areas and parking on yellow lines. If yellow lines appear we want parking permits as back lane is dark and congested. Blyth valley was a good council but Northumberland are letting us down. We will have protest if you change our parking plus remove the yellow lines that you have put down, your spoiling a coastal resort SHAME! do not support the councils proposals of yellow lines. Congestion is worse since the council placed the yellow lines at the wa memorial statue, without the views of residents in the first instance on Collywell Bay road. I do not know anyone in Collywell Bay who is supporting this proposal. Why does the council look at building a car park??? or extending the car park at the bottom of the avenue. What needs to happen is a sign post informing visitors not to park on the residents side of the road - e.g. Parking meters, passes for residents (free) surely other proposals can be implemented instead of being negative towards residents. After you review all the residents views are you going to reconsider???? Let us know what you decide. is this area not a conservation area? Is yellow ines within the restrictions? 1 I have never had any issues We strongly oppose this suggested amended scheme. Even after 'day visitors' have left there is often insufficient parking space for residents and their guests. I have occasionally had to park on double yellow lines opposite my home using my 'Blue Badge' as I have walking difficulties. Any further reduction in parking space would make life very difficult for many residents as there is simply nowhere else to park. A simple way to reduce the problem for residents would be to impose 'Residents Only' parking but this would have a detrimental impact on businesses in the area. However this did not seem to be a consideration when residents of West terrace and Waterford close had their parking spaces protected. This proposal does not include any provisions for rate payers and residents of Collywell Bay road. How will 'The amenities of the area' be improved by punitive proposals that favour occasional parking over resident parking? As residents we are aware of a strong strength of feeling against existing and further parking proposals. We would be interested to learn about the 'congestion and access issues' you refer to, since we believe these to be entirely without foundation. As in your previous consultation on this matter, you have introduced a second area of proposed change (Beresford Road). This facilitates inaccurate and invalid conclusions - Collywell Bay road should be considered in a separate way. A freedom of information request will be submitted in which you can explain the rationale behind these proposals. We support the proposal for double yellow lines at the junction with Beresford Road. We do not support the proposal for additional double yellow lines anywhere along Collywell Bay road. The park side should be left clear for anyone visiting or delivering, or working on the houses on CB rd. We have never had any parking problems in this area during our time here form 1974, but as the volume of cars parking has increased considerably since that date it may be time for the housing side to be nade limited to residents only parking certain times and most definitely at all times if the proposal is past!
