RECORD OF DECISION TAKEN BY EXECUTIVE DIRECTOR OF LOCAL SERVICES

PROPOSED 20mph SPEED LIMIT – LYSDON AVENUE / MELTON DRIVE AREA, NEW HARTLEY

Purpose of report:

To consider the results of the public consultation exercise regarding the proposed introduction of a 20mph speed limit in the Lysdon Avenue and Melton Drive area of New Hartley.

Recommendations:

It is recommended that in view of the consultation exercise, the 20mph speed limit should be introduced as proposed.

Key issues

- 1) Scheme being funded by Councillor Dungworth.
- 2) The scheme will improve road safety in the area as the 20mph speed limit will reduce vehicle speeds.
- 3) Supported by Local Councillor, Parish Council, and the vast majority of residents who responded to the consultation.

BACKGROUND

- 1) Concerns have been raised by local residents about excessive vehicular speed and road safety in the Lysdon Avenue and Melton Drive area of New Hartley. In view of this, Councillor Dungworth requested officers consult residents on the possible introduction of a 20mph speed limit.
- 2) These proposals were the subject of a consultation exercise that involved the delivery of a consultation letter to approximately 330 households, and approximately 30 statutory consultees, including the emergency services and various disabled and transport associations/organisations. A plan showing the proposals is attached together with a copy of the consultation letter (see Appendix 1).

CONSULTATION

- 3) The consultation exercise ended on 1st December 2014, and responses were received from 83 households, with 76 in favour and 7 against the proposals. A summary of these responses is attached as Appendix 2.
- 4) North East Ambulance Service was the only statutory consultee who responded to the consultation, they supported the proposals, however they indicated that response times may be affected.

IN FAVOUR

- 5) Whilst indicating their support of the proposals on the response form provided, the following comments were made:-
 - Scheme cannot be introduced soon enough.
 - Scheme should be introduced in the whole village.
 - Physical Traffic Calming Measures are needed.
 - Parking problems in the area need to be investigated.
 - Pedestrian Crossing needed on main road through village at shops.
- 6) In response to these comments, where appropriate, requests have been added to the Directory of Requests for consideration in a future Local Transport Plan (LTP) Programme.

OBJECTIONS

- 7) Whilst objecting to the proposals on the response form provided, the following comments were made:-
 - Scheme is a waste of money
 - There are no speeding problems in the area.

RECOMMENDATIONS

8) From the outset, the County Council has endeavoured to respond positively to local concerns raised in this area and it is inevitable that some sections of the community will be dissatisfied with whichever decision is

reached. The results of the consultation exercise show that the majority of residents who responded support the proposals. It is therefore recommended that the 20mph Speed Limit is introduced as proposed.

9) The Council has the power to hold a public inquiry before making any traffic regulation order. Such an inquiry might enable disputed evidence to be tested under cross-examination and the need for an order to be critically examined by an independent inspector. In this particular case, officers believe that the extensive consultation process and involvement with interested parties, means that such an inquiry is unlikely to bring any fresh information to light and it is therefore recommended that an inquiry is not held.

Proposed 20mph Speed Limit - Lysdon Avenue / Melton Drive area, New Hartley

Concerns have been raised by local residents about traffic speeds and road safety in the above area. Councillor Dungworth has also expressed her concerns and has agreed to fund the introduction of a 20mph Speed Limit at the Lysdon Avenue and Melton Drive areas of New Hartley subject to favourable consultation with residents.

I am therefore writing in accordance with Regulation 5 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1998 (as amended) to formally ask for your comments on the proposal to introduce a 20mph speed limit on the Lysdon Avenue and Meldon Drive areas of New Hartley as shown on the attached plan.

The following streets will be governed by the 20mph speed limit:- Lysdon Avenue, Gloria Avenue, Seaburn View, Seaburn Avenue, Wansbeck Grove, Alston Road, Maple Court, Mountford Road, Merrington Close, Mountrose Close, Melton Drive, Hastings Gardens, Hastings Terrace and Apple Court.

The start of the limit will be identified by means of 20mph terminal signs. 20mph repeater signs will be introduced at intervals throughout the extent of the proposed limit.

The County Council is seeking your views on the proposals and a freepost response form is attached to facilitate the consultation process. It should be stressed that this is a genuine consultation and that comments received will be carefully considered.

Regrettably, it is not possible to reply to individual comments, but you may wish to note that comments may be included in a Decision Report, to the Executive Director of Local Services and may be available for public inspection. The closing date for any comments you may wish to make is Monday 1st December 2014, if you wish to respond to this consultation online, please visit the web address http://trafficconsult.northumberland.gov.uk/.




I would urge you to take the opportunity to comment on this important matter as any decision taken will be based upon the responses received from residents who take time to return the consultation form.

I conclude by saying that this idea is one of the most ludicrous I have ever neard, as well as being a total waste of money and a ruination of the ambiance of the village. Unless of course there have been a large number of recorded traffic deaths and serious accidents to warrant such a measure.

We take this opportunity to draw your attention to another hazard within New Hartley road network. Prior to the construction of a chicane, at the Western end of Bristol Street, many motorists were speeding into the village and overtaking vehicles, which were parked on the inner curve of the road. This greatly increased the chance of them having 'head-on' collisions with vehicles leaving the village. The chicane has improved the situation. Unfortunately, in contravention of the chicanes' signage, incompetent motorists are still failing to 'give way' to vehicles leaving the village. Instead, they hurry though the chicane and overtake the parked cars. This again results in great risk of them colliding with vehicles leaving the village.
