# RECORD OF DECISION TAKEN BY EXECUTIVE DIRECTOR OF LOCAL SERVICES

# PROPOSED PROVISION OF BOLLARDS – U6528 SYCAMORE STREET / MAPLE STREET BACK LANE, ASHINGTON

#### Purpose of report:

To consider the results of the canvass exercise, regarding the proposed provision of bollards at Sycamore Street / Maple Street Back Lane in Ashington.

#### Recommendations:

It is recommended that in view of the consultation exercise, the bollards should be introduced as proposed.

### Key issues

- 1) Scheme being funded by Councillor Wilson.
- 2) The scheme will improve road safety in the area as the road is currently used as a "rat run".
- 3) The bollards will assist in enforcing the existing Traffic Regulation Order, effectively making a "No Through Road" at this location.
- 4) Supported by Local Councillor and the vast majority of residents who responded to the consultation.

### **BACKGROUND**

- 1) Concerns have been raised by local residents by way of a petition regarding road safety and the fact that the Sycamore Street / Maple Street Back Lane is used as a "rat-run" by drivers to avoid traffic lights situated in Ashington Town Centre. This is despite the fact that a Prohibition of Driving Traffic Regulation Order is already in place restricting the use of vehicular traffic on the U6528 Sycamore Street/Maple Street Back Lane.
- 2) County Councillor Wilson has also expressed concerns and has agreed to fund the installation of bollards, which will assist in enforcing the existing Traffic Regulation Order, effectively making a "No Through Road" at this location. Signage to indicate this will be sited as necessary. It should be noted that the street will still be open to pedestrian traffic and cyclists.
- 3) These proposals were the subject of a consultation exercise that involved the delivery of a consultation letter to approximately 80 households/businesses, and approximately 30 statutory consultees, including the emergency services and various disabled and transport associations/organisations. A plan showing the proposals is attached together with a copy of the consultation letter (see Appendix A).

#### CONSULTATION

- 4) The consultation exercise ended on 14th January 2015, and responses were received from 35 consultees, with 33 in favour and 2 against the proposals. A summary of these responses is attached as Appendix B.
- 5) North East Ambulance Service was the only statutory consultee who responded to the consultation, they supported the proposals, however they indicated that response times may be affected.

#### IN FAVOUR

- 6) Whilst indicating their support of the proposals on the response form provided, the following comments were made:-
  - Scheme cannot be introduced soon enough.
  - Scheme will significantly improve road safety in the area.

#### **OBJECTIONS**

- 7) Whilst objecting to the proposals on the response form provided, the following comments were made:-
  - Proposed bollards will make situation worse for residents who would need to access their properties from Woodhorn Road.

#### RECOMMENDATIONS

8) The consultation responses have been discussed with Councillor Wilson, particularly the objections, which have been noted. From the outset, the County Council has endeavoured to respond positively to local concerns raised in this area and it is inevitable that some sections of the community will be dissatisfied with whichever decision is reached. The results of the canvass exercise show that the majority of residents who responded support the proposed bollards. It is therefore recommended that the bollards are introduced as proposed, however, the situation will be monitored with regard to residents living at the north of the bollards who would need to access their properties from Woodhorn Road.

9) The Council has the power to hold a public inquiry before making any traffic regulation order. Such an inquiry might enable disputed evidence to be tested under cross-examination and the need for an order to be critically examined by an independent inspector. In this particular case, officers believe that the extensive consultation process and involvement with interested parties, means that such an inquiry is unlikely to bring any fresh information to light and it is therefore recommended that an inquiry is not held.

# Proposed Provision of Bollards - U6528 Sycamore Street / Maple Street Back Lane, **Ashington**

Concerns have been raised by local residents by way of a petition regarding road safety and the fact that the above location is used as a "rat-run" by drivers to avoid traffic lights situated in Ashington Town Centre. This is despite the fact that a Prohibition of Driving Traffic Regulation Order is already in place restricting the use of vehicular traffic on the U6528 Sycamore Street/Maple Street Back Lane.

County Councillor Wilson has also expressed concerns and has agreed to fund the installation of bollards. It is proposed to site the bollards in the vicinity of the gable end of no. 2 Sycamore Street as shown on the attached plan. The bollards will assist in enforcing the existing Traffic Regulation Order, effectively making a "No Through Road" at this location. Signage to indicate this will be sited as necessary. It should be noted that the street will still be open to pedestrian traffic and cyclists.

Before implementing the installation of bollards we would like to canvass resident's opinion on this proposal. A freepost response form is attached to facilitate this process.

I thank you for your assistance in this matter.


