**Proposed No Waiting at Any Time Restrictions,
C123 Albion Terrace / Lyne Terrace, Lynemouth**

14th December 2016

Purpose of Report

To consider the the introduction of a "No Waiting at Any Time" restriction adjacent to the Health Centre at the junction of C123 Albion Terrace / Lyne Terrace, Lynemouth.

Recommendations

- I. It is recommended that the following restrictions are introduced on Albion Terrace / Lyne Terrace, Lynemouth: No waiting at any time, (double yellow lines).

Key Issues

1. This area has been the subject of traffic safety concerns over a period of time i.e. obstruction of a junction, resulting in visibility issues, raising concerns with residents, local Councillor and Parish Council.
2. The Scheme is funded and supported by Councillor Milburn Douglas.

Background

1. Safety concerns have been identified to Councillor Douglas by residents and staff of the Health Centre on a number of occasions with regard to obstruction of the junction.
2. It is proposed to introduce no waiting at any time restriction in this area
3. This would help improve traffic safety for the residents, Health centre visitors and road users of Albion terrace and Lyne Terrace, Lynemouth.

Consultation

1. These proposals were the subject of a consultation exercise, conducted on the 15th April 2016. This involved the delivery of a consultation letter to 12 properties and 26 statutory consultees, including the emergency services and various disabled and transport associations/organisations. A plan showing the proposals is attached together with a copy of the consultation letter (see Appendix A).
2. The consultation exercise ended on 6th May 2016 and responses were received from 1 consultee, with 1 in favour (with conditions), 0 against and 0 neither for nor against the proposal. A summary of the response is attached as Appendix B.

Comments

1. Councillor Douglas was notified of the results of the consultation.
2. Suggestions resulting from the consultation prompted a site meeting and discussions between the Vice Chair of Lynemouth Parish Council and an Officer of the Council, a revised plan was proposed and agreed upon, attached as Appendix C.
3. Councillor Douglas confirms he wishes to proceed with a revised version of the proposal, this will be funded through his allocation in the Member Local Improvements Programme.
4. This scheme will be carried out at the same time as a similar scheme on Albion Terrace Lynemouth, which has also been proposed and agreed with Councillor Douglas. Thereby, making a saving in advertising costs for the traffic regulation order and programming.

Recommendations

1. It is recommended that the revised proposal as detailed in Appendix C should proceed. A further consultation was not deemed required as the revision takes into consideration the comments and observations provided within the original consultation.
2. The Council has the power to hold a public inquiry before making any traffic regulation order. Such an inquiry might enable disputed evidence to be tested under cross-examination and the need for an order to be

critically examined by an independent inspector. In this particular case, officers believe that the extensive consultation process and involvement with interested parties, means that such an inquiry is unlikely to bring any fresh information to light and it is therefore recommended that an inquiry is not held.




**Re: Proposed No Waiting at Any Time Parking Restrictions,
Wellway Medical, Albion Terrace, Lynemouth**

Further to your letter of 15th April, Wellway Medical has considered the proposed new parking restrictions outside the surgery particularly those on Albion Terrace which is the main thoroughfare through Lynemouth, we are aware that this is an issue and have asked patients not to park outside our front entrance.

However we are confused and concerned by the inclusion of the adjacent roads - Lyne Terrace and the back street of Albion Terrace. We have received no complaints about parking on either of these two streets and note that most of the domestic parking throughout Lynemouth is on side streets precisely the same as these.

We would therefore fully support the no waiting at any time restrictions on Albion Terrace, but object to the inclusion of the other two sides of the surgery in the absence of a similar policy concerning side streets in Lynemouth.

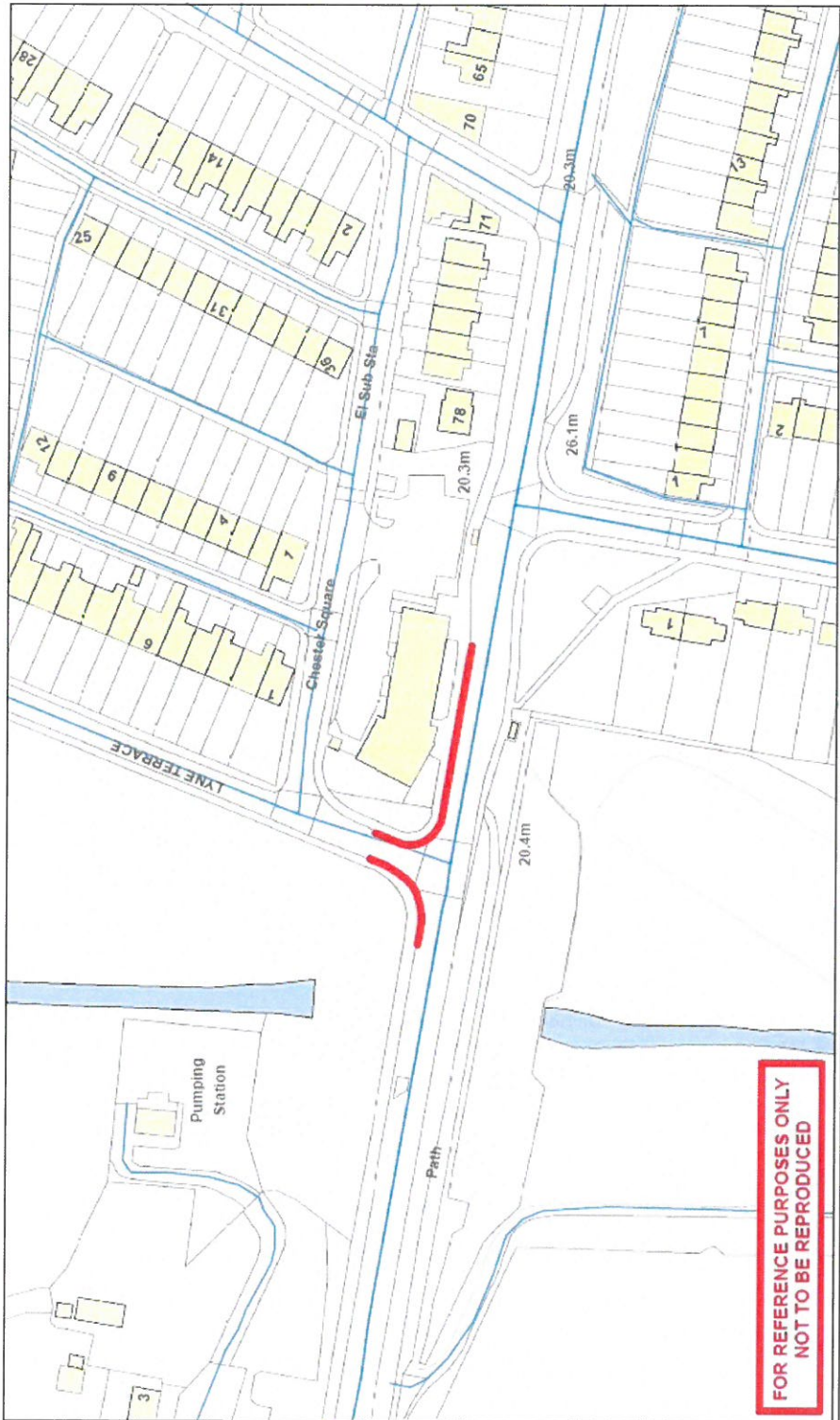
