RECORD OF DECISION TAKEN BY DIRECTOR OF LOCAL SERVICES AND HOUSING DELIVERY

PROPOSED 30MPH SPEED LIMIT EXTENSION C393 HIGH MICKLEY

Background and Key Issues:

- Concerns have been raised by residents and Councillor Anne Dale about road safety at the C393 / U8282 junction in High Mickley.
 Following a site investigation an extension to the 30mph Speed Limit has been proposed in order to alleviate these concerns.
- The 30mph speed limit will be extended on a section of the C393 Hedley-on-the-Hill to Prudhoe road, at the Bowlers Hill area as shown in Appendix 1.
- 3) Bearing in mind the ongoing road safety concerns in the area, and the fact that the speed limit extension will improve road safety, no formal consultation is required, although an information letter has been sent to all affected residents and statutory consultees. A copy of this letter together with a plan of the speed limit extension is attached as Appendix 1. None of the residents or statutory consultees provided any response to the information letter.
- 4) Councillor Dale's support of this scheme is attached as Appendix 2.

RECOMMENDATION:

It is recommended that the 30mph Speed Limit is extended on the C393 as proposed.


