# PROPOSED PARKING RESTRICTIONS, MANOR COTTAGES, CORBRIDGE

**Cabinet Member: Councillor Glen Sanderson** 

#### **Purpose of Report**

To consider the results of the consultation exercise regarding proposals to provide parking restrictions at the entrance to Manor Cottages in Corbridge.

#### Recommendations

It is recommended that the proposed 'No Waiting at Any Time' parking restrictions should be implemented.

#### **Key Issues**

- 1. The County Council received concerns from local residents, the local ward Member and the Parish Council about parking in Manor Cottages, at the junction with Stagshaw Road.
- 2. The consultation was positively received by residents.

#### Background

- 1. The County Council received concerns from local residents, the local ward Member and the Parish Council about parking in Manor Cottages, at the junction with Stagshaw Road.
- 2. Cars are parking at the junction and are blocking sightlines for those entering and exiting Manor Cottages.
- 3. Following a site meeting with representatives of the Parish Council, residents were consulted on a proposal to provide double yellow lines around the junction to keep it clear of parked cars. A copy of the consultation plan is shown in Appendix A.
- 4. 24 responses were received. The results were:

For: 22 (92%)Against: 1 (4%)Neutral: 1 (4%)

- 5. A summary of the responses is shown in Appendix B.
- 6. A number of the respondents also requested residents' permit parking in Manor Cottages. This was rejected in the past therefore it is recommended that the impact of the proposed double yellow lines be monitored and further action taken if necessary.
- 7. The local ward Member is in favour of the proposals.
- 8. The Parish Council is in favour of the proposals.
- 9. It is therefore recommended that the proposed 'No Waiting at Any Time' parking restrictions should be implemented.


