

DIRECTOR OF LOCAL SERVICES AND HOUSING DELIVERY IN CONSULTATION WITH PORTFOLIO HOLDER

PROPOSED PUFFIN CROSSING, NORTH SEATON ROAD, ASHINGTON

Cabinet Member: Councillor Glen Sanderson

Purpose of Report

To consider the results of the consultation exercise, regarding a proposal to provide a puffin crossing on North Seaton Road, Ashington.

Recommendations

It is recommended that:

Given the results of the consultation and the location on a route to school, it is recommended that the proposed puffin crossing be implemented as part of the 2018-19 LTP Programme.

Key Issues

- The County Council has received concerns via the local ward Councillor about the safety of schoolchildren who cross the A196 North Seaton Road in Ashington.
- 2. Concerns about speeding traffic have already been raised with Northumbria Police who have carried out some monitoring.
- 3. Following feasibility work and a consultation it is proposed to install a new puffin crossing.

Background

- The County Council has received concerns via the local ward Councillor about the safety of schoolchildren who cross the A196 North Seaton Road in Ashington.
- 5. Central Primary School is located to the east of North Seaton Road. Pupils who live to the west therefore must cross the road to get to school. The number of pupils crossing is likely to increase due to the recent housing developed on the site of the former Ashington Hospital.

- 6. North Seaton Road is an 'A' class road which carries a significant volume of traffic. A survey carried out in September 2017 recorded an annual average daily traffic figure of 9,108 vehicles.
- 7. Speed information from the survey showed that the 85th percentile speeds were 31mph southbound and 33.7mph northbound. This is below the level at which Northumbria Police would normally undertake enforcement, however, they have carried out some enforcement activity in response to local concerns and have contacted drivers who were travelling over the speed limit.
- 8. In response to the concerns raised an allocation was included in the 2017-18 LTP Programme to allow initial feasibility and design of a puffin crossing. The location of the proposed crossing, which has been agreed by the local ward Member, is shown in Appendix A.
- 9. A school crossing patrol site is in place close to the location of the proposed puffin crossing. It is not possible to locate the puffin crossing at the patrol site due to the proximity of road junctions, however, consideration will be given to combining the two with the possibility of freeing up the school crossing patrol officer to cover a vacant site.
- 10. There is a northbound bus stop located within the controlled area of the proposed crossing. Due to the road layout it is proposed to move this further south so that a vehicle overtaking a stationary bus has sufficient visibility to the signals ahead.

Consultation

- 11. Adjoining residents and statutory consultees were consulted on the proposed puffin crossing.
- 12. Only four responses were received. One was in favour, one against and two were neutral. A record of the responses is shown in Appendix B.
- 13. Three of the four responses were from residents, of which one was in favour, one against and one neutral.
- 14. The response against referred to the loss of parking as a result of the proposed crossing. Approximately 35m of parking space will be lost if the proposal goes ahead. Discussions with the local ward Member has confirmed that the loss of parking is considered acceptable in order to achieve the improved safety for pedestrians crossing the road.

Recommendation

15. Given the results of the consultation and the location on a route to school, it is recommended that the proposed puffin crossing be implemented as part of the 2018-19 LTP Programme.
