PROPOSED 'NO WAITING AT ANY TIME' PARKING RESTRICTION, BAILIFFGATE, ALNWICK

Cabinet Member: Councillor Glen Sanderson

Purpose of Report

To consider the results of the consultation exercise regarding a proposal to provide a 'No Waiting at Any Time' (double yellow lines) parking restriction in Bailiffgate, Alnwick.

Recommendations

It is recommended that the proposed 'No Waiting at Any Time' parking restriction is implemented.

Key Issues

The County Council has received concerns from users of St Michael's Church and Church Lane, via the local ward member, about parked cars obstructing sightlines and access to properties.

The consultation response was positive and the scheme will be funded through the LTP.

Background

- The County Council has received concerns via the local ward member, from users of St Michael's Church and Church Lane about parked cars obstructing sightlines and access to properties.




Fig.1. Church Lane/Bailiffgate junction showing parked cars.

- 2. The entrances to St Michael's Church and Church Lane are adjacent on the north side of Bailiffgate. Residents permit parking bays are in place to the east and there are currently no parking restrictions to the west. Vehicles therefore park here and affect sightlines for those exiting onto Bailiffgate, as shown in Figure 1.

- 3. As well as affecting sightlines for those exiting the Church or Church Lane, the parked cars also force eastbound vehicles out into the centre of the road. The horizontal and vertical alignment of the road here is not good and further affects forward visibility, which means that westbound traffic could meet oncoming traffic 'head on'.
- A 'KEEP CLEAR' road marking is in place at the church entrance, however, this often does not provide sufficient room for those vehicles that do need to stop outside the church, for example for weddings or funerals.
- Residents and statutory consultees were therefore consulted on a proposal to provide a 'No Waiting at Any Time' parking restriction (double yellow lines). The restriction is designed to keep parked cars

away from the Church entrance and from the bend in the road. A copy of the consultation plan is shown in Appendix A.

6. Ten responses were received as follows:

For: 8 (80%)Against: 1 (10%)Neutral: 1 (10%)

- 7. There was no response from Alnwick Town Council, however the local ward members support the proposal.
- 8. Given the outcome of the consultation and the support of the local ward members, it is recommended that the 'No Waiting at Any Time' parking restriction should be implemented.


