PROPOSED PARKING RESTRICTIONS, LONGMEADOWS, DARRAS HALL

Cabinet Member: Councillor Glen Sanderson

Purpose of Report

To consider the results of the consultation exercise regarding a proposal to introduce parking restrictions in Longmeadows, Darras Hall.

Recommendations

It is recommended that the proposed parking restrictions are not implemented.

Link to Corporate Plan

Living - "We want you to feel safe, healthy and cared for" Enjoying - "We want you to love where you live"

Key Issues

The County Council has received concerns from residents of Longmeadows, via the local ward member, about parked cars causing congestion and obstruction issues at school times.

The majority of consultation responses did not support the introduction of parking restrictions.

Background

- The County Council has received concerns via the local ward member, from residents of Longmeadows about indiscriminate parking in the street at school start and finish times.
- 2. Issues raised include congestion preventing access for larger vehicles, obstruction of driveways and drives being used for turning.
- 3. Longmeadows is a residential street with no footways. At its eastern end it has a pedestrian link through to Broadway. Parents dropping off/picking up children from Darras Hall Primary School are using this link to get to and from the school. Figure 1 shows the general area.

- In response to the concerns raised residents were consulted on potential parking restrictions including double and single yellow lines and residents permits. A copy of the consultation letter is shown in Appendix A.
- 5. All 54 properties were consulted. 28 responses were received just over half the eligible respondents. The results were:

Single yellow lines: 6 (21%)

Double yellow lines: 2 (7%)

Residents permits: 4 (14%)

No restrictions: 16 (57%)

A copy of the responses is shown in Appendix B.

- 6. Many of the responses stated that there was no issue at all while others acknowledged the additional cars present at school times but felt that as it is only for short periods restrictions are not necessary.
- 7. There was no response from Ponteland Town Council.
- 8. Given the above it is recommended that the parking restrictions should not be implemented, the local ward member supports the recommendation.

Parking Issues, Longmeadows, Darras Hall

The County Council has received concerns via your local ward member, Councillor Jones, about parking in <u>Longmeadows</u> associated with the school run. In order to address this, the following options are available:

- · Double yellow lines which would prevent parking at all times.
- Single yellow lines which would prevent parking at certain specified times of the day. This could be all day or just at school start and finish times.
- A residents permit parking scheme. This would mean that only residents and their visitors could
 park in Longmeadows. Only two permits are available per household, so the scheme can be
 restrictive. Please note there is an annual charge for each permit. (Note: permits only apply to
 the public highway and are not required to park on private driveways).

I am therefore writing to ask for your views on these proposals, including whether you feel that restrictions should apply to all or only part of the road. A freepost form is enclosed for you to send any comments you may have or you can reply via email to HighwaysProgramme@northumberland.gov.uk or online at http://trafficconsult.northumberland.gov.uk

This is an initial consultation to find out peoples views. You will be consulted formally on any proposals that are brought forward as a result.
