**Proposed Parking Restrictions,

Purpose of Report

To consider the introduction of proposed parking restrictions on Millway, Seaton Sluice.

Recommendations

It is recommended that the following parking restrictions are introduced:
No Waiting at Any Time restrictions (Double Yellow Lines).

Key Issues

1. Residents had raised concerns about indiscriminate parking on Millway, Seaton Sluice following the introduction of the new Co-op.
2. The scheme is to be funded by Councillor Dungworth, through her Members Local Improvement Scheme allowance.
3. Following the consultation and further monitoring it is recommended to proceed with the proposed parking restrictions.

Delegated decisions

Background

1. Residents contacted their local Ward member with concerns regarding safety issues for both pedestrians and motorists caused by parked cars on Millway, Seaton Sluice.
2. Indiscriminate parking on the road is making it difficult for residents and visitors to negotiate this road safely.
3. After meeting with Councillor Dungworth, officers proposed that "No Waiting at Any Time" restrictions be introduced in order to alleviate these concerns.
4. A consultation letter was sent to 25 residents and 26 statutory consultees on the proposed parking restrictions. A copy of the consultation letter and plan are attached in Appendix A.
5. 17 responses were received as a result of the consultation letter, with 13 in favour 3 against and 1 neither for nor against the proposal. A summary of the responses is attached as Appendix B.
6. The results of the consultation were discussed with Councillor Dungworth, who agreed that the proposals should be introduced as proposed.

Proposed Parking Restrictions, Millway, Seaton Sluice

Concerns have been raised with County Councillor Dungworth, regarding vehicles being parked too close to the junction of Millway & Beresford Road, Seaton Sluice, causing traffic safety issues. Councillor Dungworth has therefore requested that "No Waiting at Any Time" restrictions be introduced at this junction in order to alleviate these concerns.

I am therefore writing in accordance with Regulation 5 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (as amended) to formally ask for your comments on the proposal to introduce No Waiting At Any Time Restrictions on the junction of Millway & Beresford Road, Seaton Sluice as shown the attached plan.

The school run parents are being encouraged to park elsewhere for drop off which is already impacting this street, further parking restrictions will make it near impossible for residents to access their own properties, for deliveries and for the co-op to get deliveries given. currently it is mainly shoppers at the co-op who block this road, perhaps make the road resident only which would perhaps alleviate the parking issue. Or alternatively make it a one way street.
	1			The introduction of this restriction will improve the traffic flow in this area as it is becoming very congested throughout the day.

At this present moment we have a lot of fly parking at school times and throughout the day with people accessing the local co-op. Does that then mean that people will just end up parking further into Millway Grove which would in turn make the parking for the residents of Millway grove more difficult and not easier?

The junction is a major safety issue, due to vehicles parking both sides of the road, blocking access & causing blindspots for other drivers, and making it unsafe for pedestrians. This is the main access to Seaton Sluice Junior School!! A man was knocked down on this junction earlier this year, he broke his leg, and now walks with a zimmer frame, his independence is ruined!! Something needs to be done!! The proposed yellow lines would definitely solve the problems we are encountering. I would also suggest on the entrance into Millway Grove A "No Entry", access to properties only sign, like what they have in Waterford Close (S/S), This will alleviate any unwanted vehicles parking in our Cul-De-Sac, as this is not a through road!! And to alleviate vehicles parking on the bank into Millway Grove, as this is becoming a major access problem for use. Beresford Road = Crossing needed by Co-Op - nightmare to cross road more 30 signs needed & speed camera's, is like a race track!! The island is not safe to cross!!
