Introduction of No Waiting Restrictions in Bamburgh, Belford and Seahouses

31 January 2020

Purpose of Report

This report sets out the background to the proposed implementation of new No Waiting Restrictions (Double Yellow Lines) at locations in the north Northumberland villages of Bamburgh, Belford and Seahouses.

Recommendations

It is recommended that the new No Waiting Restriction At Any Time (Double Yellow Lines), on sections of the following locations: Front Street Back Lane Bamburgh, High Street, Belford and Kingsfield Seahouses be introduced.

Key Issues

1. There are issues with indiscriminate parking and sight visibility.
2. These additions are in response to concerns raised by the Parish Council.
3. The decision to introduce a permanent Traffic Regulation Order is supported by the relevant Parish Council and Councillor Renner-Thompson.

Delegated Decision

Background

Following concerns raised by local residents via their Local County Councillor and their individual Parish Councils. These issues are causing a number of road safety issues, including poor visibility at junctions and indiscriminate parking.

This matter was discussed between NCC Officers, County Councillor Renner-Thompson following his discussion with the specific Parish Council i.e. Belford, Bamburgh and North Sunderland & Seahouses Parish Council. It was agreed to introduce No Waiting Restrictions At Any Time (Double Yellow Lines).

Notification of these changes will be advertised as part of the legal process of making this Permanent Traffic Regulation Order.

Details of the new restrictions are shown on the plan in Appendix A.

Northumbria Police, other emergency services and relevant statutory consultees will be notified that this new Traffic Regulation Order.

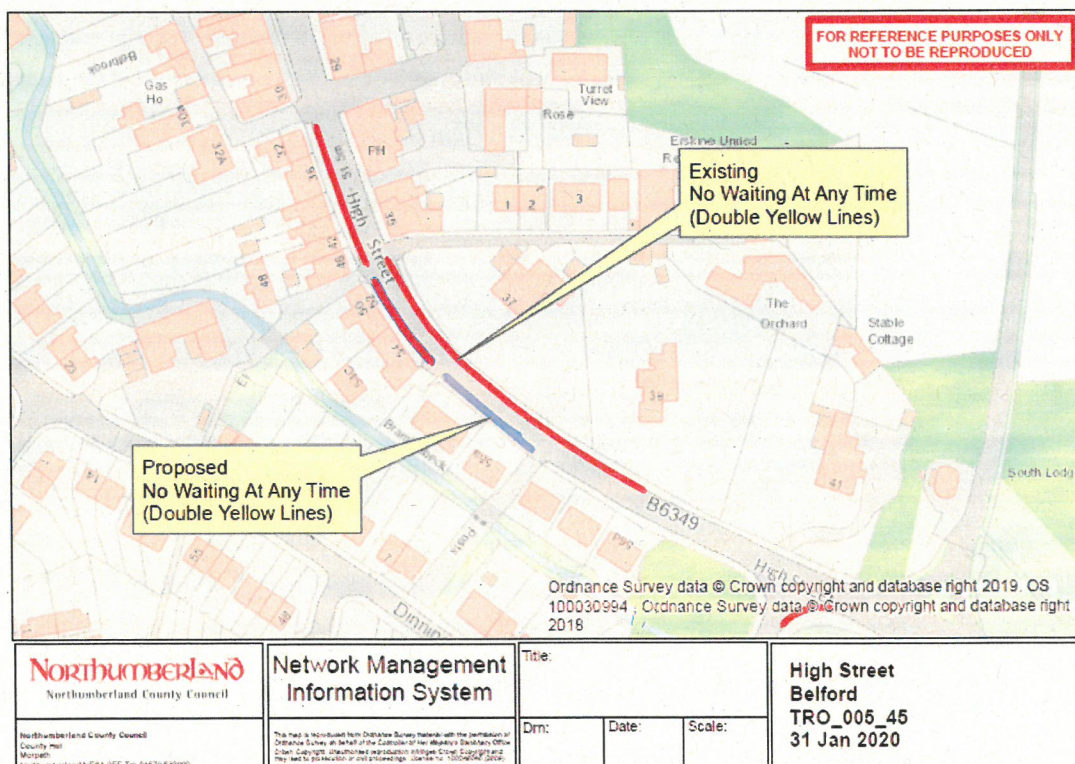
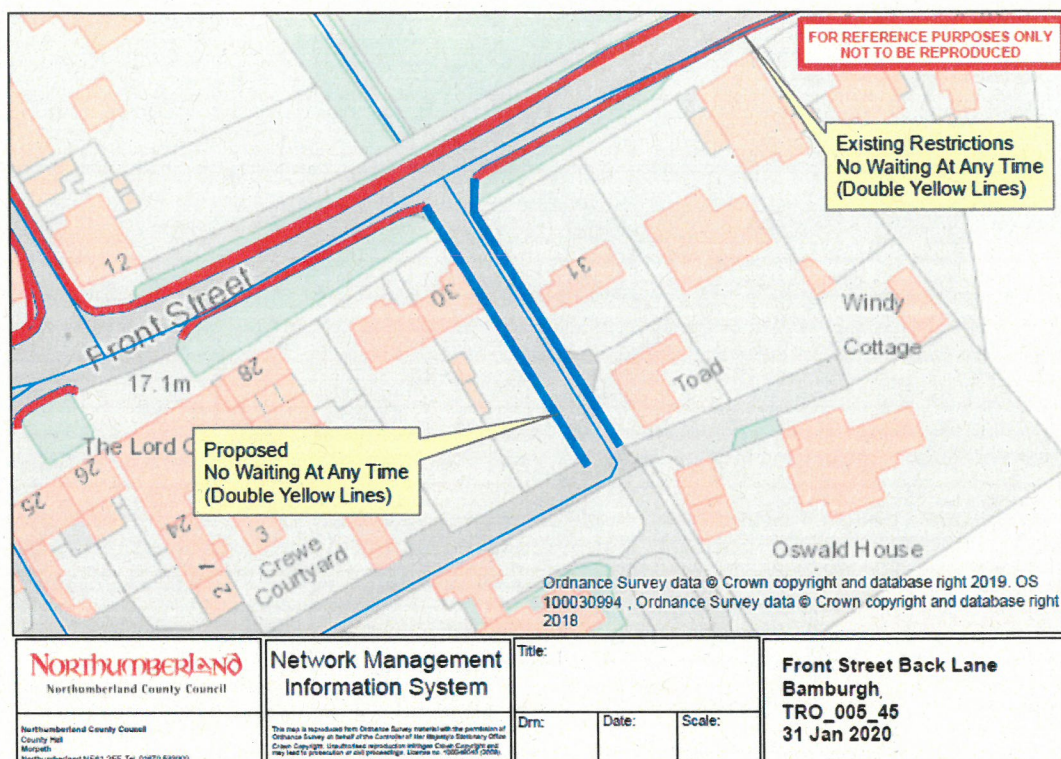

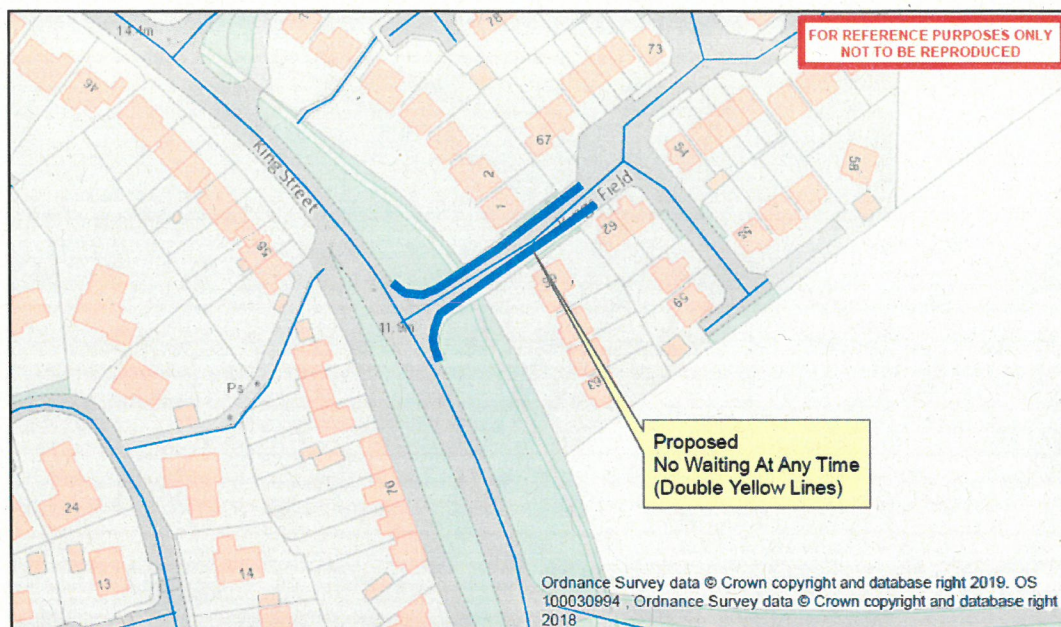
