To introduce new No Waiting Restriction At Any Time (Double Yellow Lines) Front Street Back Lane Bamburgh, High Street Belford and Kingsfield Seahouses.

It is recommended that the new No Waiting At Any Time Restriction (Double Yellow Lines) on High Street Belford be extended to the junction of Croft Field Belford. This has been requested by residents following the advertising of the original proposal and report via the legal process.

Purpose of the Addendum

The purpose of the Addendum is to extend the No Waiting Restrictions At Any Time (Double Yellow Lines) on High Street Belford, to the junction of Croft Field. See Appendix A.

This is a result of feedback from residents following the legal advertisement of the original proposal as detailed in the Decision Report. This was noted and following discussions with the local County Councillor and Parish Council, it was agreed to extend the restrictions at a later date, thereby not delaying the original decision and wasting essential resources.

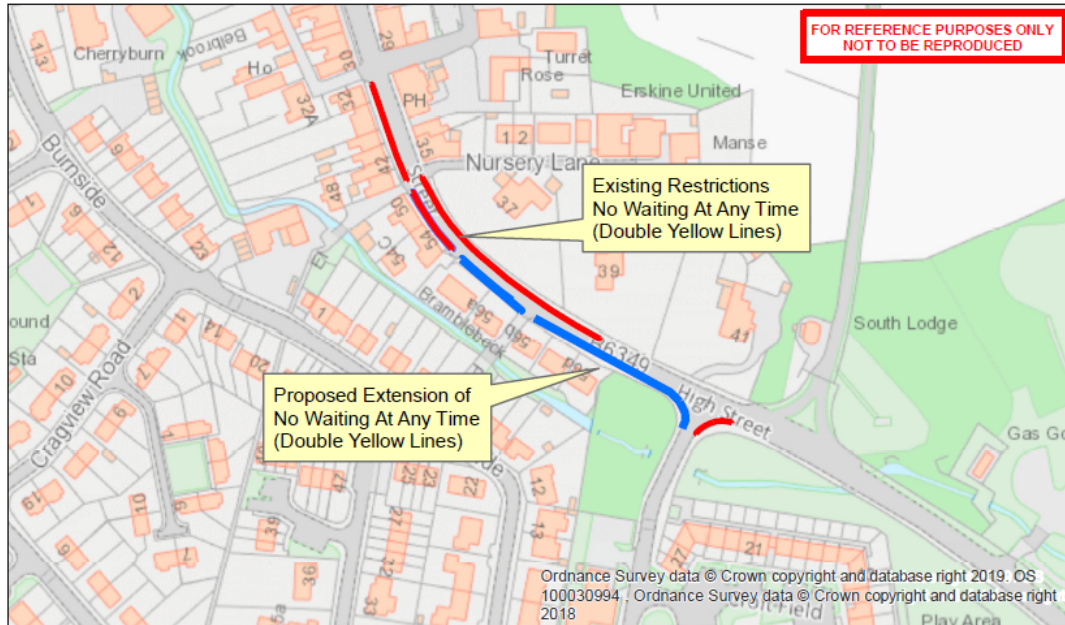
