PROPOSED 30mph SPEED LIMIT EXTENSION, C169 WEST TURNPIKE, GLANTON

To consider a proposal to extend the 30mph speed limit on the C169 West Turnpike road in Glanton.

Key Issues

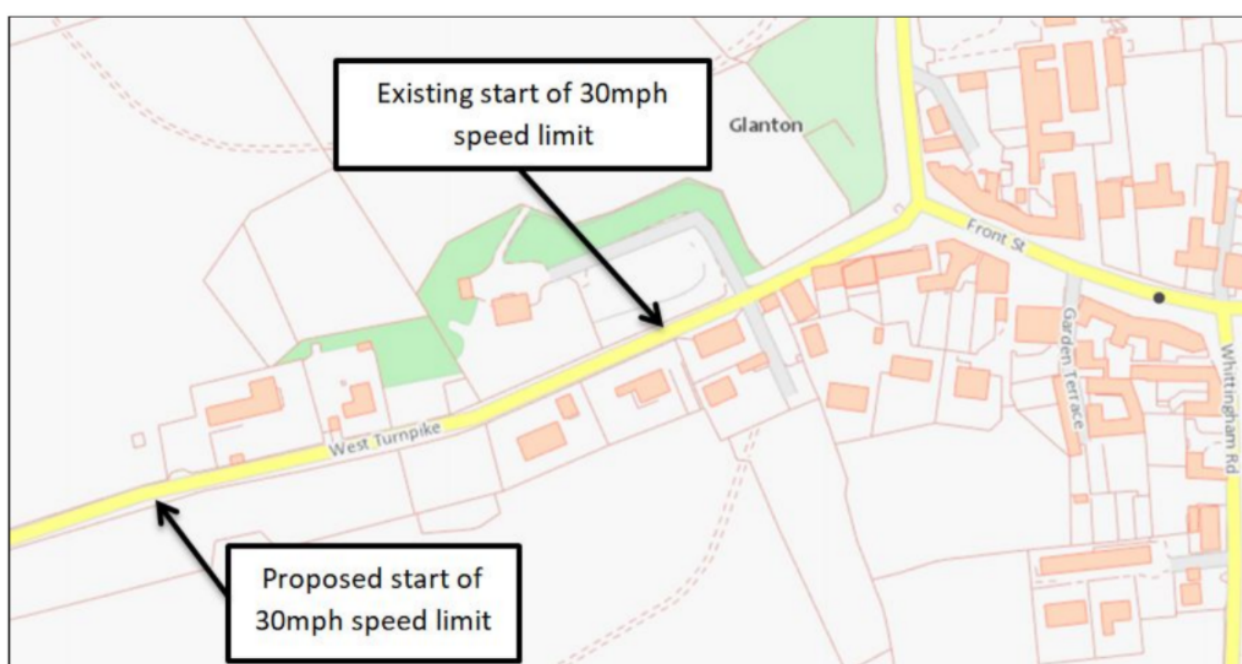
New development in the area is located outside the existing 30mph speed limit.

The extension of the 30mph speed limit in this location was submitted as a priority for the 2020-21 Local Transport Plan Programme by Glanton Parish Council.

Delegated decisions

Background

1. New development adjacent to the C169 West Turnpike road in Glanton is outside the existing 30mph speed limit. This development has occurred in a piecemeal fashion over a few years.
2. This means that the existing 30mph signage is no longer located in a position appropriate to the nature of the road.
3. Glanton Parish Council submitted the extension of the 30mph speed limit as one of their priorities for the 2020-21 Local Transport Plan Programme.
4. Statutory consultees were therefore informed of the Council's intention to extend the 30mph speed limit, as shown in the diagram below.



5. Two responses were received to the consultation, both in favour of the proposed 30mph speed limit extension.
6. It is therefore recommended that the 30mph speed limit should be extended.
