Original Decision Report

To introduce No Waiting Restriction At Any Time (Double Yellow Lines) in Doxford Place Cramlington.

Recommendations

It is now recommended that additional No Waiting Restriction At Any Time (Double Yellow Lines) in Doxford Place Cramlington, be implemented. This follows concerns raised by local residents following the original decision made.

Key Issues

1. There are issues with indiscriminate parking and sight visibility.
2. These additions are in response to concerns raised by local residents and road users
3. The decision to introduce a permanent Traffic Regulation Order is supported by County Councillor Swinburn.

Addendum - Signed 21 August 2020

The purpose of the Addendum is to implement additional No Waiting Restriction At Any Time (Double Yellow Lines) in Doxford Place Cramlington, adjacent to Doxford Place Methodist Church.

This follows the introduction of restrictions in the original report. Following this decision, concerns were raised by residents to County Councillor Swinburn, about indiscriminate parking which is causing road safety concerns at the north end of Doxford Place. See Appendix A.

Purpose of Addendum - November 2020

Following the legal advertisement for the implementation of the Traffic Regulation Order to enforce the additional No Waiting Restriction At Any Time (Double Yellow Lines) in Doxford Place Cramlington, adjacent to Doxford Place Methodist Church (as approved in the 21 August Addendum to the original report) the Council received small number of objections to these additional no waiting restrictions adjacent to the Church.

Once the advertising period had been completed NCC Officers and Cllr Swinburn assessed the comments and observations in detail and reviewed the decision taken in relation to the 21 August Addendum.

In view of the comments received and reconsidering the requirements for restrictions in this area, it is recommend not to introduce the proposed restrictions contained in the 21 August addendum decision report. It is considered the pragmatic approach in the current climate. It has also been decided to monitor the area with the assistance of Parking Services, Enforcement Officers and review with the Councillor in 12 month's time (and before if required).

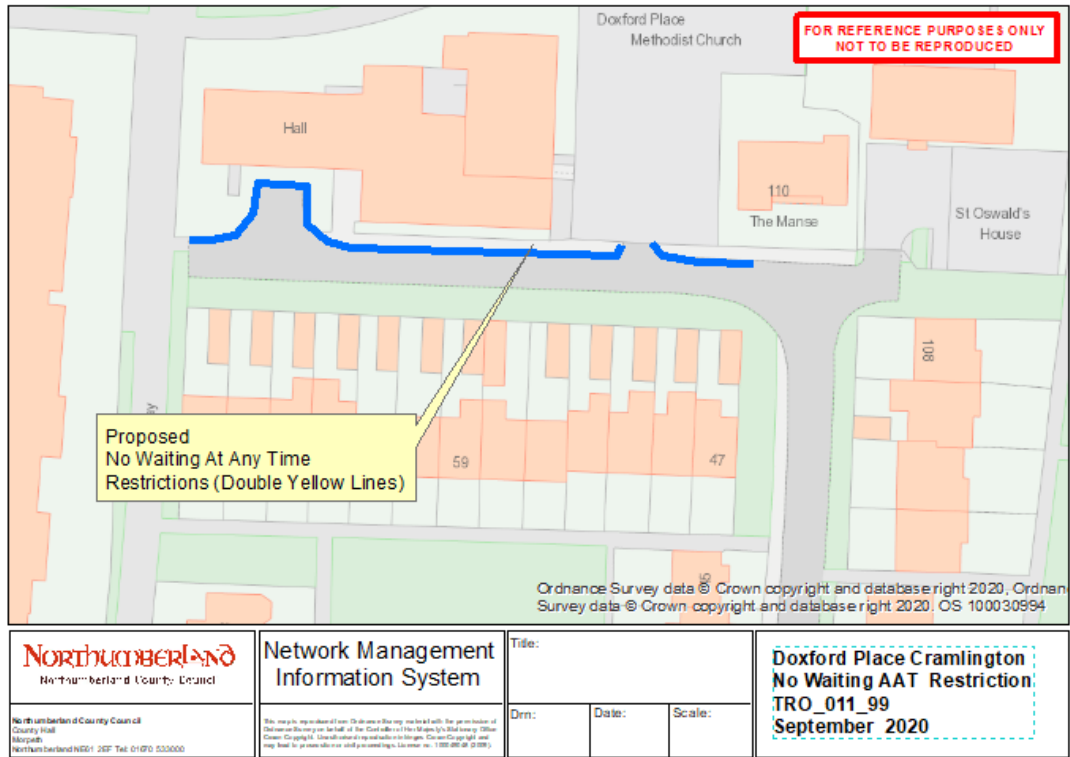
