#### **Purpose of Report**

To consider the introduction of 'No Waiting at Any Time' parking restrictions on Spittal Hall Road Junctions and Billendean Terrace & Farne Road Junction in Spittal due to road safety concerns.

#### Recommendations

It is recommended that a "No Waiting at Any Time" (Double Yellow Line) parking restrictions are introduced on Spittal Hall Road Junctions and Billendean Terrace & Farne Road Junction in Spittal.

#### **Key Issues**

- 1. Residents have raised safety concerns for both pedestrians and motorists caused by parked cars on Spittal Hall Road Junctions & Billendean Terrace & Farne Road Junction.
- 2. The scheme is to be funded by County Councillor Georgina Hill, through her Members' Local Improvement Scheme allowance.

### Background

Residents contacted their local Ward Member with concerns regarding safety issues for both pedestrians and motorists caused by congestion and indiscriminate parking on Spittal Hall Road Junctions & Billendean Terrace & Farne Road Junction in Spittal.

Indiscriminate parking on the road is making it difficult for residents, visitors and general road users to negotiate this road safely.

After discussing the issues with the County Councillor Hill, it was agreed that double yellow lines should be introduced without any formal consultation due to the restrictions being necessary on road safety grounds.

### Consultation

The proposed additional 'No Waiting At any Time' parking restrictions will be introduced without formal consultation due to road safety concerns highlighted in this area. However, canvassing in the area has been carried out by the Local Councillor via individual personal contact and local forums.

Statutory Consultees including the emergency services and various disabled and transport organisations/associations will be informed of the decision as well as the Chief Officer of Police. Plans showing the proposals are attached as Appendix A.

#### Recommendation

To proceed with the introduction of the Waiting and Loading At Any Time Restrictions (Double Yellow Lines) as detail in Appendix A. It is anticipated that these restrictions will improve both visibility and road safety in these key areas for all road users.

Notification of these changes will be advertised as part of the legal process of making this Permanent Traffic Regulation Order.


