#### **Purpose of Report**

This report sets out the background to the proposed Road Safety Improvements at Tweedmouth West First School, Berwick Upon Tweed.

#### Recommendations

It is recommended to implement the proposed Road Safety Improvements at Tweedmouth West First School, Berwick Upon Tweed.

#### Link to Corporate Plan

#### **Key Issues**

- 1. The proposal has been developed following concerns raised by residents in the area, in relation to the introduction of a previous scheme adjacent to Tweedmouth West First School, which included parking restrictions and a '20 MPH' speed limit.
- 2. Concerns were raised that the existing problems would be dispersed to other areas.
- 3. The scheme is supported by County Councillor Georgina Hill.
- 4. The scheme will be funded from LTP allocation.

### Background

Following the introduction of the scheme detailed below, concerns were raised by residents that initial problems would be moved to other locations within the estate.

The initial scheme Introduced in 2018 consisted of the following measures;

- 20mph speed limit in the Osborne Road / Ladywell Road area of Tweedmouth
- No Waiting at any Time Restrictions (Double Yellow Lines) at the Osborne Road/Prince Edward Road, Osborne Road/Ladywell and Osborne Road/Osborne Place junctions aiming to reduce the amount of indiscriminate parking, improve visibility and improve road safety in the area.
- Removal of the 'except for buses' element of the one way system meaning all vehicles will be required to adhere to this restriction.

### Consultation

Following these concerns, discussions took place between NCC Officers and County Councillor Georgina Hill. The following scheme was proposed and consulted on in September 2019 (details are attached as Appendix A)

- Two new sets of 'School Keep Clear' road markings either side of the existing 'School Keep Clear' markings.
- Double yellow lines (No Waiting at Any Time restrictions) from 7 Osborne Road up to and including the Electric Sub Station. This will include junction protection between 19 and 29 Osborne Road.
- Double yellow lines (No Waiting at Any Time Restrictions) at all junctions off Ladywell Way / Ladywell Place.

Following the consultation, there was an overwhelming response in favour of proceeding. The results were as follows: 24 - in Favour, 2 - Against and 1 - Neither.

Details of the proposals are shown on the plan at Appendix B.

Traffic Regulation Orders will be drafted to reflect the proposals for the parking restrictions. There will also be an amendment to the existing 'One Way' Restriction - Moving Traffic Order, this will now allow all vehicles.

Council Officers have worked closely with County Councillor Georgina Hill on the scheme, so that the new scheme complements the existing restrictions and goes some way to resolve the concerns raised by residents.

Northumbria Police, other emergency services and relevant statutory consultees will be notified of these amendments as part of the process for making the permanent Orders.

#### Proposed Additional Parking Restrictions associated with Tweedmouth West First School

You will recall that in August 2018 residents were consulted on the proposed scheme for Tweedmouth West First School.

Consultation was favorable and the following measures are to be introduced:-

- · 20mph speed limit in the Osborne Road / Ladywell Road area of Tweedmouth
- No Waiting at any Time Restrictions (Double Yellow Lines) at the Osborne Road/Prince Edward Road, Osborne Road/Ladywell and Osborne Road/Osborne Place junctions - this would aim to reduce the amount of indiscriminate parking, improve visibility and improve road safety in the area.
- Removal of the except for buses element of the one way system meaning all vehicles will be required to adhere to this restriction.

During the consultation process concerns were raised that the introduction of the parking restrictions would simply move the problem further along Osborne Road, as such we are proposing the following additional restrictions as indicated on the attached plan:-

- Two new sets of School Keep Clear road markings either side of the existing School Keep Clear markings.
- Double yellow lines (No Waiting at Any Time restrictions) from 7 Osborne Road up to and including the Electric Sub Station. This will include junction protection between 19 and 29 Osborne Road.
- Double yellow lines (No Waiting at Any Time Restrictions) at all junctions off Ladywell Way / Ladywell Place.

The County Council and County Councillor Georgina Hill are seeking your views on these proposals. The closing date for any other comments you may wish to make is Friday 27th September 2019. 			restrictions will duplace parking into Ladywell Road / Osborne Place which has been left unrestricted. I
			feel single yellow lines into these roads with school time restrictions would be better. Make Osborne
			Road a 'one way' street from the Osborne Place junction and prevent traffic travelling back towards
			Ladywell and Prince Edward Road junction past the school. There is currently nothing stopping
