

# RECORD OF DECISION TAKEN BY SERVICE DIRECTOR - LOCAL SERVICES

Windy Edge, Alnwick - 30 & 40 MPH Speed Limits

#### **Purpose of Report**

This report sets out the requirement to amend the current speed limits on the A1068 Alnmouth Road and B1340 Denwick Lane to accommodate the new Windy Edge housing development in Alnwick.

#### Recommendations

It is recommended that the proposals to improve traffic calming features at the existing 30 MPH routes and proposals to introduce new 40 MPH speed limits are implemented on the A1068 Alnmouth Road and B1340 Denwick Lane.

#### **Key Issues**

- The construction of a new residential development means that the existing speed limits no longer reflect the needs of the surrounding area and could present a road safety problem.
- New accesses to and from the housing development necessitates amendments to be made to the carriageways that flow past the site in the form of traffic calming features to enable the free flow of traffic and encourage slower speeds.

- Representatives from the County Council have been working closely with Councillor Castle, Alnwick Town Council and the developer to establish and process the proposals, primarily as part of the planning process.
- 4. The cost of the TRO will be met by the developer as part of the overall capital investment being used to construct the development as part of the current planning conditions imposed.

#### **Delegated Decision**

#### Background

Following planning approval for the new Windy Edge housing development to be constructed in Alnwick, a new scheme is proposed along the adjacent routes; namely the A1068 Alnmouth Road and B1340 Denwick Lane.

Upgrades to the carriageways as part of the development include site accesses, shared use footway/cycleways, dropped kerb pedestrian crossings and bus stop shelters. Gateway features and amendments to the speed limit locations are also proposed.

#### **Proposals**

#### A1068 Alnmouth Road

The A1068 consists of a single carriageway which operates an existing 30 MPH speed limit delineated by street lighting where residential properties are situated. Elsewhere the route is derestricted and no physical traffic calming features exist, with existing traffic signing and road markings limited to centre lines, intermittent 'SLOW' markings, hazard warning signs relating to sharp bends and junctions as well as an 'Alnwick' nameplate sign to signify entrance to the town.

At the existing 30 MPH gateway, improved features are proposed in the form of new centre lines, coloured surfacing with hatching and rumble strips to encourage slower speeds alongside the new junction that is to be constructed for access to the new development. A 40 MPH restriction is also proposed in order to act as a graduated speed reduction measure on Alnmouth Road, whereby the derestricted speed limit transitions into 40 MPH and then 30 MPH into Alnwick. New traffic signs, a new electronic traffic sign and a new 'Welcome to Alnwick; Please Drive Carefully' nameplate will also be installed, all of which will support an improved transition for motorists to reduce their speeds as they approach Alnwick. The extents of the 40 MPH proposal are shown below.




Figure 1: Proposed 40 MPH Speed Limit Extents on Alnmouth Road

#### B1340 Denwick Lane

In a similar layout to Alnmouth Road, the B1340 is a single carriageway with a 30 MPH gateway into Alnwick and a derestricted speed limit on the outskirts of the town. The traffic calming features are more prominent as the route enables access to Alnwick Gardens and the associated car park. A pedestrian refuge island exists in the centre of the carriageway near these entrances. Right-turn pockets provide access to Alnwick Castle and the car park. 'No Waiting at Any Time' restrictions prevent indiscriminate parking and promote the off-street parking available.

The extents of the proposed 40 MPH restriction, which will replace the derestricted speed limit that links with the existing 30 MPH area, are shown below and this will also act as a graduated speed reduction feature on Denwick Lane.




Figure 2: Proposed 40 MPH Speed Limit Extents on Denwick Lane

New road markings in the form of speed limit roundels at the gateways are to be introduced with red surface treatment and illuminated speed limit signs are to be installed to further support the notification. New centre lines with 'keep left' arrows and intermittent 'SLOW' road markings will also be installed.

The speed limit reduction measures will promote slower traffic speeds in Alnwick where increased footfall, traffic flows and vehicle turning movements are expected.

Details of the proposals are shown on the plans at Appendix A.

Northumbria Police, other emergency services and relevant statutory consultees will be notified of these amendments as part of the process for making the permanent Orders.


