1. POST AND FOUNDATION DESIGN TO BS EN 12899-1:2007, AND BASED UPON WL6 (1.2KN/M2).
2. POST AND FOUNDATION DESIGNS PROVIDED ARE BASED UPON SOFTWARE OUTPUT. ALL POST AND FOUNDATION DESIGNS SHOULD BE CHECKED BY THE CONTRACTOR FOR COMPLIANCE WITH CURRENT STANDARDS.
3. ENSURE A MINIMUM OF 0.5m CLEARANCE FROM EDGE OF CARRIAGEWAY.

**ROAD MARKINGS**

1. ROAD MARKINGS SHALL COMPLY WITH THE TRAFFIC SIGNS REGULATIONS AND GENERAL DIRECTIONS, 2016.
2. PERMANENT ROAD MARKINGS SHALL BE RETROREFLECTIVE THERMOPLASTIC ROAD MARKING MATERIAL, IN ACCORDANCE WITH BS EN 1871.
3. ROAD MARKINGS AND THEIR APPLICATION SHALL COMPLY WITH VOLUME 1: SERIES 1200 OF THE SPECIFICATION FOR HIGHWAY WORKS.
4. THE CARRIAGEWAY IS TO BE SWEEPED AND CLEANED (JETTED) PRIOR TO THE INSTALLATION OF ROAD MARKINGS.
5. ALL ROAD MARKING WORKS SHALL BE AGREED WITH THE SITE SUPERVISOR PRIOR TO BEING CARRIED OUT.
