### PROPOSED 30mph SPEED LIMIT, DUDDO

### **Purpose of Report**

To consider a proposal to provide a 30mph speed limit in Duddo.

#### Recommendations

It is recommended that the proposed 30mph speed limit is implemented.


- 'Tackling Inequalities' Creating places where there is equity in access to an environment that encourages physical activity and active travel.

#### **Key Issues**

 Road traffic speeds in Duddo were raised as a priority for the Local Transport Plan Programme by Duddo Parish Council.

### **Background**

- 1. Concerns over traffic speeds in Duddo were submitted as a priority for the Local Transport Plan by Duddo Parish Council.
- 2. Duddo is a small village located on the B6354 between The A697 near Wooler and the A1 near Berwick. This location means that it is subject to significant through traffic. The roads in the village are currently subject to the national speed limit of 60mph. Although the road layout, which includes a series of bends, generally leads to lower speeds, the average is above 30mph.
- 3. Guidance on speed limits set out in "Setting Local Speed Limits" (DfT 2013, revised 2024), states that a 30mph speed limit should be the norm in villages. It goes on to say that reasonable minimum criteria for the definition of what constitutes a village would be 20 or more houses and a minimum length of 600 metres, though this can be reduced to 400 metres to suit local circumstances.
- 4. A 30mph speed limit is therefore considered appropriate in Duddo because:
- 5. Statutory consultees were therefore consulted on the proposed 30mph speed limit. The extent of the proposal is shown in red on the plan below.



6. One response was received. This was from Duddo Parish Council confirming their support. A summary of their response is shown in the Appendix. The local ward member also supports the proposal.

- 7. To the north of the village, due to the bends in the road, the new speed limit will begin at a point approximately 200 metres from the first houses. This is so that minimum visibility requirements are met, giving approaching motorists sufficient time to see the terminal signs and reduce their speed.
- 8. The Parish Council asked that this arrangement be replicated at the other two entrances to the village. However, where the minimum visibility requirement is met, it is not appropriate to extend 30mph speed limits out into open countryside and they should coincide with the start of development. Compliance with the speed limit is more likely where motorists see the terminal signs and development at the same time, reinforcing the visual message for reduced speed.
- 9. It is therefore recommended that the 30mph speed limit should be implemented as proposed.

# **Consultation Response**

Duddo Parish Council very much welcomes Northumberland County Council's proposal to provide a 30mph speed limit in the village of Duddo. However, they would request that the 30mph speed limit be extended to all points where current village signs are located on the highways, and not just to the North Eastern approach. A number of residents who walk, some with children and dogs, have expressed concerns about fast moving traffic arriving into the village from the West and so slowing the traffic coming into this side of the village from further away would enhance safety.
