

RECORD OF DECISION TAKEN BY EXECUTIVE DIRECTOR OF LOCAL SERVICES

Proposal to removal of all advisory Disabled Parking Bays and installation of three 'Blue Badge Holders Only' parking bays – Glovers Green, Alnwick

Purpose of report:

To consider the removal of all Advisory Disabled Parking Bays and the installation of 3 restricted parking bays reserved for disabled blue badge holders, Glovers Green, Alnwick

Recommendations:

It is recommended that in view of the consultation and information received on individuals circumstances, that the proposals for the removal of all Advisory Disabled Parking Bays and the installation of 3 'Blue Badge Holders Only' parking bays, Glovers Green, Alnwick should proceed.

Key issues

- 1) Scheme being funded by Councillor Heather Cairns.
- 2) The scheme will reduce indiscriminate parking in the area.
- 3) The scheme will support vulnerable members of the community.

BACKGROUND

- Concerns have been raised by residents of Glovers Green in Alnwick about inconsiderate parking in the existing advisory disabled bays. Councillor Heather Cairns has also expressed concerns and requested officers consult residents on the possible removal of all advisory disabled bays and the introduction of 3 restricted parking bays reserved for disabled blue badge holders only.
- 2) These proposals were the subject of a consultation exercise that involved the delivery of a consultation letter to 31 residents and 30 statutory consultees, including the emergency services, various disabled and transport associations/organisations. A plan showing the proposals is attached together with a copy of the consultation letter (see Appendix 1).

CONSULTATION

- 3) The consultation exercise ended on Wednesday 6th May 2015, and responses were received from 11 households, with 7 were in favour and 4 against the proposals. A summary of these responses is attached as Appendix 2.
- 4) Of the statutory consultees consulted only The North East Ambulance Service responded in favour of the consultation.
- 5) Due to comments/observations received regarding the proposed location of the disabled parking bays, a second consultation was_held with a revised location as proposed by the consultees. A plan showing the proposals is attached together with a copy of the consultation letter (see Appendix 3).
- 6) The second consultation exercise ended on Monday 8th June 2015, and responses were received from 6 households, with 4 were in favour and 2 against the proposals. A summary of these responses is attached as Appendix 4.
- 7) For further clarification, a site plan is attached (see appendix 5) to show the extent of the restricted disabled bays alongside the non-restricted parking bays on Glovers Green.

SUPPORT

- 8) Both consultations received majority support for the overall scheme. The second consultation demonstrated a preference for the revised location of the bays.
 - The consultation was supported by anecdotal evidence supplied by Councillor Heather Cairns after she spoke to the residents. She indicated that residents were in favour of making the new disabled bays enforceable, which would assist in reducing indiscriminate parking in the Glovers Green area. It was also suggested that residents were supportive of the revised location, which allows direct access to the rear of their

vehicles. It is also anticipated that this will assist in resolving anti-social behaviour in the area.

RECOMMENDATIONS

- 9) From the outset, the County Council has endeavoured to respond positively to local concerns raised in this area and it is inevitable that some sections of the community will be dissatisfied with whichever decision is reached. The results of the consultation exercise show that the majority of residents who responded support the proposals. It is therefore recommended that all advisory Disabled Parking Bays be removed and 3 restricted parking bays reserved for disabled blue badge holders only be installed, as proposed.
- 10)The Council has the power to hold a public inquiry before making any traffic regulation order. Such an inquiry might enable disputed evidence to be tested under cross-examination and the need for an order to be critically examined by an independent inspector. In this particular case, officers believe that the extensive consultation process and involvement with interested parties, means that such an inquiry is unlikely to bring any fresh information to light and it is therefore recommended that an inquiry is not held.



(I refer to the final paragraph of my notes enclosed to A. Douglas Esq in my Reply letter of 25 Oct 2014). Given the current difficulties in getting parked, perhaps it would be a less contentious issue if you considered the proposed "Blue Badge" Bays to be sited in the original location across the head of the cul de sac, facing a brick wall instead of front gates of other tenants homes. I would appreciate if the above could be given some careful consideration, at least you are aware of my opinion, as previous ward councillor for 13 years. |

With reference to the above and your letter dated Wed 8th April, REF: H014/AD also following a telephone call to you directly, I would like to highlight my concerns over the proposed bays. Whilst we are not against them for those that require the use of disabled bays we are very much against them being directly in front of our privately owned property. We would appreciate a meeting on site with a representative to gather a clearer picture and perhaps suggest a better location for all those involved. We feel that when we come to put our property on the housing market this will have a huge detrimental effect to the selling power and asking price. We have been advised to seek legal advice if the bays go ahead in the proposed areas to claim damages in this respect. May we also point out that one of the bays, the one proposed outside our home is very close to a number of steps and in health and safety terms this surely cannot be deemed safe for a wheelchair user. There are two other sides to the carpark, one of which remains on the level and that back on to the rear of other properties with no direct access that would solve the solution for everyone. We have direct access to our property from the carpark and pavement which prove crucial when responding to emergency service fire calls. |


