PROHIBITION OF DRIVING/PEDESTRIANISATION ORDER 2024  
(TROM\_317)**

Northumberland County Council, in exercise of their powers under Sections 1, 2, 3 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

1. (1) This Order shall come into operation on the 23<sup>rd</sup> August 2024 and may be cited as Northumberland County Council Church Street Rothbury Prohibition of Driving/Pedestrianisation Order 2024.
- (2) Except where otherwise stated, any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. No person shall cause any vehicle to enter the length of highway detailed in The Schedule of this Order.
3. This Order will hereby revoke Article 5 of "The County of Northumberland (Rothbury Town Centre) (No Waiting at Any Time, Disabled Only Parking Bays and One Way Traffic) Order 2006".

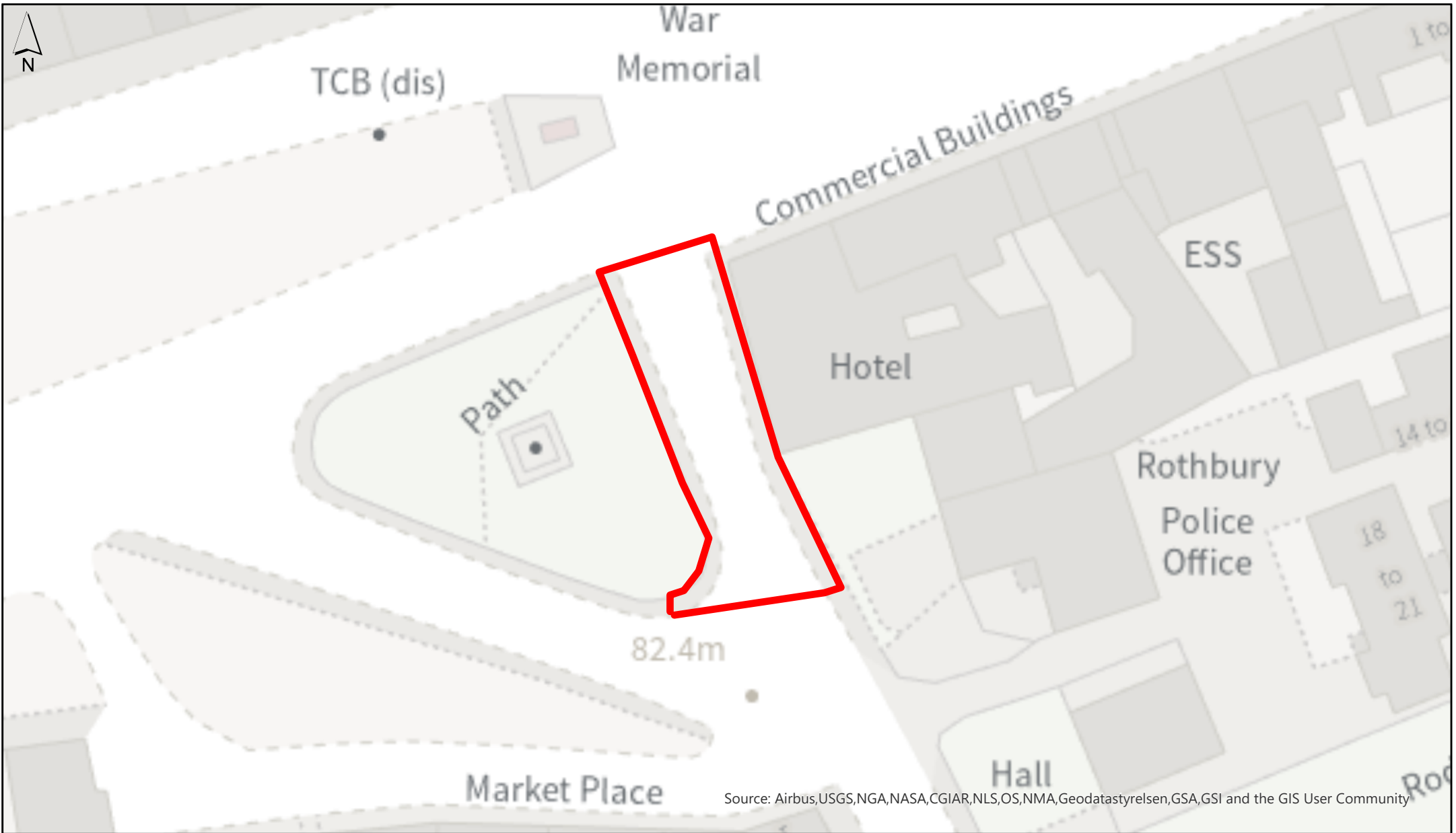
