### NORTHUMBERLAND COUNTY COUNCIL **ROAD TRAFFIC REGULATION ACT 1984** CHURCH STREET ROTHBURY PROHIBITION OF DRIVING/PEDESTRIANISATION ORDER 2024 (TROM 317)

Northumberland County Council, in exercise of their powers under Sections 1, 2, 3 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

- 1. This Order shall come into operation on the 23<sup>rd</sup> August 2024 and may be (1) cited as Northumberland County Council Church Street Rothbury Prohibition of Driving/Pedestrianisation Order 2024.
  - Except where otherwise stated, any reference in this Order to a numbered (2) article is a reference to the article bearing that number in this Order.
  - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. No person shall cause any vehicle to enter the length of highway detailed in The Schedule of this Order.
- This Order will hereby revoke Article 5 of "The County of Northumberland (Rothbury 3. Town Centre) (No Waiting at Any Time, Disabled Only Parking Bays and One Way Traffic) Order 2006".
