The effect of the Order, which will come into force on the 18th January 2016, will be to introduce No Waiting At Any Time restrictions on The Peth and Walkergate in Alnwick

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 18th January 2016 and may be cited as "NCC North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011 - Amendment No 15 Order 2016".

2. In the Order:-

"Order" means "NCC North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011".

"Amendment Order" means "NCC North Northumberland (Central) Area (Waiting & Loading) Composite Order 2011 - Amendment No 15 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

(Referenced in this Amendment Order as: The Schedule - DELETIONS)


