Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 4th November 2013 and may be cited as "NCC North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011- Amendment No 5 Order 2013".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "NCC North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011- Amendment No 5 Order 2013".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

(Referenced in this Amendment Order as: DELETIONS)



STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER

The proposal is being considered for the the replacement of the 'No Waiting at any Time May – September' restriction to 'No Waiting at Any Time'

The key issues are:

- The Department for Transport are urging Local Authorities to reduce sign clutter where possible. Amending the time restriction will remove 21 signs from the network
- 2) The seasonal aspect of the restriction does not serve any significant purpose
