#### 1. Commencement and Citation

This Order shall come into operation on the 13<sup>th</sup> February 2017 and may be cited as "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011 - Amendment No 18 Order 2017".

#### 2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011- Amendment No 18 Order 2017".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.


