Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45, 46, 49 and 51 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:

#### 1. Commencement and Citation

This Order shall come into operation on the 11<sup>th</sup> May 2015 and may be cited as "Northumberland County Council North Northumberland (Northern) Area (Parking Places) Composite Order 2011 – Amendment No 4 Order 2015".

#### 2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Northern) Area (Parking Places) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Northern) Area (Parking Places) Composite Order 2011 – Amendment No 4 Order 2015".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

#### 3. Provisions

The following provisions shall be additions to, deletions from, or substitutions in the restrictions detailed in the Order:

### Addition to PART I - PRELIMINARY Article 2. Interpretation

#### 2. Interpretation

In this order, unless the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"coach" means a public service vehicle but excluding such a vehicle when it is being used to operate a local service as defined by The Transport Act 1985;

"coach parking place" means an area of the highway described in Schedule 12 to this Order (See Article and Schedule 12)

### Substitution to PART I – PRELIMINARY Article 2. Interpretation

#### 2. Interpretation

In this order, unless the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"maximum permitted stay" means the maximum time that a vehicle may be left in a parking place as defined in column 9 of Schedule 2, 3, 11 or 12;

"parking bay" means a marked area in a parking place referred to in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 for the leaving of a vehicle;

"parking place" means any area on a highway referred to in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12;

"parking space" means a space individually marked for the leaving of a vehicle within a parking place referred in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 hereto;

"permitted hours" in relation to a parking place, means the times of operation specified in Schedule 6 as represented by the corresponding time code in column 6 of Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 of this order relating to that parking place;

#### Substitution to PART II -PARKING PLACES

#### 4. Designation of parking places

Any length of road specified in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 of this Order as a parking place is hereby designated as a parking place.

#### 5. Use of a Parking Place

No person shall use a Parking Place other than as specified in this Order

### 6. Vehicles for which parking places are designated

Each parking place specified in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 of this Order may be used, subject to the provisions of this Order, for the leaving during the permitted hours of such vehicles as are Passenger Vehicles, Goods Vehicles, Motorcycles, Invalid Carriages or Coaches provided that the use of that Parking Place or part of the Parking Place in which the Vehicle is left has not been suspended.

Each parking place specified in in Column 8 of Schedule 8 of this Order may only be used for the leaving of police vehicles provided that the use of that Parking Place or part of the Parking Place in which the Vehicle is left has not been suspended.

Each parking place specified in Column 8 of Schedule 9 of this Order may only be used, subject to the provisions of this Order, for the leaving during the permitted hours of car club vehicles provided that the use of that Parking Place or part of the Parking Place in which the Vehicle is left has not been suspended.

Each parking place specified in Column 8 of Schedule 10 of this Order may only be used, subject to the provisions of this Order, for the leaving during the permitted hours of electric vehicles provided that the use of that Parking Place or part of the Parking Place in which the Vehicle is left has not been suspended.

Each parking place specified in Column 8 of Schedule 12 of this Order may only be used, subject to the provisions of this Order, for the leaving during the permitted hours of coaches provided that the use of that Parking Place or part of the Parking Place in which the Vehicle is left has not been suspended. All vehicles must have engine switched off when stationary.

### Substitution to PART III - SUPPLEMENTARY PROVISIONS

#### Section 1 – Use of a Parking Place

### Manner of standing and waiting in a parking place

Every Vehicle left in a Parking Place in accordance with the provisions of this Order shall so stand:

- (i) in the case of a Parking Place in relation to which special provisions as to the manner of standing of a Vehicle in that parking place are specified in column 7 of Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 as to be in accordance with those provisions;
- (ii) for a Parking Place specified in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 so that every part of the Vehicle is within the limits of a parking bay or parking space;

#### Substitution to PART V - OPERATION

#### 25. Contravention of restrictions and parking places

Save as provided in Articles 24, 25 and 26 of this Order, if a vehicle is left in a length of road defined in Schedules 1, 2, 3, 4, 8, 9, 10, 11 or 12 during the Permitted Hours without complying with the provisions of this Order a contravention shall be deemed to have occurred and a penalty charge notice may then be issued by a police constable in uniform or Civil Parking Enforcement Officer. Once issued a penalty charge shall be payable.
