(PARKING PLACES – REF TRO -008-14) :- NOTICE IS HEREBY GIVEN that the Northumberland County Council have made the above-named Order under Sections 1, 2, 4, 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, which will come into force on 29th February 2016, will be to introduce three Disabled Blue Badge Holder Parking Places on Market Place and one Time Limited Disabled Blue Badge Holder Parking Place on Hill Street in Corbridge

The following restrictions are revoked from the Principal Order, West Northumberland Area (Parking Places) Composite Order 2011 (TRO_008):-

Deletion – Limited Waiting Parking Place (residents permit holders and limited Waiting) – Proscribed – Monday - Saturday 9am – 6pm - 3 hours, No Return within 4 hours

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:

1. Commencement and Citation

This Order shall come into operation on the 29th February 2016 and may be cited as "Northumberland County Council West Northumberland Area (Parking Places) Composite Order 2011 - Amendment No 14 Order 2016".

2. In the Order:-

"Order" means "Northumberland County Council West Northumberland Area (Parking Place) Composite Order 2011".

"Amendment Order" means "Northumberland County Council West Northumberland Area (Parking Place) Composite Order 2011 - Amendment No 14 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

(A) Additions

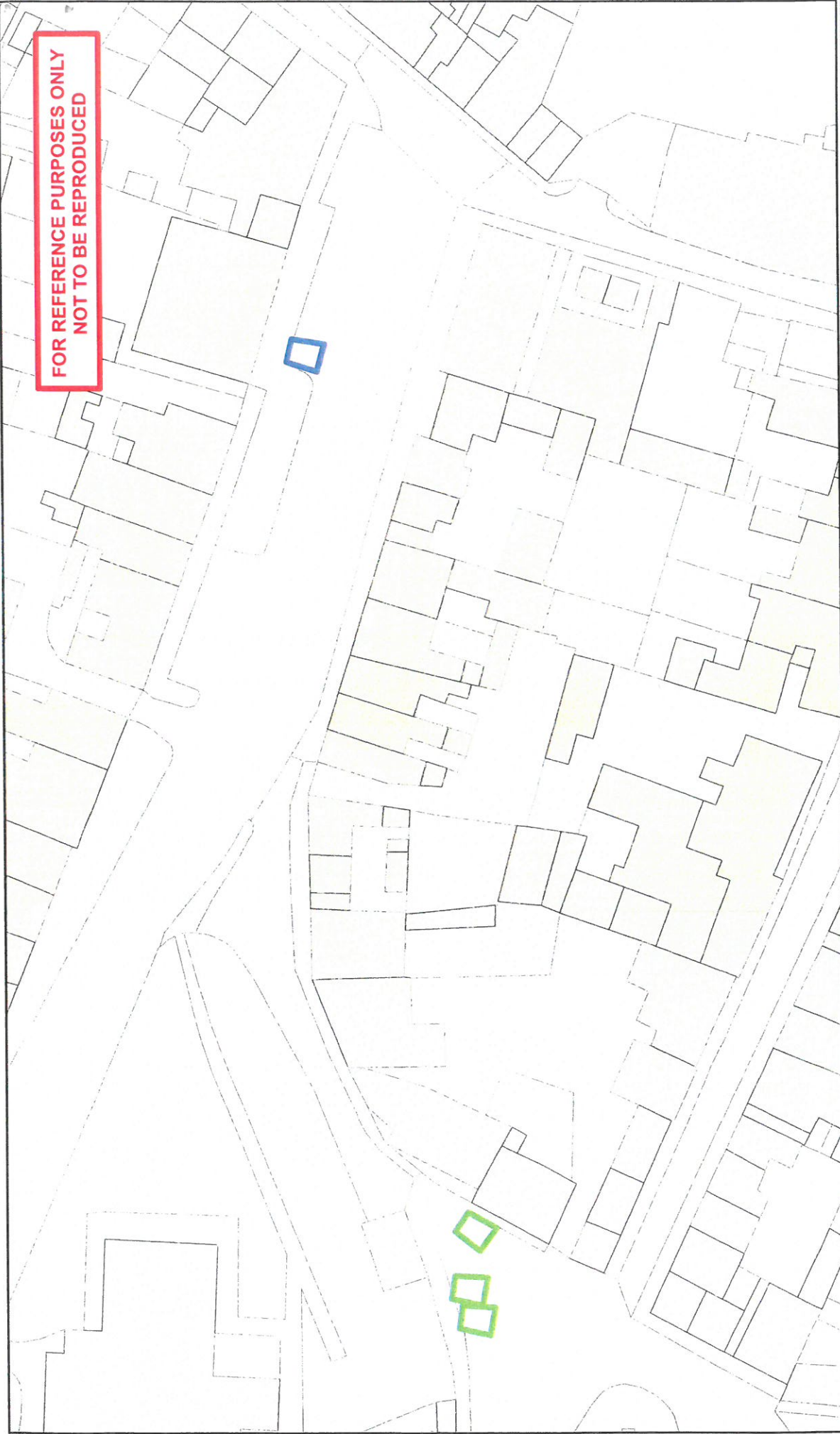
