Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 7th July 2015 and may be cited as "North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 Amendment No 14 Order 2015".

2. In the Order:-

"Order" means "North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "NCC North Northumberland (Southern) Area (Waiting and Loading) Composite Order 2011 Amendment No 14 Order 2015".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

to Schedule 1 – Waiting of the Order



**STATEMENT OF THE COUNCIL'S REASONS FOR
MAKING THE ORDER**

It is considered necessary for the provision of additional "No Waiting at any Time" restrictions in the High Stanners Area of Morpeth. Thereby, allowing enforcement against indiscriminate parking and to aid traffic flow in this area.
