Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 35, 32, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby delete the following Order:

**1. Commencement and Citation**

This Order shall come into operation on the 27<sup>th</sup> January 2014 and may be cited as "Morpeth Town Centre (No Waiting At Any Time, Limited Waiting, Loading Only Parking, Disabled Only Parking and Residents Only Parking Places) Order 2003 – Amendment Number 5 Order 2014.

**2. In the Order:-**

"Amendment Order" means "Morpeth Town Centre (No Waiting At Any Time, Limited Waiting, Loading Only Parking, Disabled Only Parking and Residents Only Parking Places) Order 2003 – Amendment Order No 5 Order 2014".

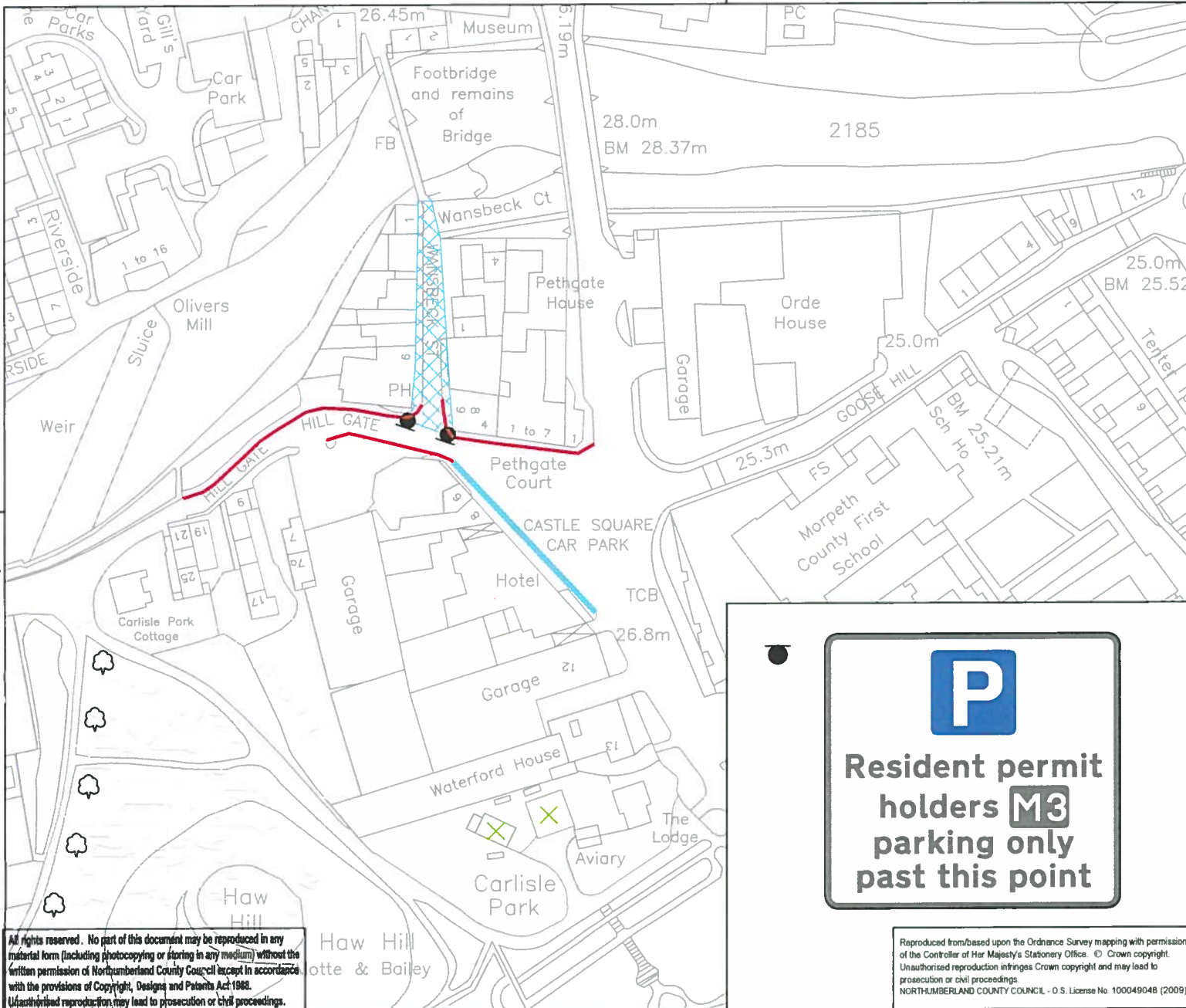
