Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 19th September 2016 and may be cited as "NCC North Northumberland (Southern) Area (Parking Places) Composite Order 2011- Amendment No 12 Order 2016".

2. In the Order:-

"Order" means "NCC North Northumberland (Southern) Area (Parking Places) Composite Order 2011".

"Amendment Order" means "NCC North Northumberland (Southern) Area (Parking Places) Composite Order 2011- Amendment No 12 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

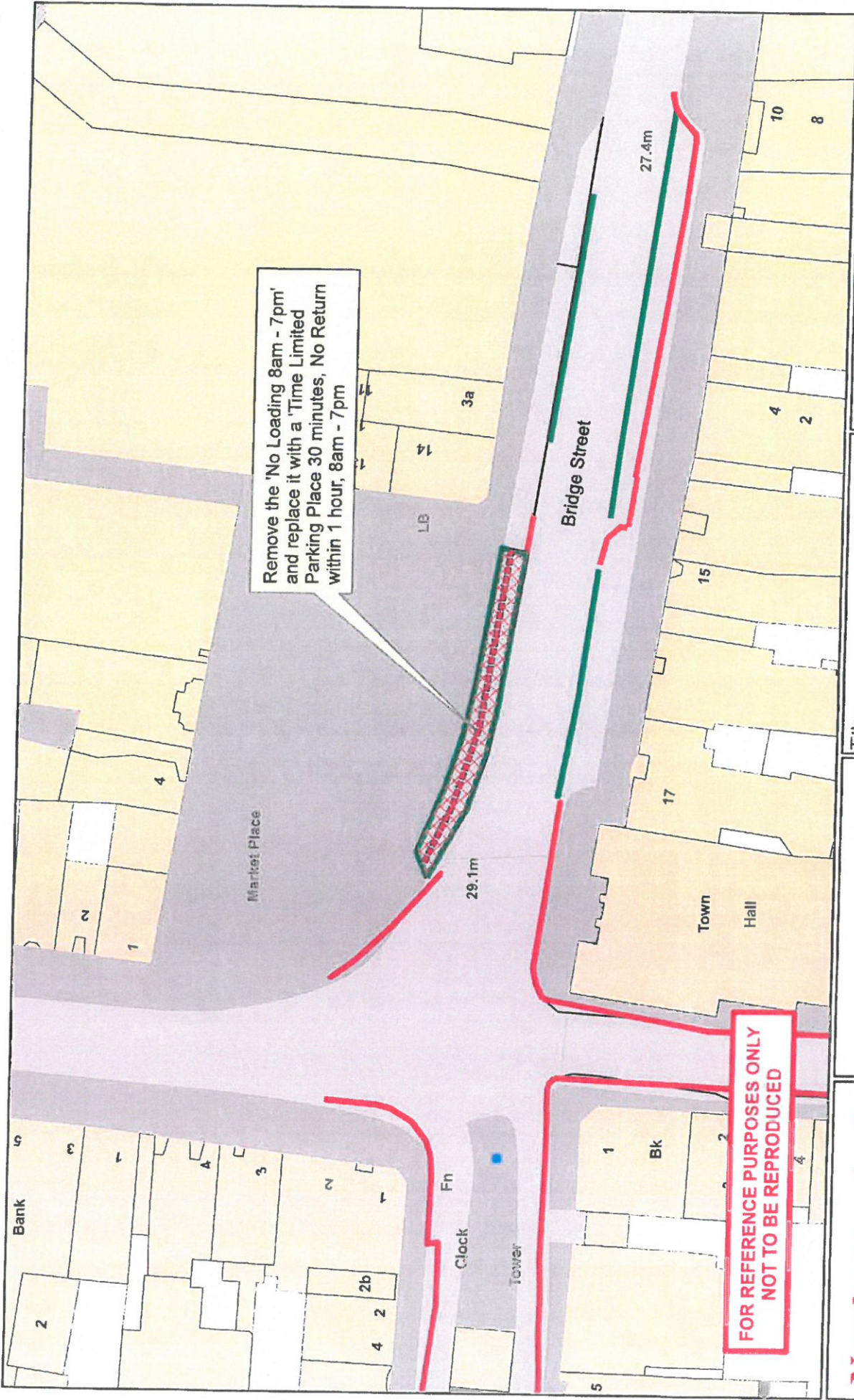
