

**THE NORTHUMBERLAND COUNTY COUNCIL**  
**(CIVIL PARKING ENFORCEMENT AMENDMENTS) ORDER 2012**

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 35, 32, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:

**1. Commencement and Citation**

This Order shall come into operation on the 31<sup>st</sup> July 2012 and may be cited as the "Northumberland County Council (Civil Parking Enforcement Amendments) Order 2012.

**2. Amendments to Existing Orders**

The Orders specified in the First Schedule are amended in the following way:

(a) The following expression(s) and the meaning(s) assigned to it (them) is (are) deleted (when included) in that Article in the Orders which deals with the meaning of expressions used in the Orders

(i) "parking attendant"

(ii) "excess charge"

(iii) "excess charge notice"

(b) The following expression and the meaning assigned to it is inserted in appropriate alphabetical order in that Article in the Orders which deals with the meaning of expressions used in the Orders

(i) "civil enforcement officer" shall have the same meaning as in section 76 of the Traffic Management Act 2004 with the reference to "the authority" in subsection 2 thereof being a reference to the Council

(ii) "penalty charge" shall have the same meaning as in section 92 of the Traffic Management Act 2004

(iii) "penalty charge notice" shall mean a notification issued by the Council in accordance with section 78 of the Traffic Management Act 2004

(c) Each reference to "parking attendant" in the Orders other than any reference to parking attendant contained in any Article in the Orders which deals with the

meaning of expressions used in the Orders is replaced by a reference to civil enforcement officer.

(d) Each reference to "fixed penalty" in the Orders other than any reference to parking attendant contained in any Article in the Orders which deals with the meaning of expressions used in the Orders is replaced by a reference to penalty charge.

(e) Each reference to "fixed penalty notice" in the Orders other than any reference to parking attendant contained in any Article in the Orders which deals with the meaning of expressions used in the Orders is replaced by a reference to penalty charge notice.

(f) Each reference to "traffic warden" in the Orders other than any reference to parking attendant contained in any Article in the Orders which deals with the meaning of expressions used in the Orders is replaced by a reference to civil enforcement officer.

### **3. Specific amendments to individual Orders**

The Orders shown in the Second Schedule shall be amended in the manner shown within the Second Schedule in relation to each such Order

### **4. Correction to amendment orders**

The Amendment No 1 Orders listed in the Third Schedule and the consequential amendments to the orders referred to therein shall be further amended so as to correctly cite the Amendment No 1 Orders as having been made in 2012.

**“10 Contravention of restrictions and parking places**

Save as provided within this Order, if a vehicle is left in a Parking Place without complying with the provisions of this Order, a contravention shall be deemed to have occurred and a Penalty Charge shall be payable. A Penalty Charge Notice may then be issued by a police constable in uniform or a Civil Enforcement Officer.”
