If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to the Order you may before the 9th December 2017 apply to the High Court for that purpose.

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under sections 32, 35 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby makes the following Order:

1. Commencement and Citation

This Order shall come into operation on the 30th October 2017 and may be cited as "Northumberland County Council (Off Street Parking Places) Composite Order 2014 – Amendment No 8 Order 2017".

2. In the Order:-

"Order" means "Northumberland County Council (Off Street Parking Places) Composite Order 2014"

"Amendment Order" means "Northumberland County Council (Off Street Parking Places) Composite Order 2014 – Amendment No 8 Order 2017".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be; additions to, deletions from, or substitutions in the restrictions in the Order:

to Part I - Preliminary 2. Interpretation

ADDITION – “**Hexham Abbey Parking Permit**” means a permit issued by the Council under provisions of Article 7 as defined in Schedule 3 Of this Order;

To Part II – Use of Land and Parking Place

ADDITION - 7. Parking Permits (i) (e) Hexham Abbey Parking Permit



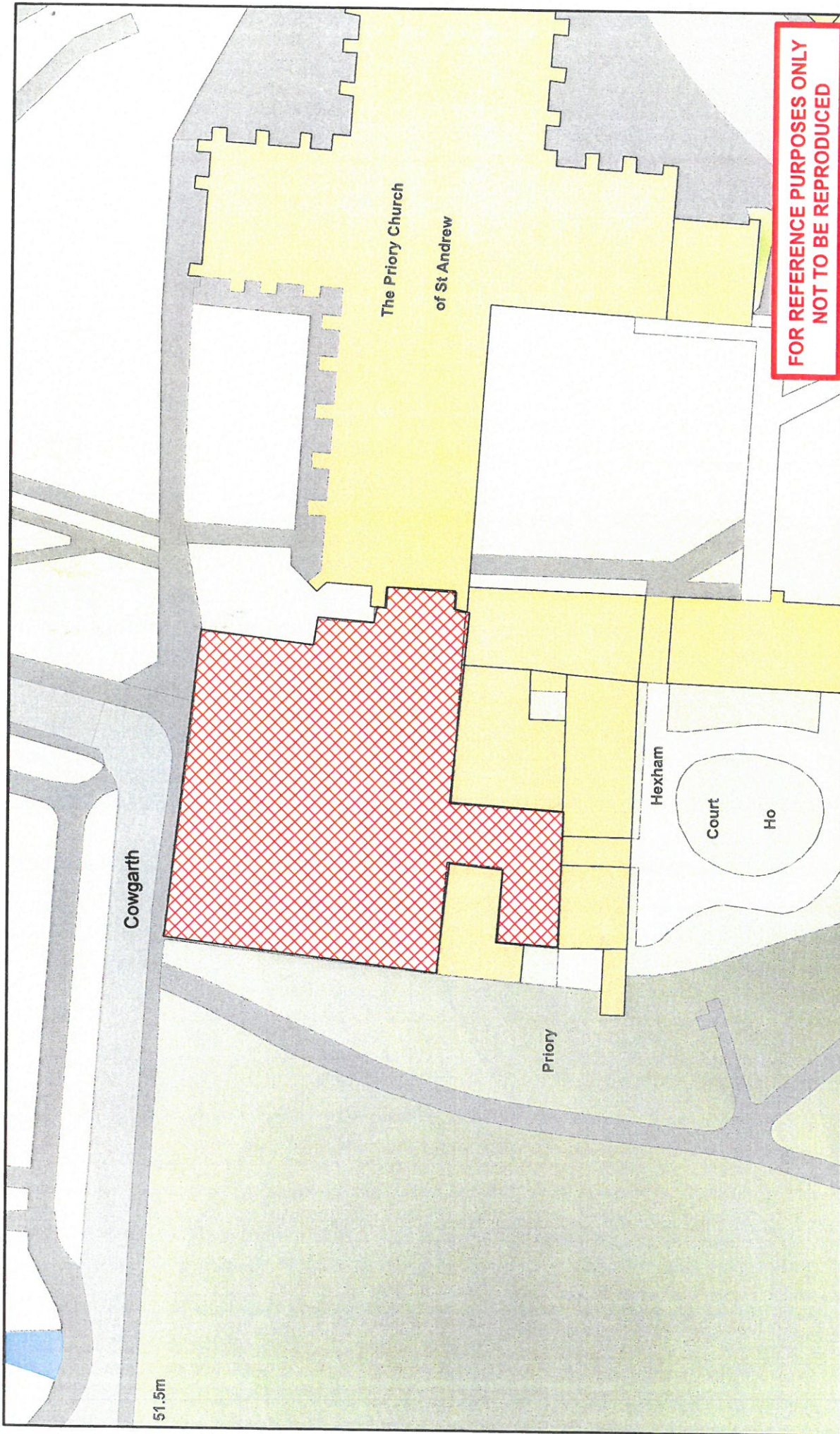
