


THE COUNTY COUNCIL OF NORTHUMBERLAND
ROAD TRAFFIC REGULATION ACT 1984
(B6318 AT ONCE BREWED 40 MPH SPEED RESTRICTIONS) ORDER 2015

The Northumberland County Council, in exercise of their powers under Sections 1(1), 2(1) and (2), 82(2), 83(2) and 84 and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, hereby make the following order:

1. (1) This Order shall come into operation on the 8th day of June 2015 and may be cited as "The County of Northumberland (B6318 at Once Brewed 40 mph Speed Restrictions) Order 2015."
- (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- (3) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
2. Save as provided in Article 3, this Order shall render it unlawful for a person to cause or permit a vehicle to proceed at a speed in excess of 40 mph on those lengths of highway detailed in Schedule 1.
3. Nothing in Articles 2 and 3 shall make it unlawful for a person to drive in excess of the stated speed limit on the length of roads specified in that Article if it is being used for police, fire and rescue or ambulance purposes.

SCHEDULE 1

40 MPH Speed Restriction

- (i) **On the B6318** - a point 88 metres east of its junction with the C307 (Park lane to Twice Brewed) (Grid Reference 375401 566970) to a point 75 metres west of the access to Winshields (Grid Reference 374365 566695). (A distance of 1072 metres)
- (ii) **On the C307 Park Lane to Twice Brewed Road** – a point 156 metres south of it junction with B6318 (Grid Reference 375296 566793).
- (iii) **On the U7038 Close A Burns Junction to Twice Brewed Road** - a point 65 metres North of it junction with B6318 (Grid Reference 375296 566793).
