


ROAD TRAFFIC REGULATION ACT 1984
THE COUNTY OF NORTHUMBERLAND

PREMISES) ORDER 2016

The County Council of Northumberland (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 3 and 4 and Paragraph 20 of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), hereby make the following Order:-

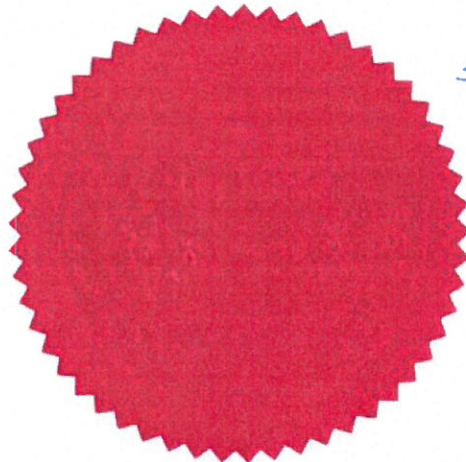
1.
 - (1) This Order shall come into operation on the 7th November 2016 and may be cited as "The County of Northumberland (C362 Duddo Hill Junction to Dovecote Farm Junction Stannington) Prohibition of Driving Except for Access to Off-Street Premises) Order 2016."
 - (2) Except where otherwise stated, any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
 - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. Save as provided in Article 1, no person shall cause any vehicle to enter, except for access to off-street premises, those lengths of highway described in Schedule 1 of this Order.
3. Nothing in Article 2 shall render it unlawful to cause or permit any vehicle to enter the roads referred to therein for so long as may be necessary to enable:-
 - (1) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations:-
 - (a) buildings, industrial or demolition operations;
 - (b) the removal of any obstruction to traffic;
 - (c) the maintenance, improvement or reconstruction of the said lengths of road or side of road;
 - (d) for fire and rescue, police or ambulance purposes;
 - (e) registered local bus services, scheduled express carriages, school buses, work buses, cycles and agricultural vehicles.

- (f) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Communications Act 2003, and
- (2) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in the pursuance of statutory powers or duties.

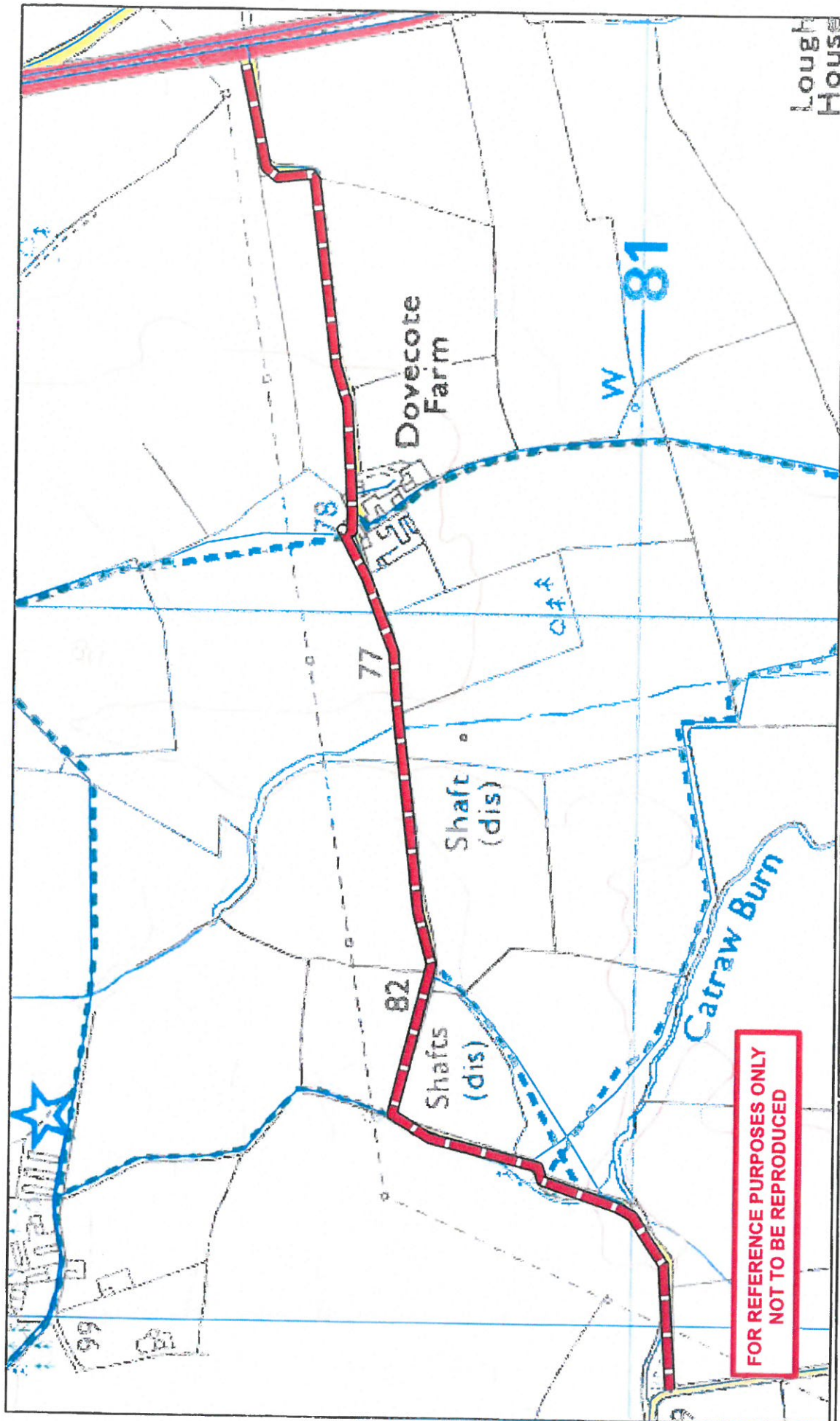
