The Northumberland County Council, in exercise of their powers under Sections 1(1), 2(1) and (2), 82(2), 83(2) and 84(1) and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, hereby make the following order:

## 1. Commencement and Citation

1.1. This Order shall come into operation on 26<sup>th</sup> November 2016 and may be cited as the "The County of Northumberland (A189 North Seaton Roundabout Extension of 30 mph Speed Limit Restriction and introduction of new 50mph Speed Limit) Order 2016 (TROM 57)."

## 2. Interpretation

- 2.1 In this Order, unless the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:
- 2.1.1. "Council" means Northumberland County Council
- 2.1.2 "The Act" means the Road Traffic Regulation Act 1984

#### 3. Restrictions

- 3.1 The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act or by or under any other enactment
- 3.2 Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.

## 4. Extension of 30mph Speed Limit and Introduction of New 50mph Speed Limit

4.1. Save as provided in Article 5, this Order shall render it unlawful for a person to cause or permit a vehicle to proceed at a speed in excess of 30mph on those lengths of highway detailed in Schedule 1 and 50mph on those lengths of highway detailed in Schedule 2.

#### 5. Exemptions

5.1 Nothing in Article 4 shall make it unlawful for a person to drive in excess of the stated speed limit on the length of roads specified in Schedule 1 and Schedule 2 attached to this Order if it is being used for police, fire and rescue or ambulance purposes.

## SCHEDULE 1

## Extension of Existing 30mph Speed Limit

(i) B1334 Newbiggin Road (west of roundabout) – From its existing start / end point approximately125 metres west of its junction with A189 North Seaton Roundabout to a point approximately 25 metres west of its junction with A189 North Seaton Roundabout (a distance of approximately 100 metres)

### SCHEDULE 2

## Introduction of New 50mph Speed Limit

- (i) A189 Spine Road Northbound (South of North Seaton Roundabout) From its junction with North Seaton Roundabout to a point approximately 630 metres south of its junction with North Seaton Roundabout.
- (ii) A189 Spine Road Northbound (North of North Seaton Roundabout) From its junction with North Seaton Roundabout to a point approximately 300 metres north of its junction with North Seaton Roundabout.
- (iii) A189 Spine Road Southbound (South of North Seaton Roundabout) From its junction with North Seaton Roundabout to a point approximately 140 metres south of its junction with North Seaton Roundabout.
- (iv) A189 Spine Road Southbound (North of North Seaton Roundabout) From its junction with North Seaton Roundabout to a point approximately 470 metres north of its junction with North Seaton Roundabout.
- (v) A189 North Seaton Roundabout The carriageway within North Seaton Roundabout, including all entrances and exits.
- (vi) B1334 Newbiggin Road (west of North Seaton Roundabout) From its junction with North Seaton Roundabout to a point approximately 25 metres west of its junction with A189 North Seaton Roundabout.
- (vii) B1334 Newbiggin Road (east of North Seaton Roundabout) From its junction with North Seaton Roundabout to a point approximately 550 metres north east of its junction with North Seaton Roundabout
