

**ROAD TRAFFIC REGULATION ACT 1984  
THE COUNTY OF NORTHUMBERLAND  
(MORPETH TOWN CENTRE – VARIOUS LOCATIONS -  
PROHIBITION OF DRIVING EXCEPT FOR ACCESS TO OFF-STREET  
PREMISES) ORDER 2017  
(TROM\_080)**

The County Council of Northumberland (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4 and Schedule 9 Part III Paragraph 20 and Part IV Paragraph 27 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), hereby make the following Order:-

1. (1) This Order shall come into operation on the 11<sup>th</sup> September 2017 and may be cited as "The County of Northumberland (Morpeth Town Centre – Various Locations - Prohibition of Driving Except for Access to Off-Street Premises) Order 2017."
- (2) Except where otherwise stated, any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. Save as provided in Article 1, no person shall cause any vehicle to enter, except for access to off-street premises, those lengths of highway described in Schedule 1 of this Order.
3. Nothing in Article 2 shall render it unlawful to cause or permit any vehicle to enter the roads referred to therein for so long as may be necessary to enable:-
  - (1) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations:-
    - (a) buildings, industrial or demolition operations;
    - (b) the removal of any obstruction to traffic;
    - (c) the maintenance, improvement or reconstruction of the said lengths of road or side of road;
    - (d) for fire and rescue, police or ambulance purposes;
    - (e) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Communications Act 2003, and

- (2) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in the pursuance of statutory powers or duties.
4. This Order will revoke Schedule 4 contained in the "The County of Northumberland (Morpeth Town Centre) (No Waiting at Any Time, Limited Waiting, Loading Only Parking, Disabled Only Parking and Residents Only Parking Places) Order 2003"

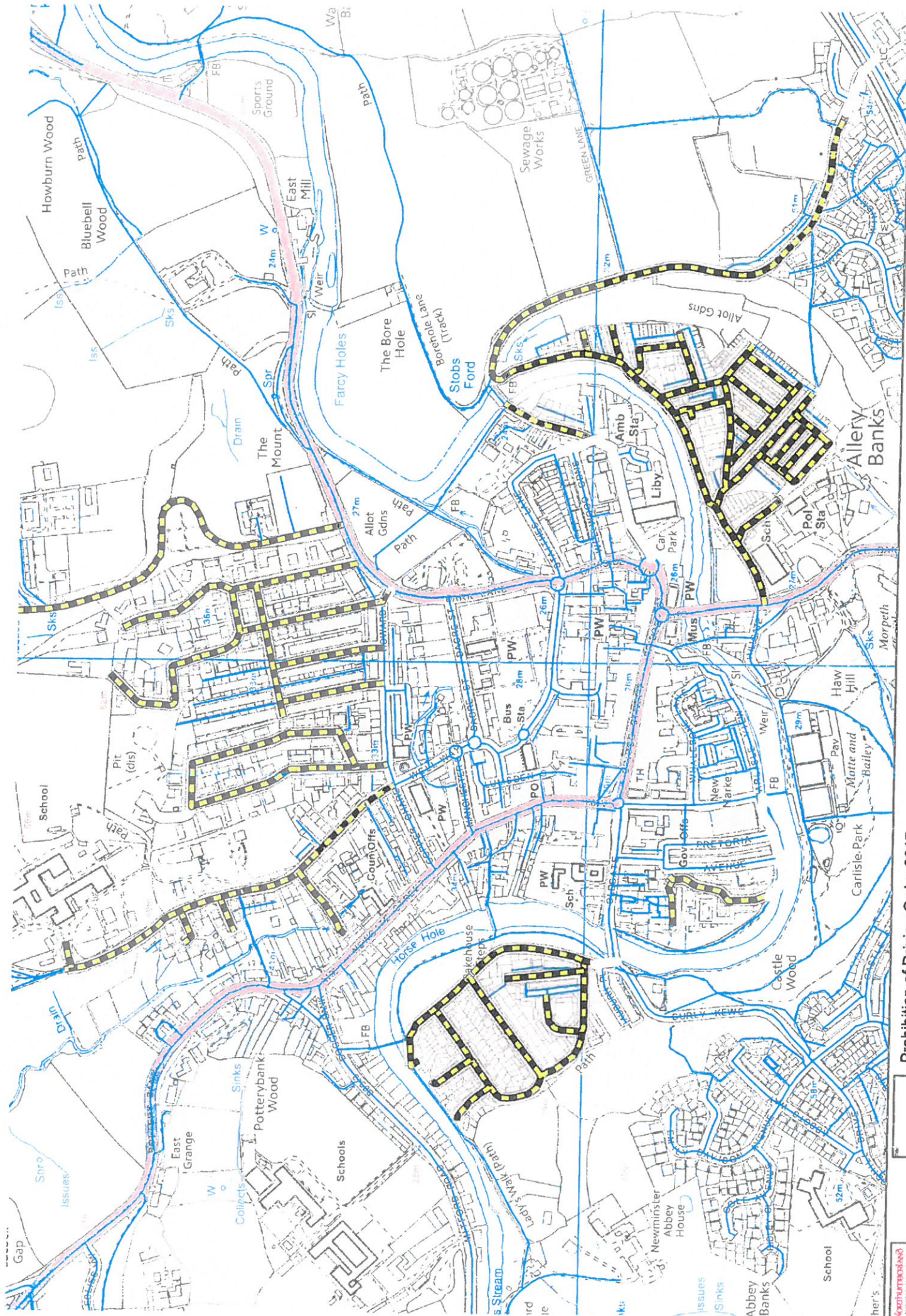

**STATEMENT OF THE COUNCIL'S REASONS  
FOR MAKING THE ORDER**

The general effect of this Order is to clarify the "Prohibition of Diving Except for Access to Off Street Premises" element of the "(Morpeth Town Centre) (No Waiting at Any Time, Limited Waiting, Loading Only Parking, Disabled Only Parking and Residents Only Parking Places) Order 2003". By revoking Schedule 4 – Prohibition of Driving Except for Access to Off Street Premises of the 2003 Order and placing these items in this new Order. Thereby, allowing clearer parameters for enforcement.
