

## **ROAD TRAFFIC REGULATION ACT 1984**

### **THE COUNTY COUNCIL OF NORTHUMBERLAND C407 LAVEROCK HALL ROAD BLYTH PROHIBITION OF DRIVING AND REVOCATION) ORDER 2016 (TROM\_006)**

(Prohibition of Driving – C407 Laverock Hall Road Blyth :- NOTICE IS HEREBY GIVEN that the Northumberland County Council have made the above-named Order under Sections 1, 2, 4 and Schedule 9 Part III Paragraph 20 and Part IV Paragraph 27 of the Road Traffic Regulation Act 1984.

**The effect of the Order, which will come into force on the 1<sup>st</sup> February 2016 will be :**

- To prohibit any vehicle to enter: **On the C407 Laverock Hall Road** – from a point 25 metres west of its junction with U9523 Etal Road to a point 255 metres west of its junction with U9523 Etal Road.
- The Order will further revoke "The County of Northumberland (Laverock Hall Road Blyth) (Prohibition of Driving and Revocation) Order 1995.

Exemptions for certain necessary purposes are included in the Order.

A copy of the Order, together with a map showing the lengths of road involved and a Statement of the Council's Reasons for Making the Order may be examined at Blyth Information Centre, Blyth Library, Bridge Street, Blyth during normal office hours or by contacting the Programme and Production Team, Local Services Directorate, County Hall, Morpeth, NE61 2EF.

If you wish to question the validity of the Order or any of the provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirements of the Act or any instrument made under it has not been complied with in relation to the Order you may before the 12<sup>th</sup> March 2016 apply to the High Court for that purpose.



The County Council of Northumberland (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 4 and Schedule 9, Part III Paragraph 20 and Part IV Paragraph 27 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), hereby make the following Order:-

1. (1) This Order shall come into operation on the 1<sup>st</sup> February 2016 and may be cited as "The County of Northumberland (C407 Laverock Hall Road Blyth Prohibition of Driving and Revocation) Order 2016."
- (2) Except where otherwise stated, any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. Save as provided in Article 1, no person shall cause any vehicle to enter, those lengths of highway described in Schedule 1 of this Order.
3. Nothing in Article 2 shall render it unlawful to cause or permit any vehicle to enter the roads referred to therein for so long as may be necessary to enable:-
  - (1) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations:-
    - (a) buildings, industrial or demolition operations;
    - (b) the removal of any obstruction to traffic;
    - (c) the maintenance, improvement or reconstruction of the said lengths of road or side of road;
    - (d) for fire and rescue, police or ambulance purposes;
    - (e) registered local bus services, scheduled express carriages, school buses, work buses, cycles and agricultural vehicles.

- (f) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Communications Act 2003, and
- (2) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority in the pursuance of statutory powers or duties.
- 4. This Order revokes "The County of Northumberland (Laverock Hall Road, Blyth)(Prohibition of Driving and Revocation) Order 1995.

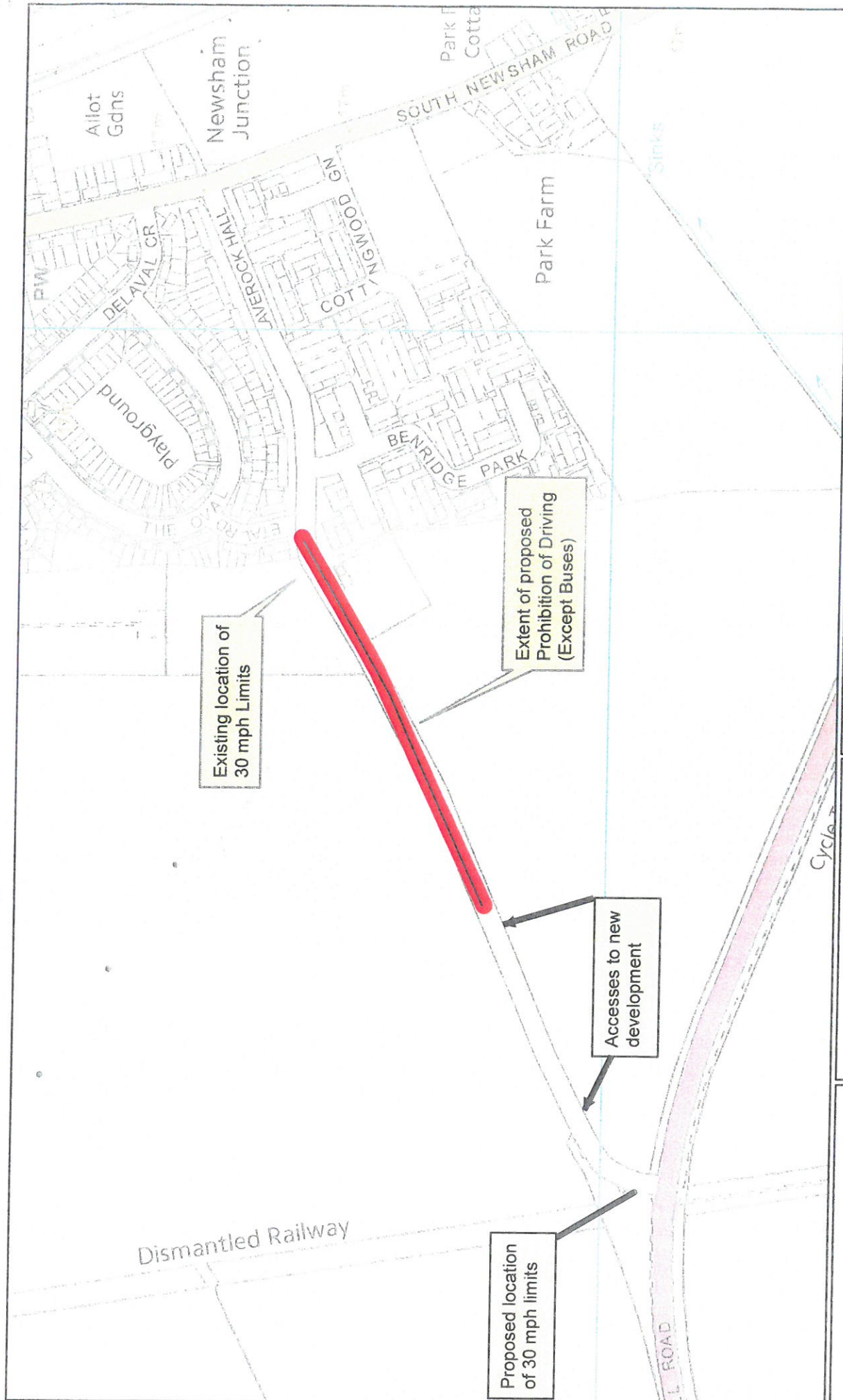
